
CRYSTAL FALLS, Iron County: Crystal Falls was located on the NE ¼ of Section 29, Township 43, Range 32 of Marquette County, Michigan, in when founded in 1880 by **George Runkel**, **Samuel D. Hollister** and **William Morrison**. The village was platted for Mr. Runkel and **James H. Howe** by **John Pumpelly** in 1881, named by Mr. Runkel from the crystal beauty of the falls (Crystal Falls) on the **Paint River** running by it. His daughter, **Julia Runkel**, became the first postmaster on September 28, 1881. Iron County was set off in 1884 (but not organized until 1885), and **Henry C. Kimball** became the first postmaster with the office in Iron County on July 1, 1884. Crystal Falls, the county seat, was incorporated as a village in 1889 and as a city in 1899.

THE VILLAGE OF CRYSTAL FALLS, on the N.E. ¹/₄ of Section 29, Township 43, Range 32, Marquette county, Michigan, has been laid out by the Crystal Falls Iron company, and lots are now offered for sale at low prices and on reasonable terms. The village derives its name from the Falls of *[the]* Paint River near which it is situated.

















IRON COUNTY COURT HOUSE



Iron County Court House, Head of Superior Avenue, Crystal Falls, Iron County, Michigan, Illustrated in Walter R. Nursey's book *The Menominee Iron Range*, **1891, Page 129:** The Iron County Courthouse in Crystal Falls, Michigan, an imposing castle-like structure built in 1890, stands at the head of Superior Avenue commanding a view of the main street of the city and the scenic panorama of the valley at its feet. On a clear day one can stand on the tower balcony and see neighboring Iron Mountain across the hills some 20 miles away. The brick structure, described as "to the Queen's taste" and "the finest building Northwest of Milwaukee or Detroit" in 1891, was named to the National Register of Historic Places in February 1975 – the first such site to be named in the Iron County area.

On February 28, 1889, a resolution was adopted to remove the County seat to Iron River and that matter placed before the electors at the ensuing spring elections. Election results showed a total of 2,193 votes cast on the issue with 1,050 favoring removal and 1,142 being against the proposed change. This appears to have settled the controversy, and as the

stipulation exacted by the taxpayers vote at the launching of the County, that no courthouse be constructed for a period of five years, was not nearing fulfillment, the more public spirited leaders turned their energies in this direction.

A committee recommended the raising of \$30,000 for the purpose and that the proposition be placed before the electors at the forthcoming annual Township elections. The bond issue was approved by a vote of 1,164 to 567, and on April 22, the Board proceeded with the steps necessary to carry out the mandate.

J.C. Clancy, an architect of national reputation, designed the building, characteristic of the Romanesque revival period with its high-pitched roof, high windows, deeply arched doorways, and exterior ornamentation. The contractor for the building was Louis A. Webber, whose low bid of \$26,470 was accepted by the County Board. However, Webber had some problems in completing his contract due to personal illness and the County Board was forced to call in another contractor to finish the work.

Work on the building started in July 1890. By November the walls were erected as high as the ceiling on the second story and part of the roof was on. In February 1891, plastering and the installing of black oak were in progress. By May the tower was near completion and the 17-foot high statues of Law, Mercy, and Justice were placed in position. *[William J. Cummings]*











This engraving appeared in Walter R. Nursey's book *The Menominee Iron Range*, published in 1891. The Lockwood Hotel, already under construction by mid-February 1882, was located on the northeast corner of Superior Avenue and Fourth Street. D.C. Lockwood was the proprietor of the large, three-story building with a frontage of 58 feet on Superior Avenue and a depth of 46 feet on the east. The Lockwood Hotel burned to the ground on Wednesday, August 8, 1918. Theresa DeLand's charred body was found in the ruins of the gutted building. *[William J. Cummings]*














Guardian Angel Church, 412 Crystal Avenue, Crystal Falls, Iron County, Michigan, ca. 1910: This unused black-and-white halftone postcard view identified as "Guardian Angel Church, Crystal Falls, Mich." shows the original Guardian Angels Church. According to *A Collection of Recollections: Crystal Falls, Michigan, 1880-1980,* "Catholic masses for the pioneers of Crystal Falls were inaugurated by Reverend Father Melchoir Faust of Quinnesec on a visiting basis in Doucet's hall and skating rink in the fall of 1883. Beginning in 1884, the spiritual care of the parish became the duty of six different visiting pastors from Iron River. In 1887 the first resident pastor assigned to Guardian Angel's was Father Edward Chapius. Between the first and present pastor, Father Joseph Gondek, there were 24 priests who served for periods as short as one month, to those of Father Joseph Kunes, who ministered to the people for a period of twenty-two years.

"Credit for the erection of the first permanent church building is accorded to temporarily assigned Fathers J.S. Struif and Joseph Haas. They provided leadership in the purchasing of building materials for churches in Iron River and Crystal Falls until the churches were built in both communities by 1887. That same year, Father Chapius became the first permanent pastor for Guardian Angel's parish.

"The economic depression of 1892-93 caused many families to leave Crystal Falls to find work elsewhere. In the fall of 1892, Guardian Angel's parish was reduced from 126 families to 60 as a result of this exodus. By 1897, a revival of the mining industry took place, families

returned and the church grew once again. During this period, Father John Keul made much needed repairs and improvements to the original building which had been erected in 1887." *[William J. Cummings]*



According to A Collection of Recollections: Crystal Falls, Michigan, 1880-1980, on October 31, 1931, the last was offered at the original Guardian Angels Church and the frame church edifice which had become structurally weak was demolished. Sunday masses were provided for the faithful in the Crystal Falls City Hall. The new basement church which formed the foundation and base of the current structure was completed in time for masses to be said of Christmas Day, 1931. New pews and other furniture was installed.


In June 1953 construction was begun on the new church. While the church was under construction Sunday masses were offered in the Delft Theater and weekday masses were held at Legion Post No. 87. On April 4, 1954 the new Guardian Angels Catholic Church was dedicated. *[William J. Cummings]*





First Lutheran Church, 506 Superior Avenue, Crystal Falls, Iron County, Michigan, ca. 1951-1960: This unused real photo postcard view identified the "1st Lutheran Church, Crystal Falls, Mich. 3A557" dates to shortly after the church was built in 1951. According to *A Collection of Recollections: Crystal Falls, Michigan, 1880-1980*, "Lutheran history in Crystal Falls began formally on March 18, 1891, when the Finnish Evangelical Lutheran Congregation was organized. It was followed soon after, on July 10, 1894, by the formation of the Swedish Evangelical Lebanon Lutheran Church. Both congregations were served by temporary and student pastors until 1900 when Rev. J.J. Hoikka arrived as pastor for both groups. Both services were held in the Swedish Lutheran Church building itself was purchased from the Methodist Church and in addition to the Finnish and Swedish Lutherans, the Episcopalians made use of the building.

"On January 16, 1903, the Finnish Lutherans bought the Baptist Church building and early in 1904 the two congregations became completely separate as Pastor George A. Johnson came to serve the Swedish Lutheran.

"In 1923 the Swedish Church changed its name to the First Lutheran and in 1951 the present church building was built by the First Lutheran. The Finnish Lutheran church changed its name to Emmanuel Lutheran in September of 1950.

"On May 14, 1967, the two independent congregations voted to merge and become United Lutheran. On August 13, 1967, a special service of merger was held at Fortune Lake Bible Camp, led by Synod President Mr. Theodore Matson. At that point, the name United Lutheran was selected. The present pastor, John Linna, accepted a call to United on October 22, 1967." *[William J. Cummings]*

John H. Parks was born June 4, 1845, at Standing Stone Township, Bradford County, Pennsylvania, a son of John and Mary (Hunter) Parks, Jr. In 1855 his parents settled in Bovina Township, Outagamie County Wisconsin, where John H. Parks continued his studies in a log schoolhouse, acquiring a practical education. He began to work in the woods when quite young, and became an expert in the logging and lumber business.

In June, 1864, John H. Parks enlisted in Company E, Fifth Wisconsin Volunteer Infantry, and was honorably discharged in September, 1865, when he returned to Wisconsin.

Parks bought a tract of timbered land in Bovina Township, Outagamie County, Wisconsin, and, when not employed in logging, he devoted his energies to the improvement of his land which was soon transformed into productive farm. A successful lumberman, Parks entered the employ of P. Sawyer & Son in 1877, and subsequently continued with their successors, the Sawyer-Goodman Lumber Company, with whom he came to the Upper Peninsula.

Locating in Crystal Falls in 1884, Mr. Parks, In company with his uncle, George S. Parks, John H. Parks embarked in the mercantile business in Crystal Falls in 1884, putting in a stock of general merchandise. At the present time (1911) the John H. Parks Company carries a line

of hardware and its accessories, only, having a complete stock, and is doing a substantial business, its patronage being extensive and remunerative.

John H. Parks married April 13, 1876, Eva Augusta Jewett, a daughter of Eben and Mary (Parks) Jewett, in Omro, Wisconsin. Eva was born November 29, 1853, in Wautoma, Waushara County, Wisconsin. The Parks were the parents of: Bessie Belle Parks (born November 9, 1885 in Crystal Falls, and died September 28, 1887 in Crystal Falls); John Augustus Parks (born June 18, 1890 in Crystal Falls, and died January 31, 1891 in Crystal Falls; Ulmer, Edna A. and one other child. Only Edna was living in 1900, the wife of William Jolliffe. They had three children: twins Helen M. and Margaret J. Jolliffe and John Parks Jolliffe.

According to the 1900 Federal Census John H. Parks was born in June, 1845, in Pennsylvania. His parents were both born in Scotland. He married Eva A. Jewett, daughter of Eben B. and Mary P. Jewett, born in November, 1853, in Wisconsin, in about 1876. They had three children, one of whom, Edna M. Parks, born in November, 1878, in Wisconsin, was still living in 1900. Edna M. Parks, the 21-year-old daughter of John H. and Eva A. (Jewett) Parks, married William M. Jolliffe, the 24-year-old son of Samuel and Jane (Jeffrey) Jolliffe, born in Ohio, in Crystal Falls, Iron County, Michigan, on August 14, 1900. In 1900, the Parks family was living in Crystal Falls, Iron County, Michigan.

Eva A. Jewett was listed as a 4-year-old daughter of Eben and Mary Jewett in the 1857 Minnesota Territorial Census, living in Township 106, Range 8, Winona, Minnesota, with her parents and a brother, Charles, 2-years old and born in Minneapolis, and Ella, 1-year-old and born in Minneapolis. Eva is again listed as a 6-year-old daughter of Eben and Mary Jewett in the 1860 Federal Census for Minnesota, living in Township 106, Range 8, Winona, Minnesota. In the 1875 Minnesota State Census, Eva was the 21-year-old daughter of E.B. and Mary P. Jewett, living with her parents and Clarence W. Jewett in Lake Marshall, Lyon County, Minnesota.

In the 1910 Federal Census John H. and Eva S. Parks were listed as living in Ward 3, Crystal Falls, Iron County, Michigan.

The Parks had a "fine estate" nine miles from Crystal Falls bordering Chicagoan Lake, where he had "ample barn and stable room for his valuable stock, houses for his employes *[sic – employees]*, and a commodious artistically constructed log cabin, situated on the lake shore, in which he and his family enjoy life seven months of every year."

Eva Augusta (Jewett) Parks died August 31, 1911, in Crystal Falls, Michigan. John Hunter Parks died in January, 1920, in Palm Beach County, Florida. They are buried in Evergreen Cemetery, Crystal Falls, Iron County, Michigan, with their two young children. *[William J. Cummings]*



Timothy Murphy Houses, 17 North Fourth Street, Crystal Falls, Iron County, Michigan, ca. 1983: On December 22, 1983 the Timothy Murphy house was added to the National Register of Historic Places. The Timothy Murphy House, also known as the Harbour House, is a massive two-story hipped roof Queen Anne/Colonial Revival structure built from rough-faced cement blocks in about 1900 by Fred Floodstrand, a local master mason and bricklayer. It has a two-story, wooden, "steamboat-style" wraparound porch that contrasts nicely with the mass of the house. The house is closely associated with John and Ellen Harbour, their daughter Maude (or Minnie), and her husband Timothy Murphy, the Stambaugh railroad depot superintendent. In 1982 the house was purchased for the Crystal Falls Museum Society and was extensively restored. It currently serves as a hands-on museum for the society.













Crystal Falls Dam and Power Plant, Pine Street, Crystal Falls, Iron County, Michigan, ca. 1983: On December 22, 1983 the Crystal Falls Dam and Power Plant were added to the National Register of Historic Places. The section of the Paint River where the dam is now located was once a series of falls and rapids that gave Crystal Falls its name. However, in 1891, the village of Crystal Falls constructed this dam and power plant, effectively submerging the rapids. The plant was expanded several times but could not keep up with demand from the growing population of Crystal Falls. The plant is still operational, providing roughly one third of the power to Crystal Falls, and is likely the oldest hydro-electric plant still in operation in the Upper Peninsula.













A 137-site campground is situated in a shady, wooded site with buffer strips between most of the sites. Bewabic has picnic areas, a tennis court, a hiking trail, two playgrounds, an excellent beach and a boat launch to Fortune Lake. It is also part of the Iron County Heritage Trail system. The 2.5 mile ski trail is groomed for both classical and skating style skiing during the winter. The park is also open to individuals who want to snowshoe. Pentoga Park, Chicagon Lake, 1630 County Road 424, Near Crystal Falls, Iron County, Michigan, ca. 1940-1950: This unused black-and-white real photo postcard identified as "Princess Pentoga, Pentoga Park, Crystal Falls, Mich. N1692" dating between 1940 and 1950, shows the entrance to Pentoga Park with the statue of Princess Pentoga and another Native American just left of center. The back of this postcard bears a written date of June 13, 1951.

Pentoga Park is located at 1630 County Road 424 on the southern tip of Chicagon Lake five miles southwest of Crystal Falls in Iron County and is built on the former site of an Ojibwa village. Iron County purchased the land for this park in 1924 as a tribute to the Native Americans that congregated here and to preserve their burial grounds. The wooden burial structures have endured time to protect and mark the graves of the ancient Ojibwa bands that made this spot their permanent area headquarters in the 1800s.

The drums pound out a steady irresistible beat that can be heard across the calm waters of the lake. Long shadows move and mingle with the tall pines and hardwoods. The huge ceremonial fire tinges everything around orange and yellow. The Ojibwa Indians dance in a circle around the fire. The humble village stands silhouetted along the shore where birch bark


canoes sit waiting to be taken out on the water for fishing. The ceremony is in honor of one who has passed on to the realm of the Great Spirit. The body had been earlier put to rest in the burial ground on the far ridge. Occasionally mourning wails mingled with the drumbeats.

Chicagon Lake is 1,100 acres in size and approximately 115 feet deep at its deepest point. Anglers can expect to catch a variety of fish including lake trout, largemouth bass, muskie, northern pike, rock bass, smallmouth bass, walleye and yellow perch. Pentoga Park offers swimming, fishing, boating, 100 camp sites and more. *[William J. Cummings]*









An article appearing in *The Iron Mountain News* on June 6, 1925, noted the formal season opening of the Chicagoan Lake Pavilion that evening, featuring Okie Anderson and his sevenpiece jazz band from Pittsburgh, Pennsylvania. Dances were to be held at the pavilion every Wednesday and Saturday night throughout the summer. A number of "high class orchestras" had been booked. Free orchestra concerts were given on Sunday afternoons. The article noted, "Chicagoan Lake will be a haven for dancers this summer, being cool and pleasant, the board walk out into the lake providing a novel attraction." *[William J. Cummings]*





Indian Burying Ground, Chicagon Lake, Near Crystal Falls, Iron County, Michigan, ca. 1908: This black-and-white halftone postcard view identified as "Indian Burying Ground, Crystal Falls, Mich." Postmarked Crystal Falls, October 23, 1908 shows three wooden burial "houses" with a man in a hat standing to the right of the largest burial "house" in a dappled woodland setting at Pentoga, Chicagon Lake.

According to Ojibwa funeral customs, upon death the corpse was washed, groomed, dressed in fine clothing, and wrapped in birchbark before burial in a shallow grave. Following death, the soul of the deceased was believed to journey westward for four days to an afterlife in the sky. *[William J. Cummings]]*



The wooden sign at right reads "O-jib-way Jebay-mig-gon" and has a painted head of a Native American with a feathered headdress.

The funeral ceremony was attended by friends and relatives and was conducted by a Mide priest, who talked to the deceased and offered tobacco to the spirits. *[William J. Cummings]*]



In later times a long, low, gabled plank house was constructed over the grave. The Plains Ojibwa also employed the gabled grave house and left offerings of food and water at the grave house for four days after burial for the soul's subsistence on its journey to the afterlife. *[William J.
