The Marquette County Board of Commissioners met as a Committee of the Whole on Wednesday June 28, 1978 at 7:00 p.m. in the County Courthouse Annex.

Roll call was taken by County Clerk, Henry A. Skewis and the following roll recorded.

Present: Comm. Alderton, Anderson, Bollero, Carlson, Farrell, Krook, Leone, Potvin, Racine, Steele and May.

Absent: Comm. Cheatham.

Approval of the agenda was given by the general concensus of the County Board members present.

Chairperson May opened the meeting for Public Comment, none was forthcoming and Chairperson May declared the Public Comment section closed.

A discussion was held and a report given, regarding the Policy Makers Conference held in Marquette, Michigan at the Courthouse on June 3, 1978. Several problems brought out as a result of this Conference, were of great enough inportance to have the following action taken regarding them.

1. Citizens Participation and Public Awareness.

After a discussion, it was moved by Comm. Alderton, supported by Comm. Anderson and carried to refer the first - six points of this matter to the County Controller for investigation and report.

It was moved by Comm. Carlson, supported by Comm. Leone and carried that the reference to hiring a person to man an Information and Referral phone line for better citizen service, be referred to the Finance Committee for study and report.

2. Personnel Management/Labor Relations.

A discussion was held in regard to one county person being a part of all lebor negotiation and personnel policy matter, was held. It was moved by Comm. Alderton, supported by Comm. Carslon and carried that this and the other six items listed under (solutions) be referred to the Personnel Committee for recommendation.

3. Capital Improvement/Facility needs.

A discussion was held in regard to the County establishing a Central Humane Service Complex and of the development of a committee to be involved in the County's Capital Improvement Program. It was moved by Comm. Alderton, supported by Comm. Racine and carried that this be referred to the Environment, Lands and Buildings Committee for recommendation.

4. Communication/Coordination

The discussion involved three problems (1) exchange of the minutes of townships and county boards meetings (2) publishing of an in-house news letter (3) set up an in-house information center. It was moved by Comm. Krook, supported by Comm. Leone and carried that these matters be referred to the Executive Committee for recommendation.

5. Financial Management/Budgeting

A discussion was held on the suggestions to (1) provide opportunity for two-way communication between county board and departments (2) Insurance needs under a blanket coverage (3) placing of advisory and millage questions on the ballot to see what programs the public wants continued. It was moved by Comm. Racine, supported by Comm. Alderton and carried that these three items be referred to the Finance Committee for study and report.

A discussion was held regarding all boards and commissions keeping the county board advised of pending legislation that would effect County Government. This Matter was referred to the Executive Committee.

6. Growth Management/Development

A discussion was held on setting up an evaluation process for potential board and commission appointees. It was moved by Comm. Farrell, supported by Comm. Racine and carried that this matter be referred to the Governmental Study Committee for study.

A discussion was held regarding providing an opportunity for each department to study the county plans as it pertains to their areas of responsibility. It was moved by Comm. Farrell, supported by Comm. Carlson and carried that this matter be referred to the Planning Commission for study and report.

A discussion was held in regard to the best method to tie the County Comprehensive to the Capital Improvement Plan. It was referred to the Environment, Lands and Buildings Committee for study.

A copy of the memo regarding the Policy Makers Conference will be sent to all participants. It was the general concensus of the County Board that the Policy Makers Conference was a success.

A discussion was held regarding the progress of goals for 1978 of the various committees.

Comm. Anderson reported on the progress of goals of the Executive Committee, all are being worked on but some of the goals may require extra meetings to get them resolved.

Comm. Alderton reported on the progress of goals for the Personnel Committee. All goals are either finalized or are being actively worked on.

Comm. Carlson reported on the progress of the goals of the Finance Committee, all of which are being accomplished to some degree.

Comm. Racine reported on the progress of goals of the Intergovernmental Relations Committee. Several have been accomplished, the Emergency Medical Services goals are being worked on now and Law Enforcement goals have not yet begun.

Most of the goals of the Environment, Land and Buildings Committee goals are either finalized, decided upon or being worked on. The six year capital outlay program is being worked on but has not been developed as yet. Chairperson May gave a short report on goals of the Marquette County Board of Commission for 1978. All twelve goals are being worked on but Recreation and Energy are the two that have been worked on the least.

Skewis until after the Nov. 1978 General Election, was read. County Board members were asked to give some direction to the Controller on this matter. The County Commissioners who were knowledgeable of the facts on hand when the salary for extra hire of a half time clerk, was taken from the County Clerks budget on October, 1977, expressed their opinions.

Chairperson May announced that an Elected Officials Conference will be held at the County Courthouse on July 29, 1978.

A report of the Upper Peninsula Association of County Commissioners Conference, held in Escanaba, Michigan, was given by Comm. Potvin.

A discussion was held on the proper procedure that should be followed when a county board makes a temporary loan to a department in any given year. It was suggested by Thomas Solka, Ass't. Pros. Atty. that all loans be handled the same as if they were between an individual and a financial institution. A written report of the warranty claims pending on the Courthouse Annex Construction project was given by the County Controller and placed on file.
