Comm. Juidici advised the county board that one of the objectives of the Personnel Committee was being finalized, that being the Job Classification/Compensation/Benefit study.

Comm. Lowe of the Central Dispatch Advisory Board asked for a definition of the phrase "participating members" in regard to membership on that board. He was advised by County Controller Duane Beard that a participating member is a representative of each service dispatched.

Comm. LaPin gave a short report on the Solid Waste Planning Committee meeting and the need for Solid Waste disposal sites including Type III sites where construction material would be disposed of. He mentioned that blacktop is now recycled and used for road construction and that in the near future concrete will also be recycled.

On a question by Comm. Villeneuve, the county board was advised that there is no close market for shredded paper, except as mulch for gardens.

It was announced that a new EDC will be established in Marquette County. It will be known as the Certified Development Corporation and will be administered by CUPPAD.

Duane Beard and Patricia Micklow advised the county board that they were not successful at this time in setting up meeting dates for AMCAB accountability negotiations.

Chairperson Farrell opened the meeting for public comment, none was forthcoming and the public comment section was closed.

There being no further business to come before the County Board, the meeting was adjourned.
