Comm. Steele distributed the tourist guide for Upper Peninsula Travel and Recreation Assoc. and advised the County Board that tourism in Michigan is on the uprise.

Comm. LaPin gave a short report on the County EMS council meeting held on May 20, 1982. Some of the subjects discussed were:

- Need for fire department participation in accidents which involve gasoline spilled on the roadway.
- 2. Need for advanced training and a continued update of training.
- Examination of bodies at accident site by Medical Examiner or deputy medical examiner.
- 4. Ability to purchase pagers and radio equipment as a group rather than individually.

Comm. Juidici gave a short report on the recent AMCAB meeting. She stated that David Brantley, the new director has taken over and is working out well. She stated a grievance is being reviewed in regard to a complaint involving the motion and voting involved when the new director was appointed.

Chairperson Racine opened the meeting for public comment, none was forthcoming and Chairperson Racine closed the public hearing.

There being no further business to come before the board, it was moved by Comm. Leone, supported by Comm. Lowe and carried that the meeting be adjourned.
