If you are like a lot of the citizens in Burt Township, over the last several months you have gone to at least one of the township meetings. At the meeting you might have observed how our local government is being run. We now have an attorney at these meeting telling us what to do. Funny I thought that was what we elected the board members to do. What happened to doing things so anyone could understand them. Things have gotten way out of hand.

The township board now thinks that they have to make everything a resolution, with all the resulting paper work (enough to choke an elephant). If you look at the MTA website michigantownships.org and look under the tab in the upper left hand corner that says AT YOUR SERVICE then scroll down to RESOURCE TOOLKIT and scroll down to where it says MEETING and look at the last line you will see "When is a Roll Call Vote or Resolution Required. Look at this document and see if you can find where it states the board has to make everything they do a resolution.

If you had been going to the township board meetngs over the years you should recall that an awful lot of what is being written up as a resolution v taken care of in the past without the added difficulty and time now required. Think about it people, every resolution takes time away from dealing with the real problems the board should be dealing with. The problem is not making the rules and policies, the township board has been very good doing just that. The real problem has been getting the board to obey the policies after they voted them into effect. This is still a problem!

What is going on with all this spending? Has anyone seen the budget or the amended budget? We keep hearing that we have to stay within the budget. There hasn't been an update to the budget or a review of the budget for months. Just where is all the money that is being spent coming from? Has the budget been amended for the hiring of the new oudget been amended for the niring of the new manager position? Where is the money coming from for the investigation of the applicants? This is what got us into trouble in the first place. On to the investigation started by the Ad Hoc

Committee. The citizens were told that the investigation would be over before Labor Day. Guess what folks it's September 20th and it still isn't done and no real time limit has been set for it to be finalized. Are we any closer to understanding just what happened? One thing for sure about it, it is tearing this town apart. All the allegations and rumors are creating scars that may never heal.

Now our attorney has filed suit against the ex-clerk and ex-auditor because the court (Judge Stark) told him he couldn't require them to turn over certain records. I am not sure if this kicks in the law requiring the township to pay for the DEFENDANTS' legal costs but was that considered before filing suit? Did the board approve this action? If the township is now responsible for legal costs, from where does the money come. Too often decisions are being made by our board based on little or no information and without time for the members to do any investigating or thinking as to whether it may have some detrimental effects

Let's get this thing done and over with so we can start to heal. Let's start to think about just what this community needs to do, to work together and fix the problems we have without causing more

A) Appointment of treasurer / oath of office - on motion by Wampler, second by Kniss, Kathleen Correll was appointed as Burt Township Treas urer per resolution #2006-18 - 4 ayes. Kathy was sworn into office and took her seat as a voting member of the board.

B) Report from township attorney / resolutions - Attorney John Underhill presented several Resolutions to complete "housekeeping" needs. Resolution 2006-19 was adopted on motion by Wampler, second by Brzys - 5 ayes - to move the treasurers office out of the basement. Resolution 2006-20 was adopted on motion by Leavenworth, second by Kniss 5 ayes - to direct the treasurer to consider what it will take to set up a sepa rate set of records and to report to the board on recommendations at the September meeting. Resolution 2006-21 was adopted on motion by Wampler, second by Leavenworth - 5 ayes - to adopt Roberts Rules of Order for all township meetings. Resolution 2006-22 was adopted on motion by Wampler, second by Leavenworth - 5 ayes - regarding the conduct of public comments sessions at board meetings. Resolution 2006-23 was adopted on motion by Wampler, second by Kniss requiring all meetings to be digitally recorded and uploaded to the township web site - 5 ayes. Resolution 2006-24

was adopted on motion by Wampler, second by Kniss -5 ayes - reiterates the appointment of John Underhill as the Township Attorney including specific authorizations granted in such appointment. Resolution 2006-25 was adopted on motion by Wampler, second by Leavenworth – 4 ayes, 1 abstain - formal acceptance of the board to reduce the Supervisor pay and duties to only those mandated by statute. Resolution 2006-27 was adopted on motion by Kniss, second by Leavenworth - 4 ayes, 1 abstained - detailing the job description for the Township Manager position. Resolution 2006-28 was adopted on motion by Leavenworth, second by Kniss - 4 ayes, 1 nay - requiring the Township Manager to report that the Clerk and Treasurer have reconciled their books and are in order - Clerk Wampler objected on the grounds that an employee should not be put into a position of overseeing the statutory duties of elected officials. Resolution 2006-29 was adopted on motion by Leavenworth, second by Kniss - 4 ayes, 1 abstained - to set the full time manager's position at an annual salary of \$21,800. Resolution 2006-30 was adopted on motion by Wampler, second by Kniss -5 ayes - directing the Township Manager to obtain a mortgage on the Township Office and Medical Center property to pay off certain loan obligations, defray the costs associated with the ongoing investigation/audit and other uses as detailed in the resolution. Resolution 2006-31 was adopted on motion by Wampler, second by Leavenworth ayes - prohibiting future indebtedness except as approved by the electors. Resolution 2006-32 was adopted on motion by Wampler, second by Kniss - 5 ayes - allowing Peoples State Bank to give access to Karer Brzys and John Underhill as needed to facilitate the ongoing investigation but not to authorize signatory rights to the accounts. Resolution 2006-26 regarding advance payment of certain accounts without prior board approval was tabled until September 12 for the Clerk to review what accounts should be allowed to be paid to meet discount and late fee dates from vendors. A motion was offered by Karen Brzys, second by Gordon Kniss not to make inter-fund transfers except for payroll related transac

Public Comment: Joe McDonald asked for clarification on the method for the electors to approve indebtedness - either Annual Meetings, Special Meetings of the Electors or by ballot. Evie Morrison commented that we need the flexibility to pay/authorize registrations for seminars for the ambulance corps. Nancy McDonald expressed her support of Clerk Wampler's address and Karen and Kay working together. Gerry Bailey asked that the Annual Meeting be returned to June. It was noted that by statute, the annual meeting is to be held on the last Saturday of the last month of the fiscal year [it can be changed by majority vote of the board to any other day but must be in the last month of the fiscal year, Burt Township's fiscal ar ends March 31st]

Adjournment: Motion by Leavenworth, seconded by Wampler to adjourn the meeting at 8:10 p.m. - 5 ayes

Nancy Mc Donald commented on the Township Manager position posting and noted that it not be the Supervisor in the best interest of the public.

Correspondence: Clerk read a letter from the State Tax commission accepting the new assessor is (Mike Foust) report as submitted and will look forward to continued progress with the next report. 
Clark loved to fly and had a private pilot license. He also enjoyed skiing, fishing, hunting, and visiting with friends and family.



Although the attendance was down at the September 12 meeting of the Township board there was still some lively discussion. #### New Yurt Available at Porcupine Mountains Wilderness State Park

State recreation officials today announced Porcupine Mountains Wilderness State Park is accepting reservations for the park's first yurt, a sturdy, tent-like structure that originated in central Asia, that park officials said will offer visitors a new adventure in camping.

"The yurts will provide visitors with a snug, weather tight shelter that is close to the park's hiking, biking and cross-country ski trails," said Robert Sprague, park administrator. "One yurt is completed, and a second should be completed soon for winter rentals."

Each of the 16-foot-diameter yurts will sleep four people and are equipped with bunk beds, mattresses, cooking and eating utensils, a cooking stove, wood stove, and an axe and bow saw. Running water and electricity are not provided, but an outhouse is nearby and wood is provided for heat in the colder months.

"The distance and degree of challenge required to reach these new yurts will vary with the season," Sprague said. "A third yurt, which will be universally accessible, will be located near Lake Superior and should be completed next spring."

The rental fee is \$60 per night and there is an \$8 reservation fee. For reservations or more information, contact Porcupine Mountains Wilderness State Park at (906) 885-5275, Monday-Friday, 8 a.m. to 4:30 p.m.

All motor vehicles entering a state park or recreation area must display a Motor Vehicle Permit, available for purchase at the entrance. Cost is \$24 for a resident annual and \$6 for a resident daily. A nonresident annual is \$29 and a nonresident daily is \$8.

The DNR is committed to the conservation, protection, management, use and enjoyment of the state's natural resources for current and future generations.





#### NMU, OU JOIN IN OFFERING NURSING DOCTORATE

MARQUETTE – Northern Michigan University and Oakland University have received a \$950,000 grant from the State of Michigan Department of Labor and Economic Growth to jointly offer a doctor of nursing practice (DNP) degree, beginning fall 2007.

The one-year accelerated program, one of only 19 in the United States, will address a critical need in Michigan and the nation for nursing faculty members.

The American Association of Colleges of Nursing (AACN) estimated that as many as 30,000 qualified nursing school applications were denied access to U.S. nursing programs in 2004-05 due to nursing faculty shortages.

"I think state policymakers see this as a great example of how universities can join together to be highly efficient in meeting a critical state and university need," said Jean Klemczak, Michigan's chief nurse executive, who was at NMU earlier this week to meet with students, faculty and both NMU and OU administrators. "I am delighted that the development of this program is under way."

Oakland will be the degree-granting institution, but NMU nursing faculty members are helping to develop the cooperative program and will teach several courses. Additionally, 10 of the cohort's 20 spots are slated for Upper Peninsula students.

per Peninsula students.

"This was a great opportunity for two universities with strong nursing programs to come together to work as a team in a way that helps our students, communities, the state and both nursing programs," said Linda Thompson Adams. OU dean of nursing.

Part of the funding for the OU-NMU program includes scholarships to cover tuition as well as student stipends.

"Paid tuition and a stipend are tremendous incentives to get currently employed nurses with an interest in teaching to consider earning a doctoral degree," said Kerri Schuiling, NMU associate dean of nursing education. "Most nursing programs have a significant number of faculty members that are not far from retirement. We need to be educating our replacements now.

"The program is for nurses focused or having specialty certification in a practice area. It enables nurses with a focus in a practice area to attain the terminal degree for practice, which in turn, makes them attractive candidates to university programs. So being a nursing educator is not a requirement of the program."

One aspect of the program that most excites NMU and OU administrators and faculty is the opportunity it provides their respective students to learn more about various geographical healthcare issues.

"With this program, we're blending our faculty and our students so that those who are teaching and learning in an urban environment will be introduced to rural healthcare issues and vice versa," said OU's Frances Jackson, who will serve as director of the program. "The students will then be the ones who will go on to teach our future undergraduate and graduate nursing students and they will be able to bring a better understanding of rural and urban nursing issues and needs to their classrooms. That's exciting,"

NMU has offered joint doctoral programs with other universities periodically in the past, but this will be its first doctoral program that NMU faculty members have played a major role in developing and teaching.


