# What's Happened in the Burt Township

By Marc Oglevie
Things have been happening around the township since the first of November. On November 3, 2006 at a special meeting of Burt Township Board, Scott Weiting was appointed by the board to fill the vacancy created when Gordon Kniss resigned his position as trustee. Next a Meeting of the Electors (at which 110 people attended) was held on November 4, reporting on the investigation and the update on the financial situation the township is in. On page two you will find the minutes of these meeting. On November 7, Kay Wampler was elected at the General Election with 224 votes to 78 by write-in candidate Brent Hammer.

On November 14, at the regular Township Board Meeting, Karen Brzys presented a new budget with suggestion to the Board that they look things over til the next monthly meeting. She resigned her position as Township Supervisor effective November 15 at 4:00 p.m., she still kept her position as township Manager. Next Cathy Correll resigned her position as Township Treasurer effective November 15 at 12 noon. This left the Township Board with just 2 members until Kay Wampler assumed her position as Township Clerk. The reduced Board then called another Special Meeting for Saturday, November 18, to fill the position of Township Treasurer until a permanent one could be appointed for the remainder of the term. Karen Brzys turned in her resignation( by letter) as Township Manager effective immediately citing the Clerk as her reason for quitting. At the meeting the Board appointed Marc Oglevie to the temporary position of Treasurer to get the winter tax bills out, to sign checks and perform the duties that have to be done as needed until a permanent Treasurer is appointed, at the next Electors Meeting scheduled for December 7th. The positions of Township Supervisor an Treasurer are to be posted until December 1 at 4:00 p.m. At the present time three people have expressed and interest for the Treasurer position; Brent Hammer, Marc Oglevie and Joe Venturato. Only one person has expressed interest in the Supervisor's position, Jack Hubbard. At the Electors meeting these positions will be voted on by the Electors. Also on the agenda of the meeting is a discussion on the position of Township Manager, and where we want to go with this position. Do we really need this position, or should we go back to just the Supervisors position returning to the pay scale and duties as they were previously?

# That's as close to death as I want to come

By: Chris 'Scoop' Sarver Noon, on December 2<sup>nd</sup>, Capt. Franz VonRiedel and First mate/Engineer (Tugboat) Tedd Wagner aboard the 88 foot 1951 tug, Susan Hoey, towing the 94 foot 1939 tug, Seneca, left the Sault, bound for Duluth, to engage in the upcoming icebreaking season in Duluth harbor -a day and a half journey. The wind was westerly and the seas were calm on departure with a forecast of 0 to 4 foot waves out of the west-southwest within five miles of shore, and 2 to 4 foot building to 10 to 14 on the open lake. The Captain commenced their journey staying close to the south shoreline of Lake Superior's legendary "shipwreck coast". At 8 p.m., west of Whitefish Point, the waves started picking up, slightly rolling the boat. Suddenly, at 9 p.m. the wind shifted from the

north and the boats encountered westerly 10 to 14 foot waves with an occasional pair of 16-foot (widow maker) waves. In a shrieking hailstorm, the pilothouse completely iced over and only a spotlight shining on the tug in tow behind her, the crew of the Susan Hoey found themselves in a living hell. The crew said their tug felt like would point straight up towards the sky then suddenly crash down into the water with the sound of a loud steel drum. Every shelf and cabinet was emptied onto the decks and the engine room was taking on

water. Tugboat Tedd, the engineer, observed two thirds of the trailing 94-foot tugboat bottom hanging in air over the crest of a wave with a second wave ensuing. At times the waves were so close together that the boat never made it to the trough before the second wave hit. At 10 p.m., north of Crisp Point, Captain Von Riedel noticed the Seneca was gone. Engineer Wagner, stuck his head outside and glimpsed the tugboat floating away. The crew never felt the towline break. There was never a thought of retrieving the lost tug, only heading

With waves crashing over the sides and a smorgasbord of debris washing to and fro across the ice-covered deck, the tug was rocking violently front to back, and rolling precariously from side to side. Captain Franz wanted to close the door to the engine room thinking that one good wave could fill it up and sink them. First mate Tedd took on the job, crawling and pulling his way across the icy deck to the door and prayed to God when the door was finally latched shut. Enclosing the engine room, however, created another problem: the furnace was drawing too much air, forcing the engine to begin stalling. The Captain had to turn off the furnace to conserve air for the engines. Now the crew was without heat. Almost immediately the cabin temperature dropped to below freezing, and an inch of ice encased the pilothouse, disabling them from being able to see any thing outside the cabin. At this point the crew was sure they were not going to live much longer and decided their only chance was to get to the nearest safe harbor, Grand Marais.

The crew tried various attempts to aim the boat to shore. Angling the tug at a 45-degree southwest angle, the boat began rolling 45 degrees left and right into the waves. It didn't seem that they could head into shore. They felt if they turned the tug directly south, they risked capsizing. With a prayer and a wish, after an hour of debate, the crew took their chances and turned the boat directly south- perpendicular to the relentless 10-16 foot waves. Miraculously, and much to the crews surprise, "The tugboat bobbed like a cork and rode the waves dead nuts level; all of the sudden everything was calm." They had just been released from the jaws of death.





## That's as close to death as I want to come

It was now 1 a.m. on the morning of December 3<sup>rd</sup>. The tug was 6 miles northeast of Grand Marais harbor. Navigating by GPS only, Captain Franz's feet wedged between the left and right throttle stands with a death grip on the throttles, turned on full power. He reported traveling at 16.8 mph (the tugs only rated for 13 mph) and made it close to shore in what felt like the blink of an eye. First mate Tedd, sticking his head out pilothouse door, sighted the flashing beacon at the end of the Grand Marais Break wall. But, trying to determine the location of the break wall channel was virtually impossible with no visibility.

Fortunately, at this time, Grand Marais local Coast Guard auxiliary man, Howard Baker, who had been monitoring the situation on radio, contacted the crew of the tug. He told them he would be on land by the break wall channel to assist in guiding the Susan Hoey into the harbor. "Howard Baker's blow by blow radio communications guiding us into the break wall channel saved our lives," stated Capt Franz, "He guided us in by radio and shined his car lights on the water in the direction that we needed to head towards." Safe in the harbor, Capt Franz and Tugboat Tedd hugged each other knowing they had barely escaped death.

Post Story: As of 3 p.m. December 3<sup>rd</sup>, the lost tug was estimated to

be 20 miles northeast of Whitefish Point. The coast guard was unavailable to help retrieve the wayward tug and the crew was waiting out the storm, retelling their tale over a pint at the Dunes Saloon, before returning to the waters of Gitcheegumee in search of their lost tug.







# DNR Invites Deer Hunters to Participate in Online Survey

The Michigan Department of Natural Resources is asking for help from deer hunters. Accurate and complete information on hunting activity is vital for sound deer management. To obtain more hunting-related information, the DNR is offering a new option for deer hunters to report their hunting activity over the Internet.

Beginning today, all deer hunters are invited to complete an online survey. The survey is available on the DNR Web site at www.michigan.gov/dnr under the Hunting and the Deer sections.

The DNR is requesting information from all deer hunting license buyers, even if they did not hunt or harvest a deer this year. In addition, hunters should complete the survey only after they have finished deer hunting for the 2006 license year. Once hunters submit their answers, changes or additions will not be allowed.

"Last year, we held 21 public meetings across the state in relation to deer population goals," said Bill Moritz, Wildlife Division chief. "One of the constant themes was that hunters wanted to provide the DNR with feedback on their deer season, from the number of animals they saw to their harvest success."

Traditionally, the DNR has estimated deer hunter effort and success using surveys that were mailed to a sample of randomly selected hunters in scientifically designed manner. The traditional mail surveys will continue; however, the new online reporting option allows all hunters with Internet access to participate.

Moritz said the DNR is excited to pilot this online reporting option. Information from this source will be compared with the established mail survey process to compare the success of hunters using the Internet to the broader population of deer hunters.
