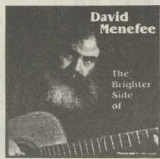

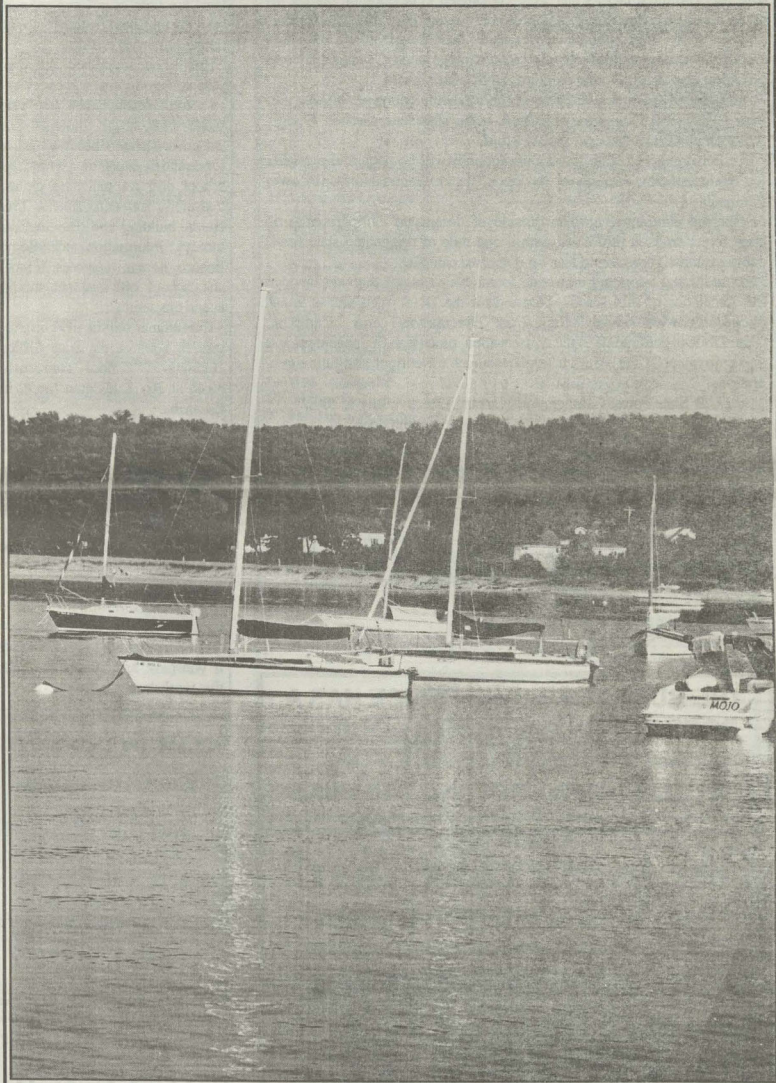

## What's been happening around town!

Supervisor Jack Hubbard is working on some of the problems that have occurred in the township over the last few years. Woodland Park will be having work done in the near future on the electrical system supplying the campsites. Jack is in contact with an engineering firm, looking into just what needs to be corrected and in what order the work needs to be done. The engineering firm will also look into the marina and give their opinion as to what has to be done there.

Jack is in contact with the lobbyist the township hired to help "Save the Harbor" and is working on getting the funding that is needed to get the breakwall project on tract. If you come to the regular monthly meeting of the Burt Township Board held the second Tuesday of each month at 7:00 p.m. at the Community Center, he will be glad to answer any questions he can. He is also talking with the different government agencies and legislators (both state and national) getting all the help he can to "Save the Harbor." Next time you see Jack tell him to "keep up the good work."

### DNR Announces Closure of 20 State Forest Campgrounds

The Department of Natural Resources today announced the closure of 20 state forest campgrounds throughout the state to facilitate a \$75,000 reduction in state General Fund appropriation to the Recreation and Trail Program for fiscal year 2007. The campgrounds will be closed effective Monday, July 9, 2007.

State forest campgrounds are within state forest lands in Michigan, and are not state parks. State forest campgrounds offer a more rustic setting for primarily tent camping. Basic campsites are \$15 per night or as posted at the campground information stations. State forest campgrounds are not staffed and are not a part of the DNR's online reservation system.

"To be forced to limit any outdoor experience has been a very difficult decision for the department," said DNR Director Rebecca A. Humphries. "Michigan's natural resources offer amazing recreational opportunities, and we encourage everyone to camp at one of the 118 campgrounds that will be open the remainder of this season."

All 138 state forest campgrounds were reviewed in developing the closure list. The three factors that were considered in developing the list include revenues collected per campground, revenues per campsite and revenues per mile. The combined factors placed the closed facilities at the low end of the revenue-producing state forest campgrounds. Closing them will provide a cost savings to the program, DNR officials said.

Campground closures will occur in the following counties: Alpena, Antrim, Cheboygan, Chippewa, Crawford, Luce, Marquette, Oscoda, Otsego, Schoolcraft, Grand Traverse and Wexford.

The remaining 118 state forest campgrounds will be open and available for rustic camping throughout the Upper Peninsula and Northern Lower Peninsula.

Dispersed camping (camping outside of designated campgrounds) on state forest lands is prohibited within one mile of designated state forest campgrounds. There are no fees for dispersed camping.

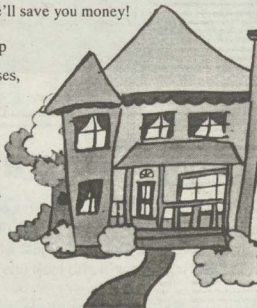

### Records Management Workshop: An Introduction for Local Governments

Good records management is good government. Everyday Michigan citizens use the records managed by more than 2,300 units of local government. As the 2005 hurricane season has demonstrated for the residents in the effected area, the loss of local government records creates many challenges. Buying and selling land, solving criminal cases, and receiving health care were just a few of the services which were challenged by the loss of records. Fulfilling basic administrative, fiscal, and legal functions of government was severely impacted by the loss of or damage to local records.

This 3-hour workshop will provide an introduction and overview of records management responsibilities of local governments. Local government officials working for counties, cities, townships and school districts, including clerks, treasurers, law enforcement, fire, courts, building and planning, attorneys, information technology, finance, human resources, librarians, school officials, etc should attend this seminar.

The seminar will be held on August 9, 2007 at the State Office Building, 2<sup>nd</sup> floor conference room at 305 Ludington Street in Escanaba.

**Summertime**  
**Fruits and Vegetables**



Summer is here and so are the farmers' markets offering an abundance of fresh fruits and vegetables. Fruits and vegetables provide a good source of carbohydrate,

soluble and insoluble fiber, vitamins, minerals, antioxidants, phytochemicals, and flavonoids, and are generally low in fat or fat-free. Both fruits and vegetables are an important part of meal plans for people with diabetes and those who want to prevent diabetes.

Non-starchy vegetables are very low in calories and high in fiber and therefore can increase the feeling of fullness. Especially when eaten raw, non-starchy vegetables are generally considered "free foods" for people with diabetes. One-half cup cooked or 1 cup raw is considered 1 serving of vegetables (5 grams of carbohydrate and only 25 calories). Just watch out for what you dip them in!

Fruit is also important. However, fruit does contain more carbohydrates and needs to be considered as part of the meal plan for persons with diabetes. Large amounts of fruit can cause blood sugar levels to go up and lead to poor control of diabetes.

Fruit juices do contain some nutrients, but the calorie levels are about the same as drinking regular soda, and they are basically low or fiber free. Therefore, juice does not contribute to helping you feel full. Also, fruit juice portions are small and usually gone in about 3 swallows.

Grand Marais Memories

TED

Ted and Marge Soldenski's place sits on the inland side of the bay in Grand Marais. It looks cottage-y and inviting, full of charm and cheer, with baskets of petunias hanging off the eaves in the summer and wooden chairs under the porch's shade. There are two hand painted signs low to the ground in the yard: both say "Please." I've always imagined that as shorthand for the Golden Rule, assuming it means please stay off the grass and don't park here or snowmobile through the yard but most of all please just use your head and be a reasonable person. Act the way you'd want to be treated. Another hand-lettered sign off to the edge of the property, closer to the small drop-off above the water says, "Trouble Road, No Trespassing."

Ted called on a hot afternoon in late July, saying he had time to talk if I could get away, so I grabbed my notebook and went. I could easily have spent the whole afternoon. Ted is interesting, and easy to talk to, and we wandered across many topics—old Grand Marais, global warming, work, religion, life.

Ted is ninety four and a half he told me, and he doesn't want to get old. "I got a sister ninety nine who hasn't been good for nothing the last few years. I don't want to get like that. I want to go fast. Out walking or something."

I nod, in total agreement. "But you don't get to choose," I say sadly, feeling bound to tack this on.

Ted sighs. "No," he agrees, "you don't get to choose."

Ted has two sisters still living, one older and one younger than him. He himself is in great shape. He walks every day, drives and goes gambling. He told me on his ninety second birthday that all that's left when you get to be his age is sex and cards. He's thin and wiry, spry, comfortable in his own skin. He was barefoot this hot day, wearing plaid shorts and a short sleeved cotton shirt, lounging in a comfortable chair in the kitchen. When I say he looks great, he gives a rueful laugh and asks if I want to know his secret and pops open the drawer to a small wooden bureau beside his chair, full of medicines.

I nod, shrug—so it goes. Ted slides the door back shut.

"I can't complain though. I'd be ashamed to tell you what all this medicine is for. I won't. You go into the doctor and half the people are worse off than you. No, I won't complain."

"But you really are in great shape."

"Yeah, well, I never had no hard liquor 'til I was ten years old."

I laugh. "Well you sure waited long enough."

Ted grins.

"I was an urchin," he says of his childhood self at one point. I am looking at a photo of him at eight or so, dressed in patched overalls, standing beside a horse, wearing an impish expression that is somehow eerie in its currentness.

"Look at you!" I cry. "You were an urchin." There is just simply no other word for it. "You look exactly the same as you do now."

Ted smiles with some satisfaction.

He'd greeted me when I came to the door by ringing a cowbell. "I was a cowherd as a boy," he told me. "I knew all the cows in town."

"So the cows had bells on their necks?"

"Yeah, every one of them, and I knew them, and I don't know nothing about music but I could remember every cow bell there was. And I can tell you something else. The bay was full of docks back then and in fly time the cows would be all underneath and only their tails sticking out."

"To stay in the shade?"

"To get away from the horse flies. All you could see was their tails. And another thing—we didn't have the mosquitoes we got now in the summer because the cows would keep the grass so short."

"Did they roam around town or were they fenced in?"

"No! They just roamed around, and the horses too."

A picture of Grand Marais in 1920 or so is emerging, like a print coming out of a photo bath. Ted was born in Grand Marais, one of fifteen children, the third from youngest. His father, Valentine, came from Poland as a young man of nineteen or so. His eighteen year old mother, Maryann, was from Alpena but was helping a sister run a boarding house in Seney when she met Valentine. The two married and settled in Grand Marais. Ted was the only one of their children born in the Bay View Hotel, which was in East Town, on Carpenter Creek. "You know they used to put businesses right on the sidewalk to use up the whole lot, but the Bay View was set eighteen feet back from the street. I was born there because the town in 1912 went bad. The lumber and the railroad went out and Ford was paying money down in Detroit, so this was like a ghost town, they left it. They asked my father to be a caretaker. And I was born in the Bay View, I'm the only one in the family, and why did they build it eighteen feet off the road?"

"Why?"

"Because they had to get the toilet over the creek."

"Oh wow."

"Yep. Across the street was the Carpenter House and the Swanson house just kitty corner from that, and the Bay View. There was three hotels in one block."

They're all gone now—just the memories and some pictures remain. I gaze at a black and white photo of the sign on the roof of the Bay View. "So, what's your birthday?" I ask, picturing Maryann in one of the rooms, preparing to have her thirteenth baby.

"Twelve, twenty eight, twelve."

Winter, just after Christmas. Usually there's some kind of blizzard raging the week after Christmas and later I think to wonder if it was so in 1912.

"Have you lived here your whole life?"

"Nope. I spent my time in Hell. I always say I paid for the Mackinac Bridge. Came back up every chance I could. I went down to Detroit during the Depression. I went down for a vacation. I was up here making moonshine—"

"Were you really?"

"Yep. And I went down to visit some family and got work at Dodge's and stayed."

Ted was a ding man—someone who could take dings out of metal without damaging the paint—for Dodge and then Chrysler for thirty eight and a half years. He got the job during the Depression, when you had to stand in line for hours every day in hopes of getting hired, and generally had to be an "apple polisher"—know someone—to get in. But Ted was "brown as a berry" from playing ball up in Grand Marais, and strong, and he got chosen for a job, and stayed. He took an early out in 1972, at the age of fifty nine. He and Marge immediately moved back to Grand Marais, to this small house he'd built, across the street from the Catholic church and next to where one of Grand Marais' two blacksmith shops used to sit.

"I always wanted to live in a house by the side of the road and be a friend to man," Ted says. "You've heard that poem haven't you?"

I have. I think it fits him well.

"Was there anything you liked about it down there in Detroit?" I ask.

"Nope."

I realize later that I should have called him on something. He met Marge downstate—she grew up there—and he seems to me a man who truly loves his wife. "Margie," he calls her fondly. "Margie's gone right now but she'll be home tomorrow."

We talk about so many things I can't begin to fit them all in to a short piece in the paper. Finally I give up. The wood his family cut and hauled to burn to make the town's electricity, the blueberry fields they worked in east of town all summer and the fiddle dances out there, the two big trees he inadvertently helped kill by pounding holes in them as a kid and which he made a pilgrimage to see every year, his childhood chore of cleaning the house's spitoons, getting his old man a lunchpail full of beer at McCann's Saloon (that toilet was over the creek too) when he was five years old, watching two of his brothers go off to World War One and return, the town's snow roller which he tried to save for posterity but that got donated for scrap metal during the next war, his first haircut at Duvell's Barbershop and the way he hopped out of the chair and told the barber to put it on the tick just like all the grown men did, his first taste of canned peaches from hunters up from downstate, his time in the Army in World War Two, getting all the squirrels in town drunk on mash back in his moonshining days, even how to make moonshine—it all has to wait, for another essay, another time.

After talking and talking we wind down a little. Was the weather different?" I ask.

Ted shakes his head, sighs a little. "I don't know," he says. "It seemed different. Ten times different. But I don't know."

I know what he means.

"One thing I do know though," he says. "The stars aren't as bright as they used to be."

"Really?"

"Absolutely. I'm sure about that."

We're quiet for a moment. Then he says, "You talk about characters. I grew up in an era of characters. All those old fishermen down on the docks, they all chewed Copenhagen and they'd spit on your feet every time you walked past just to do it. And everybody lied in their days."

I smile.

"I'll tell you about old Charlie Goodman—he really was a character. He was wanted in New York and wound up in the Soo, he trapped beaver for a living, had a dog team. When he got to Grand Marais to Hoodlum—that was the red light district, out by where Mrs. Woods' cabins are now—he thought it was a good place to stay. He paid the madam in beaver skins and she gave him change in cowhides and couldn't get 'em all on his sleigh so he had to stay another week."

I think this through. "Do you think it's true?"

Ted gives me a kind look, a forgiving look. "Well," he says. "Probably so far as it goes. Probably he did stay the night down there."

"Did you have a happy childhood?"

"Oh, yes. I was a barefoot boy. You know that poem? 'Blessings on thee, little man, Barefoot boy, with cheek of tan! With thy turned-up pantaloons, And thy merry whistled tunes; With thy red lip, redder still. Kissed by strawberries on the hill—'"

It fits him, the urchin that he was and is.

"What's your advice to people in life?"

"Be a simple man. Owe no man. Have a clear conscience. Be like the village blacksmith."

Earlier he'd recited Longfellow's poem, "The Village Blacksmith," he made me feel a little teary, for so many reasons—my father was a blacksmith; Ted reminds me of him a little; both my dad and my grandfather and my great aunt Bess would have done something like this—recite a poem—and they're all gone and I miss them and people just don't do this anymore, don't recite poems. The last verse seems a fitting close:

*Toiling,---rejoicing,---sorrowing,  
Onward through life he goes;  
Each morning sees some task begin,  
Each evening sees it close;  
Something attempted, something done,  
Has earned a night's repose.*
