

Supervisor's Report: Supervisor reported on the Small Harbor Coalition going Great Lakes wide, Senator Levin appropriation request for dredging and adding infrastructure for our harbor. He also reported about his conversations with Fish and Wildlife about the biological studies for the breakwall and they are now working with the Corps of Engineers

**Treasurer Report and Payment of bills:** Motion offered Treasurer Report and Payment of bills: Motion offered by Wieting, second by Leavenworth to approve both the post-audit and bill sheet with additions for Susan Maki & ZBA Members — 5 ayes. Treasurer Report, Bill Sheet and Post Audit Reports are available for inspection. 



### SEEKING OLD IRISES

The publication of the Historical Society's wonderful new book of old Grand Marais photos reminds me of a project I've been playing with for years: to collect and display Grand Marais heirloom garden plants. Heirlooms like furni-

ture, china, and photos are passed down through a family, and plants may be, also, with one big difference plants make more of themselves, and so can be shared with friends and neighbors, too. Sadly, like non-living heirlooms, they may also be lost accidently or just if no one cares about them. That has happened with many heirloom garden plants in many places, and it would be a pity if we let it happen here.

The plants I want to focus on right now are bearded irises. The beard is simply the part kids call the 'caterpillar" on the lower petals of these familiar flowers. Bearded irises send up pale green, spear-shaped leaves from fat horizontal structures that grow part in, part out of the ground. Although most gardeners call them roots or bulbs, these are technically called rhizomes, and serve as storage reserves for the plants. Historic bearded irises are strong, tough plants, easy to swap and share. They bloom in late spring and early sum-

If you have a patch of old bearded irises, I'd love to hear from you. If possible, I'd like to photograph the plants in bloom, to see if we can identify the variety. Using photos of the flowers, leaves, the base of the leaves, the branching of the flower stalks, and so on, as well as measurements for size and notes on scent and any history known about the plants, the Historic Iris Preservation Society (HIPS) can help us identify these old treasures. Of course I'd be delighted if anyone wants to share a "toe" of an old iris as well. Irises, like everything else these days, are considered antique if they're 50 years old or more (suddenly I feel very special and valuable), but HIPS lists irises bred as recently as the 1960s, because they are in danger of disappearing.

I'm hoping to interest the Grand Marais Garden Club and the Historical Society in helping us preserve local heirloom plants, the living history of this town. Aside from being of interest historically, they have another special quality: they're beautiful.

If you're interested in learning more about old irises, you may wish to visit the website of the Historic Iris Preservation Society at < http://www.hips-roots.com>. Membership is only \$10 per year; you may join online or write to Membership Secretary, Judy Eckhoff; 7911 S. Yoder Rd; Haven, KS 67543-8114. The website is fun; among other things, it shows photos of many historic irises. HIPS also has an annual historic iris sale.





Speaking of Paradise, can anyone forget the converted cafeteria made into their gym? I remember hitting the ceiling on a couple shots, and half-court was about where the three-point line is today. If they're still using it, it may be the smallest high school gym in the state. We also played Mackinac Island two double-headers (with players and cheerleaders staying at the host's houses). I tell my students we traveled to games by sleigh ride, as we did unless transported by snowmobile. Engadine, Big Bay de Noc, Cedarville, Perkins, Trenary, Eben, and Alba (downstate) were other towns we faced.

Once you got into seventh grade, part of the focus was raising money for the eventual Senior Trip, and some of the ways we raised it were by the usual stand-bys of bake sales and raffles, but also the tradition of the Senior Pasty Sale started with either the class of 1977 or 1978. My own Class of '79 had Jim Becker (social studies teacher at that time) as auctioneer, and we had a pretty profitable auction one Friday night. Kenny Laeder and most of the rest of us cut and sold orders of firewood also in the fall of 1978, and we had many other fundraisers so all 16 of us could go on the trip.

What about summer jobs? All three of my sisters and I worked at Welker's Restaurant and Lodge, my sisters as waitresses and I first helped with the mowing, getting the garbage to go to the dump with Wayne Pirlot (Betty Welker's daughter Diane's husband, retired from the Coast Guard) or Geogina Mixon). Later I washed dishes and one summer helped as a cook. I remember Kayleen LeFebvre and Marilyn Mixon being waitresses a couple summers, as well as Natalie Coles and Cindy Barney. Over at the gathering place in town, the Kozy Korner, Bob and Sue Hicks ran the show and were always ready with a smile (albeit some times a grumpy one from Bob) and some general chit-chit as you sat and had coffee at the "Local Table" (or whatever it was called, I forget). Bob's kids and many others worked waiting on the tourists (and locals) and in the back with cooking and dishes. Around 1976 or so he had Mel McFee put blocks on the back and Bob put in some pinball games and things for a "Teen Room." Jeff Heacox and Chris Lundquist worked at the gas station for Chris' dad just across form the Kozy Korner.

Mel McFee was where Dennis Elliott worked hard as mason tender and cement finisher for several summers. I joined a year or two later, and I remember Dennis passing on words of advice as to how to "keep Mel happy" (which could be tough if the cement was hardening up too fast or he didn't think we'd gotten enough of the wall or chimney done that day). Dave Becker employed Dennis and a couple others, as well as his own son, Mike, and Jeff Sibbald before Mel. The fall of 1977 I joined and helped as Dave finished up the big job of putting a foundation under Bess Cappogrossa's Superior Hotel.

Others worked at Willard Handrich's sawmill when they turned 18, or Smith's or the third one was started later.

Of course summer wasn't just work. We played tennis and basketball on the park court, punted footballs to each other

in the baseball field, rode bikes (sometimes to Sable Lake, and if we had money, we could buy something at Dee Hubbard's Cubbard that was there for a time), had bonfires on the beach at the bay or out on Lonesome Point. In the early 1980's, Dennis Elliott and Jeff Heacox would play their banjos and for a couple years, Jerry (helped out at the Catholic Church-a friend of Fr. Jim's, I think) would sing and play his guitar at bonfires on the beach or often at Dennis' house while we had a few beers.

Grand Marais' summer men's softball team (there was a women's team for a few years as well) was fairly competitive for many years, though I don't remember us ever winning the league over the Curtis Swampers or any of the Engadine/Naubinway/Gould City teams. We also played weekend tournaments in the summer, at Germfask (I think it was always the first one, Memorial Day Weekend), Curtis, and Newberry (and once or twice in Marquette). We had tall Charlie Chapin at first base, Mike Ballard sometimes at second (or third or the outfield, as he was a very good athlete) along with Mike Morrow, first Pat O'Driscoll and then Dennis Elliott at short, and Jeff Sibbald or Jeff Mallory (Coast Guardsman) at third. Speedy Ricky Capogrossa, Ray Gage, Jack Hubbard (also caught), and I played the outfield, while Lee Keith (Coast Guardsman), Tom Baker, Ballard, Gage, and John Fishbeck were some of the pitchers I recall. Those double-headers on Wednesday nights gave us something to look forward to as we worked during the day, and "replays" to go over at night in the Dune's saloon over pizza and beer.

Chess was something I remember we did when the weather was bad outside.

Beginning in fifth and sixth grade in Mrs. Olli's class if we had all our work done, and going on into junior high, Russell Nibblelink, Randy Becker, Troy Potter and a couple others were really good, I recall. In the winter, I remember Tim Stier, Pat Rivera, Mike Morrow, Mike Becker, and others and I would play pool at Bill Britz, Sr.'s Dune's Saloon as the winds howled outside and adults sat at bar stools and talked.

Some of the names in town were Ted Soldenski (who just passed away about a year ago), George Trevethan (handyman builder), Bill LaCombe, county foreman (recently deceased), Larry Nyman, Sr., Bill Bailey, the Dombrowskis (who owned the Halfway Cabins (probably had a different name, I'm thinking) when we moved to GM in 1971. Bruce Klotz and his wife and kids ran the Green Haven, and who can't recall what wonderful pizza they had. They'd have the big barrel stove roaring in the winter as you came in the door, and snowmobilers frequented that bar before heading into town to go to Jerry Alverson's Sportsman's and the Dunes. In fact, do some of you remember when snowmobile races were held on the bay?

Other of the "town pillars" were Arvo Kallio with his hardware (before Bill Stier and his family bought it in about 1974), Oiva Ylimaki and the IGA (later taken over by Dick Perlick and Gerry Marshall), Don Morrow (carpenter)

along with Joe Hoffenberger, some of the Coast Guardsmen when there was a full-time Station in Grand Marais, Doug (builder) and Marge Thompson and their seven kids, and Jack (jack-of-all-trades) and Joyce Bezotte (who took over the Kozy Korner).

I can hardly walk by what used to be the Kozy Korner (now a tourist/craft shop I believe) without remembering all the days sitting drinking a pop after working with Mel or having a cup of coffee and seeing the Bay out the big picture window. You could see storms coming off Lake Superior and people scurrying by if it was cooler and windy out. In the winter, the snow would blow up in the corners of the windows as it did to most of the businesses on Main Street, and sometimes you could feel as if Mother Nature was swallowing you up in snow and cold. There weren't obviously many businesses for teens to go into, but we'd play hockey in our boots on the road behind my mom's house, with big clumps of snow as the goal posts, snowshoe sometimes, and sometimes cross country ski.

It's a small place, Grand Marais, but small places can make solid people and people who have dreams just like those graduating from bigger places. Hopefully Burt Township School can hang on for a long time, despite the current economic struggles.

Barack Obama was born in 1961, like most of us who graduated in 1979. When I read about his ascendancy to the presidency, it makes me wonder why some people accomplish so much in their lives, while others have dreams (not probably to be president!) that go unfulfilled. What hopes, dreams, loves, or goals did you have as you graduated from BTS (or even just went there and moved somewhere else to graduate)? Some Grand Marais graduates may have planned to get married and have a family but didn't or couldn't. Some possibly wanted to go into the service, go to college, or start their own business but haven't yet. A few of you maybe have had bigger dreams, such as flying an airplane, restoring a car, running a marathon, inventing something new and use ful-who knows. Some ex-Polar Bears maybe have already achieved some of their dreams of seeing other countries joining the military service or Peace Corps, building their own homes, graduating from college, running their own business, raising good kids. There's obviously always time left to accomplish some goals we've always had or perhaps have recently thought of.

And so as we age and our own kids go through school (or already have), if you're like me, some of what they go through reminds you of our time at Burt Township School, a time honestly (pardon the cliché') sort of "frozen in time" for me. Almost all childhoods and high school years can be mostly good times mixed in with periods of anxiety, whether you grew up in the remote "Cape Cod" town of Grand Marais, in a bigger city downstate, or even in another state or country. Memories—if not actually blurring due to time or selective memory—become nostalgic, warm thoughts in our mind, sometimes making us wish for those simpler, more fun-loving times of our youth.



**Mantracking Course Taught in Burt Township** 

Eastern Upper Peninsula Search & Rescue (EUPSAR) members had a fascinating time this past weekend in a mantracking course. Marvin Martin and Chuck Koehn, instructors with Universal Tracking Services of Oregon and Washington, flew in to teach the awareness-level course. Mantracking is the art and science of following human beings who are on foot, by detecting and following their footprints. It's an amazing and complicated skill. Several EUPSAR members, along with National Park Service personnel and police consultants, took the three-day course.

You may have seen us on Friday across from the National Lakeshore Visitors' Center, crawling across the meadow from 8:00 in the morning until 10:30 that night (yes, we took some breaks). Tracking at night proved to be challenging, but the most difficult time to see the tracks was

twilight. We moved out to the School Forest, just beyond the cement bridge, for Saturday and Sunday's sessions. Although the weather was lovely on Friday, Saturday's wind and snow presented extra challenges. Sunday's cold, sunny weather came as welcome relief. Tracking in the School Forest was very different from tracking in the meadow, due to differing terrain and vegetation. Even experienced hunters learned a great deal from this course; tracking humans is quite different from tracking wild animals.

All participants in the course said they found it interesting and well-taught; most are enthusiastic on going to the next level. For now we are all at the beginner stage, but at least we know enough to get started and to keep people from stomping all over the tracks of a lost person. This is a truly worthwhile subject of study for search and rescue personnel, as well as crime investigators - it has saved many lives. We feel privileged to have had such a fine introduction to it.
