Because of the large number of people attending the public hearing on the State's proposal to locate a Minimum Security Prison at the Acocks Medical Facility site, before Chairperson Lowe called the meeting to order he moved the meeting to the Large Circuit Courtroom.

Chairperson Lowe called the meeting to order at 7:15 p.m., roll call was taken and the following roll recorded: Present: Comm. Arsenault, Comm. Corkin, Comm. DeFant, Comm. Seppanen and Comm. Lowe. Absent: None.

Chairperson Lowe reviewed the Rules of Procedure for conducting public hearings and set forth the agenda. First, the Department of Corrections would make their presentation, followed by a question period by Commissioners. Then individuals or organizations present may make public comment, however Chairperson Lowe requested those desiring to make public comment fill out a three-by-five card that is being distributed upon entering the Courtroom.

The Committee of the Whole first heard a presentation by Department of Corrections representatives James Kurran and Wayne Stine. Included in the Department of Corrections presentation was a supporting statement of the Minimum Security Prison by Jack Kreiger, Alger County Prison Impact Task Force. County Commissioners then addressed questions regarding the State proposal to Department of Corrections representatives.

Public testimony was then heard by the Committee of the Whole from persons present at the hearing.

Seppanen and unanimously carried that the Committee of the Whole recommend the County Board make no immediate decision on the Department of Corrections proposal to locate a Minimum Security Prison at the Acocks site, but wait until the matter is further studied.
