The Marquette County Board of Commissioners met as a Committee of the Whole for a Budget Work Session on Tuesday, September 12, 1989 in Room 231 of the Henry A. Skewis Annex, Marquette, Michigan.

Chairperson Corkin called the meeting to order at 6:30 p.m. Present: Comm. Arsenault, Comm. Bays, Comm. DeFant, Comm. Seppanen and Comm. Corkin. Absent: None.

Also Present: County Administrator, Dennis Aloia, and Finance Manager, Gary Yoder.

Chairperson Corkin opened the meeting for public comment, none was forthcoming.

Administrator Aloia distributed a list compiled from the Departmental Budget Reviews held on August 28, 29, 30, 1989 containing areas of concern and/or proposed changes to the budget from Commissioners.

The first item was the FY 1990 Capital Budget. After deliberation and discussion it was moved by Comm. Corkin, seconded by Comm. Arsenault and unanimously carried that the Committee amend the Capital Improvement Budget recommendation to include the Courthouse Air Conditioning Project for \$19,500.00, and delete the Perkins Park Master Plan Project for \$10,000.00, Resource Management Tractor for \$6,000.00, and the remaining \$3,500.00 to come from the last two items on the miscellaneous project list (Sheriff's Vehicle Light Bars and Employment Programs Floor Coverings).

The Committee then discussed and deliberated on the General Fund Budget and decided to review the complete list with Mr. Yoder keeping track of the various General Fund Budget changes. The total amount of additions to the budget would be determined after reviewing the complete list. Then Commissioners could decide where the money would come from and what items would be deleted from the General Fund Budget Recommendation.

The Commissioners completed the list at approximately 10:00 p.m., with

the only item unsettled being Elected Officials Salary Scale.

The following are changes made to the Administrator's General Fund Budget recommendations by the Committee of the Whole, and fine-tuned by Finance Manager, Gary Yoder.
