The Marquette County Board of Commissioners 1992 Equalization Meeting was held on Tuesday, April 14, 1992 at 7:00 p.m. in Room 231 of the Henry A. Skewis Annex, Marquette, Michigan.

Chairperson Corkin called the meeting to order. Present: Comm. Angeli, Comm. Arsenault, Comm. Seppanen and Comm. Corkin. Excused: Comm. Potvin.

A Salute to the Flag was given followed by the Pledge of Allegiance.

Chairperson Corkin opened the meeting for public comment, none was forthcoming.

It was moved by Comm. Arsenault, seconded by Comm. Seppanen, and unanimously carried that the agenda be approved as presented.

Dennis Waarala, Marquette County Equalization Department, Michael Wainio and Norman Fortin, members of the State Tax Commission, were in attendance to answer questions regarding the 1992 Equalization Report.

Mr. Waarala presented the County Board with the Assessed Valuations for the twenty-two assessing units. He explained that due to the "assessment freeze" that was enacted by the legislature in 1991, the principal goal for 1992 is to ensure that assessment rolls prepared by the local assessing officers meet the requirements of the freeze and no changes are recommended.

The recommended County Equalization Report included: 1) Recommended Valuation by Property Class with recommended multipliers; 2) Recap of Assessed Values by Class; 3) Recap of recommended Equalized Values by Class; 4) Recommended Total Real and Personal Values (Assessed and Equalized); and 5) a number of informational items.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault, and unanimously carried that the recommended Marquette County 1992 Equalized Values be approved as follows:
