## MOVE ON CHINESE.

Heavy Detachments of Troops Leave Peking for Interior.

## ON HOSTILE EXPEDITION.

General Lieu, With Ten Thousand Soldiers, Takes Up a Position and Bids the Allies Defiance.

## HARD FIGHTING IN SIGHT.

London, April 16.—A dispatch tonight to the Reuters Telegram company from Peking says that General von Gyll, in command of five thousand Germans and three thousand French troops, is heading an expedition to attack General Lieu at Hui Lu, 120 miles of Pao Ting Fu. Lieu's position is inside territory defined by Field Marshal von Waldersee as the sphere of operations for the allies. Lieu has ten thousand men and he has refused to retire, saying that if the allies wish him to retire they had better come and compel him to do so.

\$50,000,000 FOR INDEMNITY. The Peking correspondent of The Daily Mail says he thinks that the aggregate of the indemnities demanded by the powers will not be reduced below £50,000,000, and adds that "it cannot be too strongly pointed out how serious danger would result from a too excessive reduction of the claims. If the powers fail to recoup their actual outlays, they are likely to seek compensation by separate secret arrangements with Peking which would surely lead to grave complications."

## NEW FOREIGN OFFICE PLAN.

London, Wednesday, April 17.—Dr. Morrison, writing to the Times from Peking says:

"At a meeting of the ministers of the powers today, it was decided to adopt the recommendation of Mr. Rockhill giving effect to Article 13 of the joint note concerning the reform of the tsung li yamen and the modification of the court ceremonial. It was agreed that in place of the tsung li yamen there shall be a wai em pu, or board of foreign affairs, having precedence over other boards. It is to consist of a president, who shall be an imperial prince, and two ministers, one being president of a board and the other a member of the grand council with direct access to the emperor. There also shall be two vice-ministers having knowledge of foreign affairs, one of them speaking a foreign language. With regard to the court ceremonial, the ministers of the powers when about to be received in audience shall be conveyed in imperial chairs to the palace through the central gateways, shall be received in the halls where the emperor is accustomed to entertain the imperial princes and they be shown honor equal to that shown by European sovereigns to foreign ambassadors."

## EMPEROR WILL NOT RETURN.

Peking, April 16.—The Chinese court has replied to the recommendations of Japan on the subject that it is impossible for the emperor to return to Peking until the country's guests leave. A force of 1,100 Germans and a thousand French troops leave here tomorrow to join the Pao Ting Fu expedition against Lieu Kuan Ting.

## GOOD ROADS EXPERIMENT.

Chicago, April 16.—The National Good Roads association commenced today its first practical demonstration of road construction on its southern trip. At the town of Ploosmore, thirty miles south of Chicago on the Illinois Central railroad, ground has been broken for the building of a quarter of a mile stone road under the supervision of Charles T. Harrison, road expert of the United States department of agriculture. The road will be completed by Saturday, when the "Good Roads special" will start for New Orleans, where the next demonstration will be given. Senator Martin Dodge, director of public road inquiries of the United States department of agriculture, and R. W. Richardson, secretary of the National Good Roads association, were on the ground today accompanied by Professor W. R. Hogg, of the Engineering department of the University of Minnesota, all of whom will accompany the train on the trip south.

## RENEWED RIOTING IN RUSSIA.

Vienna, Wednesday, April 17.—A dispatch from Lemberg, April 17.—The Kreuz Wiener Journal asserts that further trouble has occurred in Russia and that wholesale arrests have been made in Odessa and other cities. The correspondent says also that 15,000 signatures, including merchants and landowners, have been secured to a petition to the emperor to grant a constitution.

## JOE CHAMBERLAIN DENOUNCED.

Chicago, April 16.—Queen Wilhelmina of the Netherlands was toasted and Joseph Chamberlain of England denounced at the sixth annual banquet of the Holland society of Chicago, held tonight at the Grand Pacific Hotel. About one hundred members of the society were present, with a number of invited guests, and the affair was the

most successful and brilliant of its kind ever given under auspices of the club. President George Birkenhead, Jr., at the head of the long table made the opening address. The chief address of the evening was that of Rev. Henry E. Dosker of Holland, Mich. Other speakers were Judge Peter Grosscup and Professor Edmund James.

## GOVERNMENT COMPROMISES.

HAT TRIMMING TARIFF CASES ARE FINALLY SETTLED.

Philadelphia, April 16.—The famous "hat trimming cases" which had been the subject of a bitter battle for several years between the government and a number of importers, were settled in the United States district court here this afternoon. The settlement is a compromise by both the government and importers.

The importers, Meyer & Dickinson, Kohn, Alder & Co., Tilge & Co., and Meyer Ebeling & Co., brought suit against the government to recover, as they claimed, an overcharge of duties on imported hat trimmings. The government claimed that instead of being used for hat trimmings, the goods were being used for other purposes, and that 50 per cent. was the proper rate to be charged. In the settlement effected today, the government admitted that some of the goods were hat trimmings, and a verdict subject to further revision by the collector of the port, was rendered in favor of Meyer & Dickinson for \$58,000; Kohn, Alder & Co., \$2,110; Tilge & Co., \$400, while Meyer Ebeling & Co., received no money verdict. In the early part of 1884 and during the following three years, more than \$90 suits were brought against the government by New York and Philadelphia importers to recover all excessive duties exacted by the government in the classification of hat trimmings. Some of these cases were won by the importers, while in others verdicts were rendered in favor of the government. As the final settlements appeared to be subject to interminable delay, both sides agreed upon a compromise. All the suits outside of this city have already been settled. Judgments were entered in the courts for the amounts agreed upon.

## BLIZZARD IN THE WEST.

Denver, Colo., April 16.—Reports from northern Colorado are to the effect that a veritable blizzard has prevailed on the prairies for the past twenty-four hours and still continues. The snow is drifting badly and railroad traffic is delayed. In the vicinity of Denver and on the plains the storm is described as the worst for years.

Cheyenne, Wyo., April 16.—One of the worst storms in recent years has been in progress here for the past eighteen hours. The snow is light and a high wind has drifted it badly. Livestock losses from this and former storms are enormous. All the small ranchmen in western Nebraska, South Dakota and eastern Wyoming have lost heavily. The temperature is now near zero.

## BRIDE COMMITS SUICIDE.

English, Ind., April 15.—Mrs. Fanny Conroy, wedded last Thursday, committed suicide today by drowning in a well. She left a note for her husband, saying: "Goodbye, Frank. I love you with my whole soul, but life is not what I expected."

Seattle, Wash., April 16.—In a fit of despondency over business reverses, aggravated by the depressing effects of an attack of la grippe, Melvin R. Baldwin, ex-congressman from Minnesota and former state superintendent of Indian affairs under Cleveland, this afternoon ended his life by shooting in the head. Baldwin lives a widow and two sons, who reside at Duluth, Minn. He was sixty-two years old.

## TOWNE MADE PRESIDENT.

Duluth, April 16.—Charles A. Towne, the Populist nominee for vice president last year, is president of a company just formed here to work what is said to be a vast deposit of corundum, an abrasive mineral similar to emery. Two Democratic friends of Mr. Towne, E. E. and T. B. Lewis, discovered the deposit, consisting of two hills, practically all composed of corundum, on the north shore of Lake Superior about twenty miles from here. They made the Populist leader president of the company, which is stocked for \$1,000,000. It is the intention to establish a plant in Duluth. A number of other Duluth people, interested by an odd coincidence, are interested in the mine with Mr. Towne, and great things are expected from it.

## CHRISTIAN SCIENCE VICTORY.

Milwaukee, April 16.—Judge Elliott, of the circuit court, has discharged the two Christian Science healers, Mrs. Crescentia Arries and Miss Emma Nichols, who were on trial for practicing medicine without a license. The defendants in the case, the court said, had not attempted to deceive anyone and had not claimed to be doctors or to be qualified to act as such. Not only had they not prescribed drugs or medicines, but they were opposed to such prescriptions. The decision is an important one, as it will settle the status of the Christian Scientists for the future in this state.

## LIGHT WANTED ON FRAUDS.

Cebu, Philippine Islands, April 16.—Judge Taft, president of the Philippine commission, says that Mgr. Chappelle, papal delegate to the Philippines, recently told him that the friars would not be allowed to return to the provinces and that only a sufficient number of them, now in Manila, would act as instructors in the colleges. This disposes of the troublesome "friar question."

## WAR STILL ON IN CEBU.

Cebu is the first island to be visited by the commission upon which the insurrection is still active. It is unsafe to leave the city of Cebu without an armed escort. The delegates from the towns of the islands who are now here are anxious for the establishment of a provisional government, which they believe would assist in ending the insurrection in Cebu.

## REBEL BAND IN BAD FLIGHT.

Manila, April 16.—The chief of staff of the insurgent General Mascardo has surrendered at the town of Mariveles, in Bataan province, Luzon. He said that Mascardo's band is now greatly diminished and are in a bad way. It is impossible for them to elude the Americans and they are unable to obtain food and want to surrender. It is expected that Mascardo himself will surrender shortly.

It is intimated officially that an announcement regarding the disposition of Aguinaldo will soon be made.

## WOODRUFF INNOCENT.

Speaking of the commissary scandals, a prominent army officer said to the Associated Press today that he had every reason to believe that Colonel Woodruff, head of the subsistence department at Manila, is not implicated. He said that Colonel Woodruff was one of the ablest men in the service and that his honesty is unquestioned. The irregularities in the commissary matters were at first attributed to Captain Read's unfamiliarity with commissary work. Colonel Woodruff was reluctant to believe that frauds were being perpetrated, but the facts disclosed caused him to give Captain Read a most severe reprimand and begin an investigation.

## MARTHUR QUIRED.

Washington, April 16.—Secretary Root today cabled General MacArthur asking for additional information concerning the reports of frauds in Manila. It is expected a reply will be received tomorrow. While definite instruction had not been given General MacArthur heretofore to make a searching and complete investigation, it is understood that the request for information was of a character to imply that the department expected that such an investigation should be made. It was stated that the department intends to have all the information possible on the subject and General MacArthur will make a complete report on any wrongdoing.

Major Geo. B. Davis, whose name was mentioned in the dispatch from Manila yesterday, is now in Washington. He would say nothing today when asked if he desired to reply to the assertion. He was called upon by the war department for an explanation, and the officer said he knew nothing about the matter. Although he is in this country on sick leave, he will return to Manila, and if the matter is not cleared up when he arrives will demand a court of inquiry.

MEN MAY DOFF THEIR COATS DURING THE HOT WEATHER.

Washington, April 16.—An order was signed today by Postmaster General Smith amending Section 431 of the amended postal laws by adding the following: "Shirt Waists—During the heated term postmasters may permit letter carriers to wear a neat shirt waist or a loose fitting blouse, instead of a coat or vest, the same to be made of light gray chambray gingham, light gray cheviot or other light gray washable material, to be worn with a turndown collar, dark tie and neat belt; all to be uniform at each office."

## PORTO RICANS DENY PROSPERITY.

Ponce, Porto Rico, April 16.—The chamber of commerce today met in response to a special call and discussed the commercial and general conditions of the island. The administration of Porto Rico was criticized and it was resolved to cable to Washington denying the statements of Governor Allen and Secretary Hunt in regard to the prosperity of Porto Rico. The chamber also telegraphed to the chambers at San Juan and Mayaguez to co-operate on the same line.

## HORSES FOR THE BRITISH.

New Orleans, April 16.—The steamship European, with eleven hundred horses, cleared today for Cape Town.

## STEYN REELECTED.

London, April 16.—A Cape Town dispatch says that forty Boers recently met at Boshof and solemnly re-elected Steyn president of the Orange Free State.

## FOR NEW FRENCH EMBASSY.

Washington, April 16.—Papers have been signed by which the French government acquires a large tract of land in the heart of the residential section of Washington for the purpose of building a French embassy. The site is a high knoll a short distance west of Connecticut avenue with a frontage on S and Twenty-second streets and Decatur place.

## MUD STOPS IOWA TRAFFIC.

Ft. Dodge, Ia., April 16.—Traffic by roads is practically at a standstill in this vicinity on account of mud. Farmers are unable to get into the city and butter and eggs and potatoes are almost unobtainable. The roads for miles in every direction are dotted with abandoned buggies and wagons which are stuck in the mud.

## EDWARD'S CORONATION.

London, April 16.—The coronation of King Edward will take place at the end of June, 1902, and Westminster Abbey, according to Truth, will be entirely closed to the public for four months prior to the event. All services will be suspended in order to prepare the interior for the ceremony.

## CHICAGO MAN KILLS BROTHER.

Chicago, April 16.—As a result of business differences, Robert F. McFetridge today fatally shot his brother, William S. McFetridge, in the presence of several hundred persons. The former, with his partner in an ice company, Charles Elkins and E. J. Courtney, was arrested.

## ROYAL RESIDENCE IN IRELAND.

London, April 16.—According to The Onlooker (a society paper), a site of 145 acres has been acquired in Ireland for the erection of a royal residence, plans for the building have been approved and work will commence shortly.

## UMBRELLA RIB COMBINE.

Philadelphia, April 16.—A combination of umbrella rib manufacturers has been completed and will be known as the National Umbrella company. Six firms are engaged in the manufacture in this country with an aggregate production of the value of a million dollars.

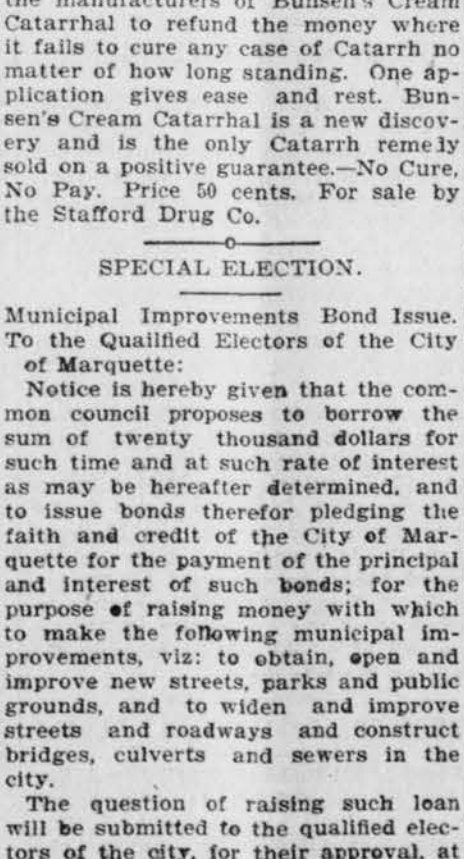

## HOUGHTON LIME KILNS RESUME.

### BIG DEMAND FOR THE PRODUCT CAUSES AN EARLY START.

The Houghton lime kilns, located on the lake front just below the Houghton end of the county bridge, are again active, operations having started there the fore part of the week under the direction of Manager John Mitchell. The plant is always idle in the winter, resuming work as soon as navigation opens in the spring; but this year operations were commenced earlier than usual owing to the great demand on the company for lime. The 500 barrels of lime that were kept in stock to supply the trade during the winter and early spring were exhausted some time ago and it necessitated the resuming of operations earlier this spring than anticipated. A considerable supply of lime stone is on hand from last year and will be enough to last until more can be brought by boat from the East as soon as navigation is open in earnest. The building boom which will be very marked in all parts of copperdom during the coming summer is the cause for the big demand for lime. The plant will likely be worked to its full capacity this year.

## SETTLED BY THE BISHOP.

Rev. Bishop Frederick Els of Marquette recently settled two church troubles—one at Lake Linden and the other at Calumet—about which considerable ill-feeling and discussion had arisen.

At Lake Linden the plans made by the committee of St. Joseph's church for the building of a new edifice were not approved by some of the members of the congregation, and they appealed to the bishop a short time ago to have them altered. Upon investigation the bishop found the plans good ones and favored by most of the parish, whereupon he gave instructions that operations continue.

The trouble at Calumet was among the members of the congregation of Sacred Heart church at Hecla. It was alleged, and a complaint was made to the bishop, that part of the congregation wished to sever its connection with the parish and form one independent of Sacred Heart church. In case that was done, a new edifice was to be built by the latter. Bishop Els, however, easily restored all harmony and the new parish scheme was dropped.

## MANY MONTHS' WORK AHEAD.

### PHONE PEOPLE SOON TO RESUME OVERHAULING OF THE SYSTEM.

Operations in Houghton and other copperdom towns will soon be resumed, it was reliably stated yesterday, by the Michigan Bell Telephone company. The task of overhauling the system in the copper country was commenced last year but discontinued late in the fall. Much progress was made at that time, but there is still considerable work left to do. It is estimated that fully a year will be necessary to complete the work planned to be done at Calumet and several months for that in the other villages. Most of the wires now strung on poles in the business portions of the towns will be placed in underground conduits especially made for the purpose. A new submarine cable will replace the one now in use between Hancock and Houghton. It will be laid on the bottom of Portage lake and will stretch from the foot of Isle Royale street, Houghton, directly across to the Hancock side. The old cable is too small for present needs and the new one is a necessity. The greater part of the coming summer will likely be a busy one with the company.

## LOCAL BANK GETS THE BONDS.

The State Savings bank of Laurium was given the entire issue of the \$100,000 worth of bonds at a rate of interest of 5 per cent. by the village council of Laurium. The village may draw the money as needed and interest will be paid only on the amount taken from the bank. A sinking fund will soon be established by the council in order to pay off Laurium's indebtedness.

## DEAL ON BY THE TECUMSEH.

### SAID COMPANY IS AFTER MORE TERRITORY OR WILL BE ABSORBED BY THE OSCEOLA.

A report is current in Houghton that a deal is on by the Tecumseh Copper company whereby it will either purchase additional territory or be absorbed by the Osceola Consolidated Mining company. The rumor is given credence by certain mining men and future developments will be awaited with interest. The Tecumseh property lies next south of the Osceola, and No. 6 shaft of the latter, which is the best quarter of a mile north of the Tecumseh line. The Tecumseh company's landed estate consists of 550 acres in Sections 27, 32, 33 and 34, Town 56 North, Range 23 West. The property is very peculiarly shaped, having about a mile and a half on the outcrop of the Calumet and Osceola lodes and an east-and-west length of two and a half miles. Lying east of the Tecumseh are the Laurium, Metalline and Torch Lake tracts, with undeveloped mineral lands on the other sides.

## VICTORIA'S FUTURE BRIGHT.

The road to the Victoria is in first class shape this spring and there is great activity around the mine. The working force is being increased, a large quantity of copper is stored up ready for shipment and the amount increases every day, and there is a constant improvement in the condition of the mine and character of the vein with every lift sunk, until today there is no better showing of mineral in Ontonagon county than can be seen at the Victoria. Owing to the large water power on the property, this will become the cheapest producer and most successful mine in this district. On surface the new sawmill is in operation cutting timbers for the mine and lumber for new houses which are greatly needed.

## LIGHT ON THE CONSOLIDATION.

Kidder, Peabody & Co., of Boston sent out a circular yesterday morning asking for the deposit of Boston & Montana and Butte & Boston. The stock depositor under the circular will receive a certain number of shares of Amalgamated or else for Butte \$2.50 in cash, or else have his original shares returned to him. The deposit of shares will be received till April 25. The circular states that the firm has been requested to arrange for the consolidation of the Boston & Montana and Butte & Boston with the Amalgamated company upon some equitable basis, and that it will require before undertaking to arrange the terms the deposit of 125,000 shares of Butte and 100,000 shares of Montana, the deposit of that amount of stock thus being made the condition on which the firm will undertake the merger.

## STANDARD OIL PLANS.

The New York correspondent of the Chicago Tribune, under date of Monday, wired his paper as follows: "Standard Oil interests during the last year have employed an engineer corps which has been engaged in the investigation of every district in every state of the Union which was believed to contain copper deposits in any large amount. This activity, according to current Wall street report today, was associated with a plan for the complete unification of the copper interests

of the country, including the development of Southern copper properties, and the buoyancy of Amalgamated and Anaconda shares on the stock exchange and the strength of Union Copper stocks in the outside markets were referred to as suggestive of the impending plans of the Standard Oil interests in copper. Together with this report came the statement that the control of the Union Copper company, with its North Carolina properties, would be shortly announced as having passed to Standard Oil. The recent Standard Oil victory, registered in the settlements of the difficulties in the American Smelting & Refining company over the acquisition of the Guggenheim properties, led to the reports of a coming connection of the large Standard Oil copper interests. That these reports were based in any way upon the work of a special engineer corps was a new development in Wall street's knowledge of the situation.

## COPPER GOSSIP.

The annual meetings of the Franklin and the Elm River companies will be held at Boston today.

The copper visible supply on April 15 was yesterday reported at 27,277 tons, a decrease of 954 tons since April 1.

Men at the Winona speak well of the property. The working force of the mine will likely be considerably increased before long.

President H. F. Fay of the Elm River and other copper companies arrived in the copper country Monday from Boston. He spent yesterday at Houghton.

The annual meeting of the Arcadian Copper company was held at Boston yesterday. It was considered an important one owing to the fact that the financial affairs of the company were looked into.

Although a steady undertone was prevalent in copper at New York yesterday, the prices, as stated by the metal exchange, were more or less nominal owing to the absence of business, with the closing on the basis of 17 cents for Lake Superior.

The Quincy people deny the rumor that two additional heads are to be installed at their mills. The report was that plans were under way for two new heads to simply replace two of the eight heads now in commission which are old and about played out.

The water is coming out of the Michigan mine at a satisfactory rate and a few months more will see the old mine entirely drained. The snow is about gone and little surface water is running, while the water level in the mine has reached the largest openings and the pumps gain a few feet each day.

The copper situation does not change materially from week to week. In the domestic market there is a steady demand for the metal at a stable basis of quotations, with Lake at 17 cents and other brands in proportion. The foreign situation shows improvement and recent exports of the metal have gone at 17. The recently announced advance in Lake to 17 1/2 was apparently on special transactions. The bid price for the metal continues at 17 cents. Some producers are holding off for a higher price and there is an undecurrent of feeling in the trade that a rise in the near future is not improbable. Late advices have indicated that lake docks will be pretty bare of copper when navigation starts for the

year. With the exception of the Calumet & Hecla, which has not been such a proportionately heavy shipper during the winter as the remainder of the producing mines, the companies will have but little copper for the boats.—Statist.

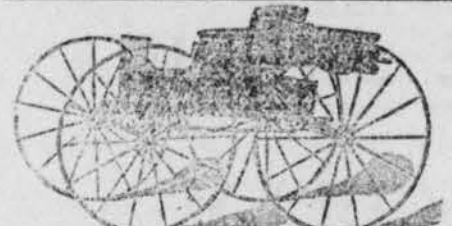

BIG MEETINGS.

Fathers Doherty and Conway Held Them at St. Peter's Yesterday.

The attendance at the mission at St. Peter's cathedral continued large yesterday, good congregations being out to all services, a particularly large assemblage gathering at 7:30 p. m.

Rev. F. B. Doherty spoke last evening on the devotion of Catholics to the sweet mother of God. He showed that Catholics never could pay her honor greater than God Himself had done, when He chose her for the mother of His only Son.

Rev. B. L. Conway preached the mission sermon on the text: "If any man have not care of his own, and especially of those of his house, he hath denied the faith, and is worse than an infidel." (1 Tim. v. 8.) After showing how the Christian family is modeled after the eternal family of one God in three divine persons, and how God gave the type of the Christian family in the Holy Family of Nazareth, the speaker explained the Catholic doctrine of marriage. It is not a mere contract to be broken at will, as is so frequently taught outside of the Catholic church, but the indissoluble union of one man and woman until death, a sacramental contract, signed with the blood of Jesus Christ, and sealed with the seal of the Holy Spirit. ### EXTENSION CONTEMPLATED.

STREET RAILWAY COMPANY APPOINTS A COMMITTEE TO INVESTIGATE THE MATTER.

There is every chance that cars will be running to the Winthrop before the summer is over. At the annual meeting of the Negaunee and Ishpeeming Street Railway and Electric company held in the Sundberg block, Negaunee Monday afternoon, a committee was appointed to look into the matter, and this committee has full power to act. The meeting was very fully attended, a large majority of the stock being represented, and proposed extension was very much favored. This matter has come to the attention of the stockholders several times so that they were thoroughly familiar with it and when it finally came up for action it took them but a short time to decide upon the course which they will follow.

The committee will get to work at once and the several routes proposed will be looked over and surveyed as soon as possible. There is a question as to whether it will be advisable to go around or over Badger hill; this is the only stumbling block which the street railway people have to contend with. The distance from the present terminus of the railway to the Winthrop is about 1.5 miles and to construct the road would mean an expenditure of about \$15,000. There is a great demand for this extension and few have any doubts but that it would pay for itself in a short time. The company is in a splendid condition financially, and can afford to expend that amount, or even more if need be, to properly install and equip the line. The Winthrop has not seen its best days by any means and traffic to and from the location would be very heavy.

The company decided to put a spur into the golf grounds and Cleveland park and work on this track will be started in a few days. The route was surveyed this week and practically nothing now remains to be done but to haul the ties and rails and commence the work of laying track and erecting poles for the wires. Cleveland park showed great possibilities as a popular resort last year, and with a line into the grove it will prove more and more popular in the years to come.

The old board of officers were elected for the ensuing year and the report of the treasurer showed that the condition of his department is exceedingly healthy. The following is the list of directors: Captain Samuel Mitchell, John Q. Adams and Joseph H. Winter of Negaunee, Frederick Braadstad, H. O. Young and A. B. Miner of this city. The officers of the company are: Captain Mitchell, president; Frederick Braadstad, vice president; and A. B. Miner, treasurer and secretary.

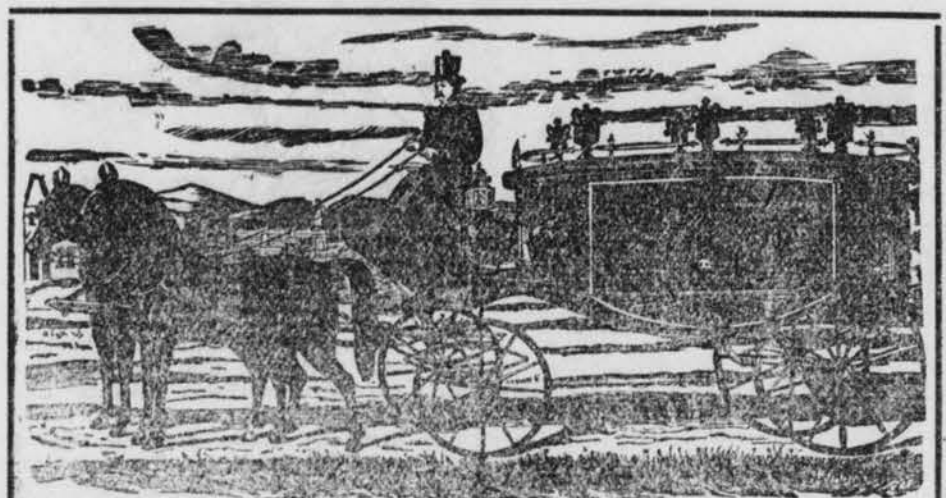

### WORK AT THE CHESTER.

JOSEPH SELLWOOD WILL SHIP CONSIDERABLE ORE FROM THE PROPERTY THIS SEASON.

Joseph Sellwood intends to thoroughly investigate the possibilities of his mine, the Chester, this season and to ship a gang of men at work stripping. The Chester is the old Rolling Mill property, one of the oldest mines on the range, it having been opened in 1871. Mr. Sellwood purchased it last year, buying from Captain Samuel Mitchell. Last season he mined and shipped a few thousand tons of low grade ore. He evidently intends to conduct operations on a more elaborate scale the coming summer as he has started in with a much larger gang of men than he worked last season.

Mr. Sellwood is also sinking a shaft at another old property, the mention of which was made in The Mining Journal some days ago. Work at these mines means employment for a considerable number of men and there is a chance of valuable finds. The ore is low grade, but it is also low in phosphorus and there is something akin to a demand for it.

The analysis of the Chester ores shipped last season reads as follows: "Chester, non-Bessemer, iron, 48.215; phosphorus, .789; Chester, Silicious, iron, 38.72; phosphorus, .928." The low showing made in "phos" in the silicious surprised most men who are familiar with these properties and has led them to think that they may show up very well. It is hoped that Mr. Sellwood will sink deeper as many are confident that a valuable ore body lies but little beneath the surface.

Captain Samuel Mitchell purchased the Rolling Mill mine in 1897 and shipped about three thousand tons of ore but he has done no work there since. The mine has a record of over 260,000 tons since its opening, but the great bulk of this shipment was prior to 1884. Last year 22,586 tons were shipped and there is every prospect that this total will be passed the coming season.

MUST PAY UP NOW.

OWNERS OF DOGS WILL NO LONGER BE ABLE TO DODGE THE TAX ON THEM.

On Tuesday last Supervisor Sandstrom received a letter from County Clerk W. A. Ross advising him that the new dog tax law would soon be in force. Full information as to how the owners of canines are to be taxed has not yet been received from Lansing, though it is supposed that when the supervisors make up their assessment rolls dogs will be included in the list of assessable property.

With this means of reaching the owners of dogs there will be more money collected on the dog tax account than under the old method of licensing them. The collection of the dog tax has been a complete failure in most places where the authorities have attempted to enforce the law. Very few would come forward and pay the tax. Many would prefer to have their dogs taken away rather than pay.

Under the new law the supervisors will ascertain just who are owners of dogs when they make the rounds in compiling information for their rolls. If the owners wish to avoid paying the tax they will have to get rid of their dogs there and then.

The collection of taxes upon dogs in the manner set forth in the new law will be the means of bringing quite a sum to the state in the course of a year. All supervisors of townships and assessors of cities will be obliged to make a careful canvass when they are gathering information for use in making up their rolls. In this way all the property owners can be reached, but it will be a difficult matter to assess persons who do not own property for their dogs.

WHY NOT LAKESIDE PARK?

Aldermen Would Like to Purchase Ward Estate Property for Pleasure Grounds.

TRACT EXTENDS SOUTH FROM SUPERIOR TO FISHER STREET.

It is Now a Bare, Unattractive Expanse of Bald Rock and Illly Kept Sward, But it Could Be Beautified at a Reasonable Expense.

IS NOW FOR SALE AT A SACRIFICE FIGURE.

Lakeside park; it is now but a name, but it may become a reality. In any event Marquette people are apparently destined to become thoroughly familiarized with the idea of the new pleasure grounds during the next few months. Lakeside Park is at present an unattractive expanse of bare, bald rock and illly kept sward, with a couple of tumble down dwellings thrown in extending from the South Shore tracks on the south side of Superior street south to Fisher street. It is owned by the Ward estate and is on the market at a reasonable figure. A number of the aldermen of the new council have already expressed themselves in favor of purchasing it for park purposes and Mayor Mangum has also lent his approving voice to the scheme.

All this transpired at the luncheon in the Hotel Marquette Monday evening, when John H. Lewis entertained the aldermen and other members of the new administration. The idea of the park was a novelty for most of the members of the council, but it seemed to take favorably and those who spoke in behalf of the proposed addition to Marquette's park facilities were attentively heard.

The new proposition was sprung from the Second ward, in which the proposed Lakeside pleasure grounds are located. Speakers representing this precinct said that their ward was asking nothing extensive this year and that its sole desire was to see the city obtain title to the land, hereinbefore described, owned by the Ward estate. Both the aldermen from the Second, Messrs. Donovan and Reau, expressed themselves as favorable to the purchase and they advanced many good reasons why the city should acquire and beautify the tract, which is now an unqualified eye sore.

Other members of the council approved the sentiments advanced by the representatives of the Second and it was apparent that there are a goodly number of votes on the aldermanic body ready to assent to a reasonable measure looking to the establishment of the new park. The aldermen to whom the introduction of the subject came as a surprise were content to listen to the arguments advanced by their colleagues who favored the purchase, not having had sufficient time to formulate definite opinions relative to the advisability of the new movement.

COUNCIL WILL DECIDE.

It now seems very probable that the Lakeside park question will be brought

up for discussion at some of the early sessions of the council. The aldermen from the Second are intensely in earnest in their advocacy of the purchase. They say that the proposed park would furnish an easily accessible breathing place for which there is an urgent need. Presque Isle and other popular resorts being too far removed from the city to be reached by people who have but limited time to spare and being equally inaccessible for many invalid summer visitors and elderly Marquette people who cannot stand long street car rides.

They point out that the land required for the projected pleasure grounds can be acquired at a reasonable figure; that it will be a good investment for the city and that, at any time the municipality desires to get its money back, the sale of the lots comprised in the tract will bring the original purchase price.

They further say that the cost of putting the land in condition for park purposes is reasonable. The idea of the park is required being the cultivation of a good green sward, planting a number of flower gardens and setting out a liberal number of trees. After the park was thrown open to the public it would no longer be a source of expense to the city as the busy men, who will be benefited by its establishment, have expressed their willingness to assume its care, guaranteeing that they will keep its fountains, lawn and gardens in first class condition.

As there is now a considerable sentiment in favor of the park in the council it need not be surprising if the aldermen act favorably on a project looking to the purchase of the Ward estate tract. Of course there will be extensive discussion of the matter before any final action is taken and if the Lakeside park finally does become a reality it will be because a majority of the aldermen think that it will be a truly valuable public improvement.

COUNT ON HELP.

Those aldermen who favor the park do not anticipate that it will be necessary to vote all the money for the purchase of the Ward tract from the city treasury. They anticipate that there will be no difficulty in obtaining donations from Marquette's public spirited citizens to make up at least half the purchase price. It is said that one or two gentlemen have already manifested their willingness to dip into their pockets to help the good work along. The South Shore people would be interested in the establishment of the new park and it is asserted that they also can be counted on for some aid. Of course it is not known at this date what the prospective donations would total, but the advocates of the purchase think that they will aggregate such a goodly sum that the council will not hesitate to appropriate the balance needed to complete the purchase price.

It is likely that some people will not favor the new park proposition. It will have its friends and its enemies. Those who would be most directly benefited will be enthusiastic in their support of the idea and those who are far removed from the Second ward will be, in many cases, either apathetic or hostile. However, the council can be relied upon to take a broad minded stand on the question and its ultimate

decision will likely be the best for the general welfare of the city.

MADE GOOD GAINS.

A Number of Coppers Forged Ahead Yesterday.

Yesterday was another big day on the Boston exchange and the market abounded in notable features. Trimountain's big jump fairly took people's breath away. The prevailing feeling is bullish in the extreme and the talent seems to think that a general boom is impending. Paine, Webber & Co. said:

"The Amalgamated-Montana-Butte announcement simply amounts to an official declaration that negotiations are on for the absorption of the two latter companies by the former. It does not settle anything. It leaves the public to anticipate and, therefore, is a tremendous encouragement to speculation. Two or three weeks will elapse before it is officially known what will be done with Butte and Montana and by the end of that period other consolidations and absorptions may be under consideration. Taken as a whole the prospect is that the coppers will break all previous records. The chief actor of the buying in Trimountain this morning indicates what is coming in the Lake stocks. We believe that the South Range group will all sell much higher."
