Said he: "The life which you condemn me for not living was a lie. Yet I tried to convert it into truth in order to be moral and self-denying according to the standard of religion and private ownership." In speaking of Miss Rand, Dr. Herron avowed affection for her and spoke with indignation concerning the contumely that has been heaped upon her.

J. P. Lyman of Grinnell presented the case against Professor Herron on behalf of the church committee. He read the letter sent to the churches calling for a council and the invitation to Dr. Herron to participate and defend. Professor Herron declined, saying, "I am perfectly satisfied that the hearing shall be ex-parte." Mr. Lyman said he did not present the charges against Dr. Herron on his own motion, but the church thought it was its duty to investigate the divorce proceedings and the defendant's treatment of his wife and children in the light of a Christian ministry.

First Wife Eulogized.

Rev. E. M. Vittum of Grinnell was the first witness. He said he had met Dr. Herron's wife at Grinnell in April. 1893, when he exchanged pulpits with Dr. Herron. He was entertained at L.e Rands, and they talked all the time of Herron. Mrs. Herron was loyal at all times, was devoted to her husband and believed in his teachings. On his last departure to Europe, she told a friend "I feel as though I want to die."

Professor Charles Noble, the second witness, confirmed Rev. Mr. Vittum in an asylum. Mrs. Herron was usually loyal. Dr. No hle said he was strongly in favor of Dr. Herron at the beginning, but had changed since. Dr. Herron's book in 1892 was dedicated to his wife in these words, "To my wife, who has been my Chicago most loving counsel."


