Considerable tinkering with the game laws by the last legislature has doubtless left many hunters in the air to know just where they are at in the matter of legal shooting seasons. Questionable points are straightened out by State Game Warden Grant M. Morse, who, in reply to an inquiry, says:

NEW

are protected by the laws of this state, the open season being under the new law from October 1 to November 30, they being classed under wild water-fowl, the same as ducks, plover, snipe, etc. Re garding the open season on quail and partridge, permit me to say that section 10 of the new law, covering these birds, is, in the opinion of the attorney general, unconstitutional, and the old law is revived, making the open season the same as last year, viz: from October 20 to November 30, both inclusive."

Deer-Open season November 8 to 30, land of Bois Blanc and the counties of Lapeer, Huron, Monroe, Sanilac, Tus cola., Macomb, Allegan, Ottawa and St. Clair, where deer cannot be hunted until three deer in any one year. Use of and the killing of any fawn in the spotted coat or any deer in the red coat is prohibited. The use of any artificial light in hunting, pursuing or killing deer is unlawful. No deer or portion of a deer can be lawfully shipped without a license tag accompanying the




