PRESIDENT IS CHEERFUL AND STEADILY GAINS.

Physicians' Reports So Elate the Cabinet Members They Are Returning Home.

ALL THE NEWS FROM THE BEDSIDE IS REASSURING.

Patient Takes Nourishment and Relishes It, a Microscopic Examination Shows No Sign of Blood Poisoning, the Wound in the Stomach Has Healed and the Danger of Inflammation Where the Bullet Lodged Has Disappeared.

Buffalo, Sept. 11.—The night consultation of physicians furnished, in some respects, the most reassuring news which has yet come from the sick room. A microscopic count of the patient's blood had been made during the day by Dr. Washburn. At the evening conference the result was submitted and was found to be perfectly satisfactory. There had been no abnormal increase of the white corpuscles, such as would have existed had blood poisoning set in, and the doctors had the satisfaction of announcing officially that the count of the blood corroborated the clinical evidence of the absence of any blood poisoning. The president was bathed and given nourishment while all the doctors were present, and afterwards he was placed in a new bed. The members of the cabinet were all below stairs while the consultation was in progress and remained until after the bulletin was prepared and issued. They were so elated over the improvement in the president's condition and the absence of any unfavorable symptoms that Secretary Root announced he felt free to depart and that he had decided to go to New York tomorrow.

DOCTORS' FAITH STRENGTHENED.

President Has Favorable Day and Scores Distinct Improvement.

Buffalo, Sept. 11.—The condition of the president continued favorable throughout the day. Nothing occurred to shake the expressed faith of the attending surgeons and physicians that he will recover.

Two Points of Danger Rounded.

The danger from two sources was pronounced practically over today. The holes in the stomach proper, caused by the perforation of the bullet, are now considered healed, by Dr. McBurney and his associates; and the eminent surgeons point to the fact that the beef juice fed to the patient last night was readily digested, as proof of this.

Sufficient time has also elapsed to warrant the doctors asserting that danger of inflammation where the bullet lodged has disappeared. It is believed the ball will now become encysted in the muscles of the back, and unless its location should prove troublesome later on there will never be any necessity of removing it. Dr. Mann today said he knew a man who had lived for years with a bullet in the muscles of his heart.

The attention of the physicians now, therefore, is mainly directed to the care and treatment of the wound caused by the incision made in the abdomen above the naval, where the operation was performed. This wound is progressing satisfactorily.

Latest "Operation" Beneficial.

"Decided benefit followed the dressing of the wound last night," is the way the doctors put it officially. The slight sear which followed the announcement, at midnight last night, of the opening of the wound, did not have a leg to stand on today, when fuller details of its insignificant character and importance were obtained. The "incident," as it is termed, would not have been mentioned in the history of an ordinary hospital case, and the physicians last night debated for some time upon the propriety of making it public.

Another milestone passed on the road to recovery was the discontinuance today by the doctors of the figures showing the respiration variations in the official bulletins. The president now breathes deeply and normally and the addition of the respiration record to the bulletins is considered valueless. The president's pulse was slightly accelerated in the afternoon, but it was not deemed material, while his temperature remained practically stationary—at 100.2—from daylight until dark.

Nourishment Relished.

Evidences of improvement were the president's keen relish of the beef juice given him during the night and the increase in the allowance from one to three teaspoonsful, also the fact that the wound is becoming "more healthy." Dr. McBurney explained this afternoon that the slight irritation found still remaining should pass away within the next twenty-four hours. All appears quiet within. A decided change has occurred in the weather. The light

SCHLEY COURT OPENS TODAY.

Many Witnesses in Washington Prepared to Take the Stand.

Washington, Sept. 11.—All the members of the Schley court of inquiry are now in Washington, Rear Admiral Howison, the third member, arriving last night. Everything is ready for the meeting of the court.

The impression at the navy department now is that the taking of testimony will not begin tomorrow, although that was the original expectation. A large number of witnesses are in Washington ready to take the stand at a moment's notice, but the formalities are expected to consume most of tomorrow's session.

No summons has yet been issued for Admiral Sampson, and it is said very few formal summons have been issued by the department.

COL. MEADE IN HOT WATER.

Naval Inquiry Board Recommends His Trial by Court-Martial.

Washington, Sept. 11.—The longest court of inquiry in the history of the navy—that held at the Brooklyn navy yard to investigate the trouble in the Marine corps—has come to a sensational termination with a recommendation which may result in very serious consequences for an officer of high rank.

Major C. H. Lauchheimer and Colonel F. L. Denny charged Colonel Robert L. Meade with drunkenness on duty while an inspection was in progress at the Brooklyn navy yard. Colonel Meade replied by charging Major Lauchheimer with making a false report and Colonel Denny with reporting against him (Meade) in order to cover up irregularities with contractors on Denny's part.

The court acquitted Lauchheimer and Denny of Meade's charges. It sustained the charge against Colonel Meade, with the exception of a recommendation which may result in very serious consequences for an officer of high rank. The court recommended that the colonel be tried by court-martial upon these charges. The court sat for four weeks.

CZAR AND KAISER MEET.

Autocrat of Russia Arrives in Prussia and is Royally Greeted.

Hela, Prussia, Sept. 11.—The meeting today between Emperor Nicholas and Emperor William was favored with perfect weather.

The German imperial yacht Hohenzollern, flying the German and Russian imperial standards at the top of the main mast, welcomed the imperial Russian yacht Standart with the imperial salute, which the Standart returned, both crews dressing ship while the bands played Russian and German national anthems.

Count Plateau, the kaiser's aide, went on board the Standart to escort the czar who went on board the Hohenzollern. The kaiser received the imperial visitor at the gangway, where the two monarchs embraced each other. They then inspected the guard of honor together, after which they retired to the quarters deck, where they remained in animated conversation until luncheon, when the czar sat on the right of the kaiser and Grand Duke Alexis on the left.

The luncheon party included Count Lamsdorff, the Russian foreign minister; Count Von Buelow, the German imperial chancellor; Count Von Eulenberg, Baron Fredericks, Count Von Schlieffen, Admiral Von Hoffman and Admiral Von Tirpitz.

Just as the meal ended, Hela was sighted. The German squadron was drawn up in double line, the vessels being decorated with bunting and the crews manning the sides. The Hohenzollern, with the imperial majesties on the imperial bridge, steamed slowly between the lines, followed by the Standart and her escort. The two yachts anchored at the heads of their respective lines, after which the admirals and the principal officers of the squadron went on board the Hohenzollern, where they were presented to the czar.

VALUABLE PROPERTY LICKED UP.

Flames Cause Heavy Loss at Syracuse, St. Johns and Brooklyn.

Syracuse, N. Y., Sept. 11.—The Syracuse Silk company's mill and the works of the Will Baumer Candle company were burned today. The loss will reach \$180,000.

St. Johns, N. F., Sept. 11.—Fire here today destroyed several stores containing fish and seal oil. Two men were killed and several injured. The loss is half a million. The fire started from the explosion of a boiler.

Brooklyn, Sept. 11.—Fire late tonight in a Reed Hook storage building, owned by the New York Storage company, has already done damage to the extent of \$100,000. The building was filled with cotton. Spontaneous combustion was the cause.

PERRY S. HEATH'S BANK.

Grand Jury Probing Its Failure Decides on Three Indictments.

New York, Sept. 11.—According to information obtained late tonight, the grand jury, which has been investigating the affairs of the Seventh National bank, has handed down three indictments. According to the same information no arraignment of the persons named in the indictments will be made for several days.

BURN ARMENIAN VILLAGE.

Turks Guilty of Fresh Wickedness—Kill Many Peasants.

London, Thursday, Sept. 12.—The correspondent of The Times at Constantinople says: "A dispatch from Erzeroum reports that a gendarme, who was summoned of an Armenian girl in a neighboring village, mustered his friends, outraged the girl, murdered many persons and finally sacked and burned the village."

HELD WITHOUT BAIL

EMMA GOLDMAN TO REMAIN IN JAIL AT CHICAGO.

ATTORNEYS MAKE STRONG APPEAL.

ARE UNABLE, HOWEVER, TO MOVE JUSTICE PRINDIVILLE.

Decision of Superior Court in Cases of Other Anarchists Is Awaited, As All Are Charged With Same Offense—Conspiracy to Kill McKinley.

Chicago, Sept. 11.—Magistrate Prindiville today decided that Emma Goldman, the anarchist and lecturer under arrest here, should be held without bail, pending the decision in the upper court of the cases of Abraham Isaak and the other eight anarchists in custody.

The action of Justice Prindiville in holding her without bail extends only to Friday of this week. At that time the question will be reconsidered and the magistrate will decide whether she is to be held without bail or released under bonds until the preliminary hearing of the charge against her, which is for the 19th.

Result of Investigation Awaited.

Miss Goldman appeared for hearing before the magistrate this morning. She had not secured counsel, but in a determined voice declared she was ready to act as her own attorney. The assistant city prosecutor, however, obtained a continuance of the hearing until the 18th, which is the date set for the hearing of the other anarchists in custody here. Prosecutor Owens stated that the result of the investigation at Buffalo is being awaited.

The court postponed the decision in the matter of bail, which Miss Goldman demanded the privilege of furnishing until later in the day. While waiting, Judge Chetlain, in the superior court, held the other anarchists until Friday when, he said, he would hear the arguments in application for writs of habeas corpus.

As the charge against Miss Goldman—conspiracy to murder President McKinley—is the one lodged against the local anarchists, who are named as co-conspirators with Miss Goldman, Justice Prindiville thought it wise to await the decision of the higher court. He said it would not be necessary for counsel to apply for a writ for Miss Goldman, as he would do exactly with her as Judge Chetlain did with the other prisoners.

Attorney Demands Release.

Miss Goldman is represented by Lawyers Brown, Geeting and Saltiel. They were busy in the habeas corpus case during the forenoon but interviewed their client in time to appear for her in the hearing on the matter of bail. Lawyer Geeting, in pleading for prisoner, said:

"This matter must be disposed of according to well known rules of law. When a party is brought into court, charged with any criminal offense, that party has the right to an immediate hearing. The constitution of Illinois declares that all persons be bailable by sufficient sureties, except for a capital offense where the proof is evident and the presumption is great.

"In this case, the affidavit filed here does not conform with the law, because the law requires an oral examination, the affidavit to be based on that oral examination. It should be upon personal knowledge as to the facts. That is a provision in the constitution which we are all sworn to support, and ignoring which is a denial of the right of the government to guarantee the rights of its citizens."

Court Stands Pat.

In deciding the case the court said: "While this morning I was inclined to believe the defendant might be entitled to bail, considering the condition the president is now in, yet at that time, of course, I did not know that there was any proceeding pending or that it was going to be taken to a higher court. The present defendant is charged jointly with other in a conspiracy. Of course, as it is being taken to a higher and superior court, I do not feel as if I should now take any action which might be contrary to the decision to be arrived at by the upper court, or that would in any way influence the court in the matter there pending. That being the case, I will remand the defendant, and if Judge Chetlain, at 11 o'clock Friday morning, admits the other prisoners to bail, I will immediately send for Miss Goldman and will admit her to bail the same as the upper court."

Geeting—"The law would require you now to make a mittimus and the statute says you must endorse on the mittimus the amount of bail."

Court—"All right. I will remand her without bail."

Geeting—"That you cannot do under the state of facts, because the statute says you must endorse the amount of bail on the back of the commitment."

Court—"Well, I will remand her without bail until Friday at 11 o'clock or shortly after, whatever time Judge Chetlain decides."

When the "anarchist queen" appeared a Justice Prindiville's court she looked pale but determined after having spent a sleepless night, due to a severe headache, at the Harrison street police station. There were none of Emma's associates.

The present grounds of the Ontonagon County Agricultural association will be sold and a new tract of land purchased to be used as fair grounds.

A Polander named Novokaski, a married man of Iron River, was drowned in Trout Lake near that place Monday. Novokaski, with two companions, was in a boat, and the unfortunate man shot at a loon. The gun kicked, throwing him out of the boat, which capsized.

An Illinois farmer was in Menominee Monday in search of his daughter, whom he thinks eloped with a young man the latter part of July. He found no trace at Menominee and went to Marinette, where he secured a confidant in Judge Holgate. It is learned the eloped had relatives in Marinette, who assisted them in their concealment.

Contractor Phee said this week at Menominee that the work of rebuilding the Wisconsin & Michigan road from Fisher to Nathan would not be completed this year. It has been a slow job and delays have been frequent on account of the scarcity of men. The road bed was to be changed, all of the curves taken out and a new grade established.

A tragedy resulting from illegal hunting of deer occurred near Commonwealth Monday night. John Seifert and a companion named Gustafson were headlighting for deer near Lake Emily. They had separated, and a short while later Seifert heard something coming towards him, and he blazed away. A yell answered his shot, and, hastening forward, he found his companion rolling on the ground. He was taken to Commonwealth, where it was found he had been shot in the abdomen. Gustafson, it was said, cannot live. Seifert is a bartender for Oliver Lenore at Commonwealth.

The old worn out Brule River bridge completely collapsed last week and is said to be beyond repair. Fred Deer, manager of the Brule farm, was driving over the bridge with a light load when, almost without warning, one end of the structure fell with a crash. Fortunately Mr. Deer and the two men with him escaped injury and the team of horses were not very badly hurt. The river was very low at the time, but, if there had been a flood on, the chances are that both men and horses would have been swept down the stream and perhaps drowned. Repairs had recently been made upon the bridge by building new trusses.

There is a likelihood that a tanning company will be organized at Menominee with local capitalists holding the controlling interest, says the Leader. Two eastern capitalists, S. G. Maxwell of Titusville, Pa., and H. L. Flanders of Chicago, are in the city to enter into negotiations and, if possible, perfect preliminary plans for the organization of such a company. The plan is to incorporate a company with a capital stock of \$100,000. The outside gentlemen are trying to interest local capital in the project, and after a long conference with S. M. Stephenson announced they had been given some encouragement. The L. & V. S. Co.'s new mill site has been inspected, together with several other sites.

The skeleton of an Indian, which had lain in its narrow grave for perhaps a century, was unearthed last week by H. W. Van Dyke, on his property at Escanaba, says the Post. Along with the bones of the aborigine were found his stone pipe, metal tobacco box, a looking glass, and about a dozen ornaments of silver, brass and copper, together with a glass vial and several implements of iron, whose nature is not known. The skeleton is in excellent state of preservation and measures about 6 feet and 2 inches in length, going to show that the man, when alive, was a magnificent type of the warriors who once inhabited this land. From the number and value of the ornaments found in the grave it is evident that its occupant was a chief or man of mark among his people.

P. F. Finnegan of Green Bay has closed a contract with Perley Love and the Peshtigo Lumber company to cut over and deliver the products from 1,400 acres of cedar land near Middle Inlet, four miles north of Crivitz, and six miles south of Wausaukee, on the St. Paul road. This is one of the most important contracts of the kind that has ever been closed in Northern Wisconsin or Michigan. The timber is owned by the Peshtigo Lumber company. Camps are now being built about three and one-half miles from Middle Inlet station, and 100 men will be employed during the winter. Mr. Finnegan is now in Menominee engaging men for the work, and it is expected that at least 20,000 telegraph and telephone poles, 50,000 fence posts and 20,000 railroad ties will be cut and hauled to the Perley Love company's yards at Middle Inlet during the season. The tract to be cut over is one of the most valuable in cedar products in the northwest. This is one of the first logging contracts closed this season.
