TAMMANY DOWNED

SETH LOW ELECTED MAYOR OF GREATER NEW YORK.

PLURALITY MAY REACH 40,000

SHEPARD PUBLICLY ACKNOWLEDGES HIS DEFEAT.

Reports Show Republicans Retain Control of Lower House of Legislature—Complete Triumph for Fusion Ticket.

New York, Nov. 5.—Seth Low, former president of Columbia university, and four years ago the Citizens Union candidate for the first mayor of Greater New York, was elected today second mayor of Greater New York by a plurality ranging from 30,000 to 40,000, defeating Edward M. Shepard of Brooklyn, the Democrat nominee. The campaign was an exciting one, and the vote, though somewhat less than that of the presidential election a year ago, was the largest ever polled in a municipal contest in this country.

In addition to the canvass for mayor public interest was largely centered in the nomination by the fusionists of William Travers Jerome for district attorney and Mayor Robert A. Van Wyck by the Democrats, for justice of the supreme court, who were voted for only in territory contained in New York county. The returns to 11 p. m. indicate Jerome has been elected by a comfortable plurality, and Mayor Van Wyck is behind his opponent by behind his ticket from 15,000 to 20,000.

The returns also indicate a complete triumph here of the Greater New York fusion ticket.

The reports from various sections of the state show that the Republicans retained control of the lower house of the legislature.

Edward M. Shepard publicly acknowledged his defeat tonight and sent a telegram of congratulation to Low, and dictated a statement to the reporters in which he expressed the hope that the incoming administration would be a successful one.

Was a Hot Campaign.

New York, Nov. 5.—After several weeks of the hottest campaign fighting ever witnessed in this city over a municipal election the day passed without unexpected quiet, considering the high feeling previously assumed. The great feature of the voting was the early casting of ballots. This was applied to the brown stone well as to the tenement house district.

The practical use of the voting machine was demonstrated in the eighteenth ward of the first assembly district, Brooklyn, and the result was known at 9:02 in the afternoon, immediately after the polls closed. No difficulty was experienced in recording the vote and in many instances the men cast votes in less than three seconds.

An incident which attracted attention in New York City was the refusal of the election judges of one district to allow a voter to cast his ballot, because he had made a bet of a box of cigars on the result of the election without comment.

Croker in his private room at Tammany Hall received the news. He is reported to have said that the Democrats had elected the candidates of the county ticket. At the time he claimed the county ticket. Croker said he did not care to say anything as to the race for the mayoralty.

At 8:45 tonight Croker conceded the election of Seth Low, fusion candidate for mayor, but was not willing at that time to give up the county ticket. He said he was much disappointed at the Brooklyn vote, as he expected Shepard to make a good showing there, it being his home borough.

As to the cause of defeat Croker was inclined to ascribe it to a large silent vote, and the fact that people sometimes feel they want a change.

Crowds such as are seen on the night of presidential elections surrounded the bulletin boards of the newspaper offices.

One man believed to be E. J. Mullaney of Clinton, N. J., while watching the bulletins near the Staats Zeitung building, was jostled off the sidewalk by the crowd, and falling on the stone roadway fractured his skull, dying soon after.

The bulletin announcing Low's election was a signal of impromptu triumphal parades in which the young men with the blaring tin horns was much in evidence.

Low Appreciates Support.

New York, Nov. 5.—Seth Low, at 9 o'clock tonight, said:

"I suppose it is safe to assume the result of the election is now assured. It bears out what my friends anticipated and I am very much gratified by the result. It is a pleasant outcome of a hard struggle. I appreciate heartily the splendid support the newspapers have given, the movement I think they have been splendid and an important factor in bringing about the result."

MURDERS A WOMAN.

CAPTIVES SAFE AND WELL.

Miss Stone and Madam Tsilka Have Been Seen Recently.

New York, Nov. 5.—The World's Salonkov, Bulgaria, dispatch says: Miss Stone and Mrs. Tsilka have been seen within the last two days by commissaries sent by the American diplomatic agent, Dickinson, from Sofia to treat with the brigands. Both captives are safe and well. It is expected their release will be arranged soon.

London, Nov. 5.—"It is stated here," says the Sofia correspondent of the Telegraph, that the "brigands will not abate the ransom originally demanded for Miss Stone's release. In Macedonia circles it is maintained that Miss Stone will be murdered on that territory in order to remove all traces of the original Macedonian instigators of her capture."

Sofia, Bulgaria, Nov. 5.—United States Consul General Dickinson has returned here from Salonkov. He authorizes the statement that he is satisfied that both Miss Stone and Madame Tsilka are alive and well treated.

FROZEN BODY FOUND.

Remains of Iowa Man Discovered in a Corn Field.

Sioux City, Ia., Nov. 5.—J. L. Schroeder, living near Pocahontas, Ia., disappeared Saturday. His frozen body was found today in a corn field only a few hundred yards from home.

NATIVE'S WIFE TELLS OF SCHEME

ARRESTS FOLLOW AND INCRIMINATING PAPERS ARE FOUND.

Lieutenant Caujot Encounters Body of Insurgents Near Catbalogan and Twenty Four Rebels Are Killed.

HANNA FINISHES SPEECH.

Entire Time of Schley Court Devoted to Arguments.

Washington, Nov. 5.—The time of the Schley court of inquiry was entirely devoted today to hearing arguments. Mr. Hanna finished his argument in behalf of the department, which had been begun yesterday, and Captain James Parker began but did not finish his presentation of the case for Admiral Schley.

Mr. Hanna today considered the retrograde movement, the bombardment of the Colon, and the charge made against Admiral Schley of disobedience of order. Captain Parker had only reached the reading question when court adjourned. He defended the conduct of his client at all stages of the campaign so far as he went.

It is expected Captain Parker will conclude his speech tomorrow when Mr. Rayner will begin.

SIGNS SECRET TREATY.

ACTIVITY AT TOULON.

Ships Are Taking on Ammunition and Supplies.

Paris, Nov. 5.—Telegrams from Toulon report the utmost activity in the preparations at that place of the squadron in getting in readiness for any eventuality. The ships are taking ammunition and supplies, including live stock and everything necessary to re-visit Admiral Caillaud's squadron. The battleship Charles Martell, the cruiser Gallie and three large transports are ready to sail. It is asserted that one of Admiral Caillaud's ships has a submarine on board.

The Echo de Paris asserts M. DeCase has received a dispatch from M. Bapst, councillor of the French embassy at Constantinople, saying that Admiral Caillaud informs him he has seized the customs of the Island of Mitylene.

Paris, Nov. 5.—An official dispatch announces the arrival of Admiral Caillaud's squadron this morning at the Island of Mitylene, where the admiral will seize the customs at Midilli and another port. Caillaud occupied three principal ports of the island of Mitylene.

BIG DIAMOND ROBBERY.

DEMOCRATS WILL CONTROL MARYLAND LEGISLATURE.

PARTY WILL CARRY STATE BY OVER 50,000.

Will Also Have Decisive Majority in Each Branch of the Legislature—Massachusetts Goes Republican.

OHIO GOES STRONGLY REPUBLICAN

INSURES FORAKER'S RE-ELECTION.

Baltimore, Wednesday, Nov. 6.—A conservative estimate at 3 a. m. indicates that the Democrats will control the legislature and will have probably sixty-seven on joint ballot, six more than a majority.

At 1 o'clock less than half the returns from the city were in. One hundred voting precincts give Hering, Democrat, comptroller, 11,090; Platt, Republican, 12,188. The first legislative district in Baltimore city, with sixty-nine precincts missing, gives the leading Republican candidate 3,822, while the leading Democratic candidate has 3,804. Others range from 3,604 to 3,790, and the delegation is about evenly divided. The second district is probably Democratic while the third is almost surely Republican.

Figures from the counties come in slowly. Montgomery is probably Democratic, and it is claimed the Democrats elected the senatorial candidate in Allegheny.

BIG PRIZE MONEY

CASES INSTITUTED BY ADMIRAL DEWEY DECIDED.

RESULT OF BATTLE OF MANILLA

PROPERTY INCLUDES MANY SPANISH VESSELS CAPTURED.

Vessels Entitled to Share Are Olympia, Baltimore, Boston, Raleigh, Concord, Petrel and McCullough.

Washington, Nov. 5.—Justice Bradley, sitting in the United States circuit court today signed a decree of condemnation and distribution in connection with the prize cases instituted by Admiral Dewey in behalf of himself and officers and crew and the naval force taking part in the battle of Manila. The decree sets for the following indicated property as a lawful prize of war, viz:

The protected cruisers Isla de Cuba and Isla de Luzon; the unprotected cruiser Don Juan de Austria; the transport Manila and all other vessels and equipment belonging to the King of Spain and his subjects, captured by the naval forces of the United States on the first of May, 1898, except such as may have been restored to private owners.

The Spanish property captured on the shore at the Cavite arsenal or elsewhere, and all non-sea-going boats pertaining to the arsenal are not subject to prize.

The vessels entitled to share in the prize property are the Olympia, Baltimore, Boston and Raleigh, the gunboats Concord and Petrel, and the revenue cutter McCullough. The Nanshan and Zafiro are held not to be entitled to a share. Upon ascertaining the value of the property condemned as prizes the secretary of the navy is to deposit an amount equal thereto with the United States treasurer, subject to the court's order.

WHITE'S ANNUAL REPORT.

Superintendent of Railway Mail Service Gives Out Figures.

Washington, Nov. 5.—The annual report of General Superintendent White, of the railway mail service, for the fiscal year 1901 shows that the mail matter handled, (exclusive of registered matter) was 14,181,224,430 pieces, an increase of 2.81 per cent. over last year. The number of errors in distribution were one to 10,626 pieces. There were 17,198,995 pieces of mail matter illegitimately addressed, an increase of over 2,500,000 over last year.

There were, during the year, 825 casualties, in which seven clerks were killed, sixty-three seriously injured and 229 slightly injured.

BOXER LEADER HONORED.

Na Tung Appointed to the Chinese Foreign Office.

Pekin, Nov. 5.—Na Tung, a former "Boxer" leader, has been appointed to the Chinese foreign office by an edict received today. The appointment is considered a test of the attitude of the Chinese ministers toward the restoration of "Boxers" to imperial favor. The Japanese influences supported Na Tung, a fact which contributes further evidence of Japan's recent policy of co-operation with China.

TAMMANY OVERWHELMED.

The work of the voters of the great city of New York yesterday will cause rejoicing throughout the length and breadth of the land. Impudent, arrogant and shamelessly corrupt Tammany has been whipped to a finish by the forces standing for decency and good government, and a decisive step has been taken for the purification of the morals of the great municipality which has so long accepted the will of a venal political boss as its rule of action.

Never before have the contending forces in that city had the issue on which they were to pass so plainly presented to them. Never before were the Tammany men so thoroughly organized, or so fully convinced that the battle to which they were challenged was to be to the death. The leaders of that iniquitous league were given full and fair notice that if the supporters of Seth Low carried the city there would be a new order of things instituted in its government which would render the great metropolis an unsafe place for the hordes who have lived by criminality and on the wages of crime, under the protection of the very officials who were sworn to enforce the laws and maintain order and decency.

It is a result over which the whole country can rejoice, for a triumph of the right anywhere brings nearer the day when it will triumph everywhere. New York is not the only city in the union cursed by a corrupt government, but misgovernment in all the others where bossism has fostered vice and protected those who traffic in it was struck at effectively by the voters of that city yesterday, when they repudiated Croker and put the seal of their condemnation on the rule of Tammany Hall.

Ex-Speaker Adams of Grand Rapids, who is under indictment on the charge of having accepted a bribe from Chas. H. Pratt when he was speaker of the house, in connection with the scheme of the latter to secure a book contract under which his concern would be authorized to place a set of law books in every county of the state for use of the circuit judges, says he is ready for trial and glad that the time has come when he can vindicate himself. The Grand Rapids Herald quotes him as saying in regard to the case against him, which is set for trial next week:

I am glad this matter is going to be brought to a focus. Two years ago when it was laid before the public, upon the advice of my friends I declined to say anything about the case and did not discuss it. Since then I have preserved that silence and borne the charges without a word. It would not benefit you nor me to have the worry and sorrow this matter has caused me during these two years known and understood, but I am glad that Prosecutor Tuttle and Judge West have decided to bring the case to a trial. It has never been delayed at my suggestion or request; that is all I care to say.

A Boston paper which claims to be a special exponent of the copper interest there is laboring incessantly and energetically to create the impression that the Amalgamated company is loaded to the danger line with copper, and that the market price of the metal is sure to be reduced in the near future. What its object is can only be guessed at. The facts do not bear out its statements, and it must have some purpose in so laboriously and persistently distorting them. At all events it is doing much to unsettle the confidence in the stability of the demand for copper, hence much to demoralize an industry that has done much to enrich Boston and give it a place of its own as a financial and speculative center. From the start the publication alluded to has manifested a singularly rabid unfriendliness toward the Amalgamated company. That may be to its credit, but it is going too far when it uses its columns to injure a legitimate industry merely to embarrass a single corporation interested in it.

Fourteen American war ships are now employed in maintaining a strict blockade of the island of Samar, of the Philippine group, where the natives treacherously attacked a company of our troops some time ago and slaughtered several of them. No supplies from the outside are allowed to reach the bad Samaritans, so the prospect is that they will ultimately be both starved and whipped into submission. Their bad faith in making a murderous attack on our soldiers while professing friendship forbids any sympathy for them in the troubles they have brought on themselves, hard though their punishment may be. In dealing with the natives in the Philippines there can be no leniency shown those of them who profess to accept our rule only to make their pretended submission a cloak to plots such

as that successfully carried out in Samar. They can understand severity but appear as yet to be utterly incapable of appreciating or profiting of lenient treatment.

Whatever it may mean, the government of Nicaragua has "renounced," which means called off or terminated, the treaty empowering the United States to construct an interoceanic canal across its territory. No information is given our government concerning the motive of the Nicaraguan government in taking this step. But whatever it may be, it is not probable that our government will place an offensive construction upon the singular action of Nicaragua. If we are not permitted to construct the canal on that route we can adopt the Panama route, provided we conclude that we must have an isthmian canal. Perhaps the wisest thing we can do is to adopt the views of Andrew Carnegie and go in for a double-track isthmian railway instead. It would cost very much less, and Mr. Carnegie, who is well posted on transportation problems, says it would do the business for us even better than a ship canal.

A colored man of Boston finds fault with the president for having dined with Booker T. Washington, on the ground that the latter is not a representative negro. According to this critic of the president, the man through whom he sought to give evidence of his regard for the colored race should have been selected from the more aggressive class of southern negroes, instead of one who holds the views entertained by Mr. Washington as to what the course of the colored people in this country should be to secure their rights and obtain fair play from the whites. The Boston colored man may "know beans" but his objection to Mr. Washington as a representative of his race doesn't show it.

It is no secret that Senor Tomas Estrada Palma is the man our government desires to have chosen first president of the Cuban republic. But there is some doubt of his election, though he is strongly backed by the military government which we have established there. General Bartolome Maso has announced himself a candidate against Palma and appeals to such a variety of elements of the population of the island that there is a fair prospect of his gaining the prize. If he should succeed in this our relations with the new government will not be as pleasant as it is desirable they should be and a new source of disquiet will be created in Cuba.

The contractors who put up the exposition buildings at Buffalo got barely enough on their work to cover the cost of construction, while those who took stock in the big venture lose all that put in. The total deficit is now placed at \$3,000,000, which is a million less than it was estimated it would be shortly before the exposition closed its gates. The experience of Buffalo should serve to deter other cities which have been planning expositions from pushing their schemes, and if it has that effect Buffalo's loss will bring a compensating advantage to the country at large, which has had a sufficiency of displays of that kind for the present.

The Pan-American exposition is over but the Pan-American congress at the City of Mexico has taken up the running and is doing its share to keep the Pan-American idea from ceasing to hold popular attention. A good idea it is, too, if we can only get the South American countries to appreciate its significance.

If the Turkish Sultan expects England to side with him in the trouble he has brought on himself he is pretty sure to be disappointed. England has enough on its hands now without mixing up in an embroilment between Turkey and France. The sultan had better pay and be done with it. Honesty may be expensive but it comes cheaper in the end than warfare.

SEARCH FOR BODIES

NO TRACES OF MICHIGAMME LAKE VICTIMS.

GRAPPLING HOOKS ARE USED

TUG AND SMALL BOATS SPEND ENTIRE DAY ON LAKE.

Those Familiar With Lake Are Satisfied Bodies of Four Boys Are in at Least Seventy-Five Feet of Water.

Michigan, Mich., Nov. 5.—The omission of the word "not" in today's account of the drowning of George W. and Able Levin and Emil and Albin Carlson left the impression that one of the bodies had been found with the boat. It was one of the four boys that was picked up. The men searching for the bodies today again went to the lake. Several on F. W. Read & Co.'s tug turn at operating the grappling hooks procured from the life saving station at Marquette, while others were out in row boats with smaller hooks. The hooks from the life saving station are four feet in length. No trace of the bodies was found.

Supervisor Sundstrom and P. H. Trezise went to Marquette Monday evening in an endeavor to find divers who would come up and work for a few days in an effort to bring the bodies to surface. While there they procured the hooks, but returned uncertain that divers can be procured at a very near date.

The people of Michigan keenly feel the loss of the four young men. All the boys were popular and they were intimately known to nearly every man, woman and child in the village. All respect the greater part of their lives here.

The Levin brothers were prominent members of the local lodge of Odd Fellows. George held the executive office in the society at the time of his death. Emil Carlson held membership in the Masonic lodge and also in the United Workmen, carrying \$2,000 insurance on his life in the former and \$1,000 in the latter. He also carried a policy for \$1,000 in the Aetna Life Insurance company. Albin Carlson was a member of the Workmen and was insured in the society for \$1,000. This will be the amount of the Carlson boys \$5,000 insurance money in all.

If the bodies of the Levins are ever recovered they will be taken to Chicago for interment in a Jewish cemetery, the father of the young men holding membership in a church congregation of that city.

Bodies in Deep Water. Those familiar with the lake are satisfied the bodies are in at least seventy-five feet of water and possibly more. In the center of the lake, between the island opposite Backes' farm and the boat houses below the hill, the depth of the water is over fifty feet. At the time the men worked there during the past summer in search of the body of James Bruce, who went down while swimming, the water was found to be that depth in places, while soundings taken at different times shows that the greatest depth is in the neighborhood of one hundred feet.

It will surprise many here if the bodies are recovered by the hooks, as the bottom is quite rough in places. There are large boulders at some points and soft mud at others. The hooks borrowed from the life saving station are made so as to double up when a rock is encountered, otherwise it would be impossible to drag them along the bottom with any degree of success.

It is the general belief that the body of Albin Carlson the young man who was heard by his father calling for help, is below the point, some half a mile or more from where it is thought are the other bodies. The western end of the lake will be thoroughly dragged before the tug moves east of the point.

The Lake's Fatality Record. Including the four victims of Sunday's accident, nine persons have lost their lives in the lake, seven of these having been drowned during the past two months. Henry Lacross, a boy, was lost on the 25th of November a year ago. During the summer, James Bruce, little chap who was in swimming with some companions, was drowned. He went over his head and was unable to swim back. Another young fellow a stranger in these parts, was drowned near Champion. About twenty-one years ago a boy named Dufrene was drowned in this end.

The loss of the four young men in the storm of Sunday night was by far the most deplorable accident that has ever occurred in the village and the afflicted parents are entitled to all the sympathy they are receiving from their many friends here as well as other places in the county.

This will make the legislature surely Republican in both branches. Quincy Carries Boston.

Boston, Wednesday, Nov. 6.—At 11 a. m. the returns from every city and town in the state except Dartmouth, give Crane, Republican, 185,500; Quincy, Democrat, 115,370. Last year the total vote of the state was: Crane, Republican, 228,054; Paine, Democrat, 130,078; Crane's plurality, 70,408.

With no state or national issues more ballots were cast today than in any year in the history of the state. The Republicans had no difficulty in carrying the state, with Murray Crane elected governor for a third time. The legislature will be strongly Republican, although the Democrats gained few votes. Quincy, former mayor of Boston, carried the city today by a plurality of 7,969 in the contest with W. Murray Crane for the governorship, a gain of about 4,000 over the plurality last year.

IOWA ELECTS CUMMINS. Entire Republican State Ticket Shows Big Pluralities.

Des Moines, Nov. 5.—The result in Iowa is remarkable. With a marked falling off in the vote throughout the state, a loss in some precincts of 40 and 50 per cent on the total vote, and an average loss in the state of one-fifth of the total of two years ago, A. B. Cummins, Republican candidate, was elected by a plurality of 90,000, the largest ever given a governor in this state.

The entire Republican state ticket was elected by similar pluralities and some extraordinary gains have been made. The Republicans elected in the legislative contests they gained three or four members to add to their majority in the senate, while in the house the great majority will be increased by seven or eight. Cummins said:

"The percentage of the majority for the Republican party is as large as any party ever had. It could not well be any larger. I am much gratified at the result."

Democratic headquarters closed early in the evening and no statement was given out. The prohibitionists claim a large gain and are very much gratified, but have not sufficient returns to give out any figures.

KENTUCKY GOES DEMOCRATIC. General Assembly Will Elect Successor to Senator Deboe.

Louisville, Wednesday, Nov. 6.—The general assembly elected yesterday, with the exception of half the senate, which holds over, will be Democratic on joint ballot by an increased majority. This general assembly will elect a successor to Senator William J. Deboe.

At 11 a. m. the returns indicate: Senate, twenty-six Democrats; twelve Republicans; house, seventy-seven Democrats, twenty-three Republicans.

For the first time in years the returns do not show the election of a single Populist to the assembly. In addition to electing a United States senator the new assembly will redistrict the state into senatorial, representative, appellate and circuit court districts for ten years.

PENNSYLVANIA REPUBLICAN. Returns Indicate 70,000 Plurality and Amendments Are Carried.

Philadelphia, Wednesday, Nov. 6.—2 a. m.—The returns indicate the election of the Republican state ticket and Frank G. Harris for state treasurer and William P. Potter for supreme court judge, by from 60,000 to 70,000 plurality. The vote in favor of the proposed constitutional amendments in the interest of ballot reform was overwhelming.

Secretary Clements, of the Union party, concedes the defeat of the state and county ticket of the union party in Philadelphia.

RHODE ISLAND FALLS OFF. Elects Republican State Ticket by Plurality of 5,000.

Providence, R. I., Nov. 5.—Without conclusive returns it was generally conceded after the close of the polls that Governor Gregory and the Republican state ticket were elected by a plurality of 5,000. This is a loss of 3,000 from last year. The vote throughout the state was light.

CHICAGO GRAIN MARKETS. Features of the Day in the Wheat, Corn and Oats Pits.

Chicago, Nov. 5.—There was a better general trade in wheat today and the market was somewhat broader, with more outside interest. The undertone was stronger and the close a cent to 1 1/2 higher. Changing was again a feature—buying of December and selling of May—the spread being 2 3/4@3. The further advance in corn, higher cables and bullish Argentine news were the main strengthening factors. At Liverpool, spot was steady to 1/4 higher, with the futures up 1/4@1/2. The exports were 130,000 bushels and no boatloads were reported taken. The Ohio state report, showing the condition of the crop, led to a 75 per cent was a late bull help. The local receipts were 212 cars.

Another active day was witnessed in the corn market, which was strong, higher prices ruling and being fairly well maintained, the close showing 3/4@5/8 gain. Higher cables, small receipts and bullish Argentine news were the main strengthening factors. At Liverpool, spot was 3/4 higher, with the futures 1/2@3/4 higher. The feature on the upturn was the free selling of December by several of the larger commission houses, but the same was well taken. The receipts were 148 cars.

Oats ruled active, with an advance of 1/2, and after a small recession rallied and closed at the top. The leading futures ranged as follows: December wheat opened at 71 1/2@72; highest, 72 1/2@73; lowest, 71 1/2; closed, 72 1/2. December corn opened at 58 1/2@59; highest, 59; lowest, 58 1/2; closed, 59. December oats opened at 37 1/2; highest, 37 1/2; lowest, 37 1/2; closed, 37 1/2.

Receipts and shipments were as follows: Receipts, Shipments. Flour, barrels, 20,000 21,000. Wheat, bushels, 329,000 284,000. Corn, bushels, 141,000 74,000. Oats, bushels, 339,000 362,000.

A. R. Jones & Co., in a despatch to Hayden, Stone & Co., yesterday said of the Chicago grain markets: "The wheat market was thoroughly bullish today and scored a healthy advance. Reports were in circulation of a sale yesterday of a quarter of a million to go to Mexico. There was nothing special in the movement or cash situation. The low relative price is now the best incentive to buy. We think purchases on any break would show good profits."

"Corn again lead in strength, based on Liverpool's advance. Corn is too high to attract outside trade. We believe corn will sell a great deal higher, but why trade in this when wheat is cheaper? The prospects are as good or better."



BLACKSMITH SHOP AND DRY.
 New Buildings Will Soon Replace Old Ones at the Negaunee Mine.

The blacksmith shop and dry house at the Negaunee mine will soon be replaced by new and more convenient structures. The use of the present buildings would probably not be abandoned this winter were it not for the fact that both are in danger of falling away with the caving ground. As stated in a recent issue, the opening extends within a few feet of the front entrance to the blacksmith shop and there is danger that more of the ground will move from that side of the bank before many weeks pass.
 The new shop and dry will be larger than those now in use, the present structures being hardly large enough to meet the requirements. The old dry house is twenty-four feet wide by seventy-six feet long. The new one will be over thirty feet in width and in the neighborhood of one hundred in length. The second floor of the dry will be fitted to meet the needs of the workmen. Bath rooms will be provided and the building will be thoroughly equipped in other ways.
 The miners will have much more room in the new building. Their lockers will be larger and the building will be more comfortable.
 The locations of the new buildings have not yet been decided on, but it is likely that the dry will be stationed on the side of the hill a short distance west of where the present one stands. No location for the new blacksmith shop is yet being considered by Captain Piper.
 It is understood that the erection of the new structures will be started at no distant date as the ground on which the old ones stand is not considered any too secure.

FACE BATTERED IN

CORPSE FOUND ON LAKE SHORE WAS UNIDENTIFIED.

NOT A STITCH OF CLOTHING

PECULIAR TEETH, HOWEVER, MAY SOLVE THE MYSTERY.

Coroner Cray Returns from Pine River, Where He Conducted Inquest, With Belief Body Was That of a Hudson Victim.

The body of the man recently found on the lake shore at a point about half a mile this side of the Pine River club is believed by Coroner Cray to have been that of one of the victims of the steamer Hudson disaster.

Impossible to Solve Identity.

It was impossible to determine the man's identity. The body was not only quite badly decomposed, but it did not have a stitch of clothing and no garments of any kind were found anywhere in the vicinity.

The remains were those of a powerful man, who evidently had weighed in the neighborhood of 185 pounds and was about thirty years of age.

from some vessel." However, it was the belief that the man was a member of the crew of the steamer Hudson, which went down off Keweenaw point several weeks ago, it being the idea that when it was seen the boat was sinking the unknown, thinking the shore but a short distance away, had stripped to the skin and took his chances by swimming.

Wreckage on the Beach. To strengthen the opinion the man was from Hudson, was the fact that wreckage was found on the beach that evidently had come from a steamer. This consisted of the decorated border of a cabin, the boards being of green and gold, and a hatch. In addition, the coroner learned at Big Bay, some miles this side of Pine river, that a hatch marked "steamer Hudson" had come ashore there.

The discovery of the body was made by Samuel Durant in a peculiar manner. Mr. Durant, who had been engaged in moving the belongings of Custodian Petee from Sauk's Head to the Pine River club, that night noticed a blue light down the beach and remarked concerning it to Mr. Petee. The men watched it for some little time and came to the conclusion it was from some launch that was making a landing.

AFRAID OF "THE BAD MAN."

La Hop Sing, the Chinese laundryman whose brother died recently, is moving into new quarters on Superior street.
