HARRISON WINS OUT. CHOSEN MAYOR OF CHICAGO FOR THE FOURTH TIME. HE DEFEATS STEWART BY 7,000. DEMOCRATS ALSO ELECT HUMMEL CITY TREASURER.

Chicago, April 7.—Carter H. Harrison was elected mayor of Chicago today for the fourth time, his majority by the unofficial count over Graeme Stewart, the Republican candidate, being 6,948. The total vote was: Harrison, Democrat, 146,323; Stewart, Republican, 139,375; Cruik, Independent Labor, 9,999; Breckton, Socialist, 11,212; Haines, Prohibition, 2,848.

Chicago, April 7.—The Democrats won today by a majority ranging from eight to ten thousand. Every Democratic candidate was elected. The Republicans carried Jefferson City, Carthage and Lamar, and the Democrats Nevada, Mexico, Rich Hill, Warmenburgh, Kirksville, Butler, Richmond, Excelsior Springs, Moberly and Joplin. The Independents carried Sedalia.

NEEDS MUCH LABOR

30,000 MEN WILL BE EMPLOYED ON PANAMA CANAL.

LOCAL SUPPLY IS INADQUATE

SUB-COMMISSION GOES TO INVESTIGATE THE PROBLEM.

Is Likely That Negroes Will Be Drawn by the Hundreds from Southern States and That Many Chinese Will Be Imported.

Washington, April 7.—Admiral Walker's estimate of the number of men to be employed on the Panama canal when the United States formally shall have entered upon the project is thirty thousand. The men now engaged on the canal construction work are principally Jamaica negroes, as they are immune to the Central American climate and do not suffer seriously from the diseases prevalent on the isthmus.

One of the purposes of the visit to the isthmus soon to be made by a sub-committee of the present canal commission is to study the labor question as it relates to the construction of the waterway, with a view of ascertaining the source from which an additional labor supply may be obtained. The local labor supply is insufficient to meet the demand. It is probable, therefore, that laborers will be drawn by thousands from the Southern states and the islands of the West Indies.

As the labor supply is controlled largely by companies organized for the purpose, it is quite likely that many Chinese and Japanese will be imported for work on the canal. They are excellent workmen and are peculiarly fitted by nature for work of that kind and in that climate.

KING EDWARD LEAVES LISBON.

Departs on the Royal Yacht, Escorted by Cruisers, for Gibraltar.

Lisbon, April 7.—King Edward boarded the royal yacht Victoria and Albert today preparatory to departure tonight for Gibraltar. King Edward and King Carlos received an ovation along the whole route followed.

King Carlos lunched on board the Victoria and Albert with King Edward today. Edward, proposing the health of Carlos, spoke of the friendship of the two nations and predicted that they would move together in paths of peace, progress and civilization for many centuries. King Carlos replied with like warmth, saying that England could count on Portugal being her true and loyal friend forever.

The British royal yacht, accompanied by the British cruisers Minerva and Venus, left Lisbon for Gibraltar this evening. The departure was signalled by a cannonade and salutes from vessels in the harbor, and the yacht was escorted twenty miles out to sea by two Portuguese cruisers.

Boston, April 7.—The manufacturing firm of George Coburn & Co., with factories in this city and Midway, Mass., today made an assignment. The liabilities are \$300,000.

MILITARY GUARDS TRAINS.

Vigorous Measures to Prevent Strike Disorders Taken in Holland.

Rotterdam, April 7.—The warship Holland is moored off town and a thousand soldiers have arrived here. The river is being patrolled by steam picket boats. An unsuccessful attempt was made to wreck a passenger train during the night.

Amsterdam, April 7.—A number of the employees of the Netherlands railroad returned to work today, enabling a continuance of the restricted service. All trains carry military escorts. The workmen's committee of defense has now proclaimed a strike of bakers throughout the country.

Castle Loo, April 7.—Queen Wilhelmina and her husband started for The Hague today. Troops guard the railroad line.

TELEGRAPHIC NEWS CONDENSED.

STOCK MARKET IS WEAK.

Some Wide Declines Despite Much Easier Money Conditions.

New York, April 7.—The weakness which developed in today's stock market bore witness to the disappointment felt in speculative circles at the failure of what are considered favorable developments in the situation to awaken any sign of interest in speculation on the part of the outside public.

Call money was not higher than 6 per cent at any time today and fell lower than that on enlarged offerings by the banks. There was some leaning on call also by stock commission houses which have supplied their expected needs with time loans and have money on their hands now owing to the practical stagnation of the commission business in stocks at present. The immediate money situation ceases to be a factor in the stock market.

The indefinite postponement of the Southern Pacific annual meeting was viewed in a more encouraging spirit this morning owing to its insurance of an indefinite prolongation of the present control of that property, but renewed uneasiness was felt over the position of the speculative pool in the Southern Pacific stock. The extension of the pool carries it only to April 10 and the suggestive weakness of the stock today had a weakening sympathetic effect on the market. Reports of strikes at some collieries in the anthracite region owing to the disputed interpretation of the strike commission's award had a depressing effect on the coalers. Sharp declines in United States Steel securities coming at the same time with the meeting of the finance committee of the corporation had a decidedly unfavorable effect. Both stocks fell over a point and

The net earnings of the United States Steel Corporation for the first quarter of the calendar year were \$24,056,136, a decrease of \$1,623,463 compared with last year.

The annual report shows that the balance of net earnings for the year, after deducting all charges, including sinking funds, depreciation and improvements, was \$108,534,374. The total surplus on Dec. 31 last was \$77,874,597, which included the capital surplus of \$25,000,000 provided at the date of organization. The volume of business during the year aggregated \$369,510,479.

The average number of employees is 168,127, receiving \$120,928,344 in salaries and wages.

WAS ELECTROCUTED

ANDREW JOHNSON MET A HORRIBLE FATE YESTERDAY.

DEATH WAS ENTIRELY ACCIDENTAL

HE GRASPED CABLE TO START AN ELECTRIC LAMP.

Jerk Broke the Span Wire and the Cable Fell on a Live Wire—Efforts to Free Unfortunate Without Avail—Leaves a Family of Six.

Andrew Johnson was electrocuted at the corner of Park and Fourth streets yesterday morning about 1:30 o'clock, as briefly stated in The Mining Journal yesterday. The are light at that corner, it appears, was out when Johnson was passing by on his way to his home, about a hundred feet off. In order to start the light up he grasped the cable by which the lamp is lowered and raised, giving it a vigorous shake. His tug was strong enough to break the span wire, running between the two lamp poles and supporting the cable and light, this allowing the cable to fall forward on one of the live wires attached to the pole just below. This completed a circuit to Johnson's hand and for upwards of ten minutes an electric current of large voltage coursed through his body. The first efforts to release him were unavailing, and when he was finally gotten clear of the cable he fell to the ground dead.

Yesterday Coroner Cray empaneled a jury to investigate the case. The members were Gus A. Larson, Tom P. Lang, John L. Johnson, John McKinon, James Freeman and Edwin C. Quarters. After looking into the death as far as possible the following verdict was rendered, "that Andrew Johnson came to his death by accidentally coming in contact with a live wire attached to a lamp pole, belonging to the Marquette City Electric Lighting company, located on the southeast corner of Fourth and Park streets."

According to the facts submitted at the coroner's inquest there were no eyewitnesses of the manner in which Johnson came to grasp the wire. It is known, however, that the light was out at the time of the accident, although it had been burning shortly after twelve o'clock, and it is also known that it had been Johnson's habit to try and shake lights up to make them burn, a practice by no means confined to the deceased and which will now probably become unpopular. Observing the light to be out and thinking to start it burning, Johnson very evidently gave the cable, ready at hand, a vigorous jerk. The span wire must have been weak, or Johnson must have pulled with very great vigor, for it gave way, dropping the cable on

to the live wire beneath and sending a heavy current through the unfortunate man at the bottom of the pole.

Outcries Aroused Neighbors.

His screams brought out the neighbors. J. C. Johnson and Tom and James Saunders, father and son, were first on the scene, Johnson being conscious enough at the time to implore aid in getting away from the wire. His hand was caught between the cable and the pulley used to lower and raise the lamp, and he was helpless to extricate himself. Johnson and Tom Saunders laid hands on him and were as promptly shocked by the current. An axe was hastily obtained and Superintendent Retaille was called out of bed to have the plant shut down. A blow of the axe on the cable released Johnson and at the same time the generators were stopped at Dead river, but the unfortunate's life was extinct. It is said that he must have received the current for ten minutes.

In the evening the "pay-off" was celebrated in a formal manner by an excellent musical and literary program at Fraternity Hall, a feature of which was an address on the objects and aims of the national legion by Dr. Sattler of Manistique. An address of welcome was given by Mayor Russell. The pay-off was made by Dr. C. N. Connor of St. Ignace, district deputy, and was accompanied by some interesting remarks by the lady. Those who received dividends were: May D. McCormick, Clara Cosford, Jos. C. Cosford, L. Harris, Christie L. Fairbanks, Josephine Frieberg, Thida Ragusett, Anna Hibbard, Fannie Hoffenbacher, Ruth Ekstrom, Frances J. Grant, Mary Johnson and Hattie Chappell. The total sum disbursed was \$2,232.31.
