BEETS WOULD PAY.

Negaunee Man Is Sure There Is Money in the Sugar Industry.

A man who is greatly interested in farming and who owns a well tilled tract of land near here said yesterday that in his opinion the sugar beet industry has a great future in this section. He thinks that all the natural conditions here are as favorable to the culture of the beet root as they are in the lower peninsula, where the industry has assumed large proportions during the short time that it has been established. Michigan now ranks among the foremost of the sugar producing states, though the first factory has been in operation for less than five years and vast areas of land that would produce abundantly have not yet been touched.

The factory that is being erected at Menominee is the first step that has been taken toward introducing beet raising into the upper peninsula and general interest has been aroused among those who believe in the agricultural possibilities of this region in the result of the experiment. If beets can be raised at a profit in the country surrounding Menominee, the Negaunee man referred to sees no reason why Marquette county farmers could not raise the new crop with equal success. The men who are promoting the Menominee factory have investigated the subject thoroughly and are fully convinced that the lower peninsula has no advantage over upper Michigan, either in the fertility of the soil or climatic conditions, that should make the business any more profitable there than in this region.

The industry, if it is ever undertaken here, would do much to encourage farming, but it would necessarily be of much slower growth than it has been below owing to the undeveloped condition of agriculture and the predominance of mining over all other occupations. Beets require more attention than any other crop. The thinning and hoeing must all be done by hand and both processes require a large amount of labor. The harvesting and hauling of the beets in the fall is also a long, tedious job. These things would count against beet culture in this vicinity, for labor is not very plentiful and as a general thing is more expensive than below. Then the roads in the country districts in the late fall when the beets are hauled to the market are not in the best of condition, to say the least. One of the first things that the farmers learned in the sections where the industry is extensively carried on was the absolute necessity of good county roads, and highway improvement has been undertaken on a larger scale than had ever before been attempted. But these hindrances do not present insurmountable obstacles, and no doubt would be overcome if beet raising should be attempted on a large scale.

It is doubtful if the farmers near here will attempt to raise beets this season, though the agents of the Menominee factory may be up here next spring and make a canvass for contracts. The factories usually solicit the farmers to sign contracts by which they bind themselves to raise a certain number of acres of the beets and deliver them to a specified point, either the factory or the nearest railroad station. Payment is based on the tonnage and the percentage of sugar. Different scales of prices prevail, but the average is about \$5 per ton for beets that list 12 per cent sugar. When the tests run higher or lower the price varies proportionately.
