HAD A BUSY NIGHT.

Fire Department Called Out No Less Than Three Times Tuesday.

The Negaunee fire department was called out Tuesday night three times, in nine hours, to subdue two obstinate fires. Few of the firemen were able to get more than one or two hours sleep and some of them were up all night.

The first alarm came in at about 9:30. The fire was located in the second story of C. J. Thoren's building, occupied by Mr. Thoren as a residence. It is thought the blaze originated from a chimney, and started in the narrow space between the Thoren building and that occupied by the Negaunee Co-operative store.

The extent of the damage is pretty hard to estimate, but it will probably reach a pretty large amount. The roof of the Thoren building was completely destroyed by the fire, and the damage caused by the smoke and water will be fully as much as that caused by the flames.

The oven is located in a rather unsubstantial addition to the bakery, and the flames went right through the roof, burning a good sized hole, but doing little further damage. There was a big stock of bread and other baked goods in the front part of the bakery that would have been ruined by a very small amount of water, so the stream was applied only to the part of the building where the oven is located.
