DENVER STRIKE MADE GENERAL. Workers in More Lines Are Called Out and Over 4,000 Now Are Idle.

Denver, May 15.—The joint executive committee of organized labor, owing to the refusal of the Citizens Alliance to agree to arbitration between the employees and employers directly interested, called out a thousand brewery workers, retail clerks, garment workers, horse shoe makers, mattress makers and electrical workers during the day, increasing the number of strikers to more than four thousand.

In a letter received today and mailed April 16, Mrs. Anenberg described the horrors of these massacres, saying in part: "Butchers Marched in Companies."

CONTRACT LET.

Consolidated Fuel & Lumber Co. Will Furnish Materials for New Sewer.

The committee on sewers, to which was referred the petition of the residents of Park street asking for the construction of a sewer along the north side of that thoroughfare, met Thursday and awarded the contract for furnishing the material to the Consolidated Fuel & Lumber Co., for \$344. The new sewer will extend from Mitchell avenue through to the Baldwin Kilns road. The conduit will be eight inches in diameter for the greater part of its length and six inches for the remainder of the distance. The company is not now provided with the material, but it will be ordered at once and will soon be shipped here in several car-load lots. About 120 Ys to be used for connections will be included in the contract. The sewer will be laid on building property and will be put in place where it will pass through Louis Kellan's lot for a distance of 200 feet. It would be well nigh impossible to avoid crossing the lot without impairing the value of the sewer. Mr. Kellan offered to give the city free right of way, only requiring the contractor to pay for the time for planting his garden. In order to comply with his wish the pipe will be laid through his lot immediately, it having already been ordered from Menominee.

Street Commissioner Thomas will superintend the work. He is an experienced man at the work, having been in charge of many similar undertakings for the city during the time that he has held his present office. His work has always been done economically and well. The question of building the proposed sewer has hung fire for several years. The residents along Park street have sent petition after petition to the council, but always until now in vain.

LIVED HERE FORTY YEARS.

James Sheehy, one of the pioneer residents of Negaunee, died yesterday morning at about one o'clock after a lingering illness. Mr. Sheehy was seventy years of age. He was born in Ireland, but emigrated from that country when a young man. He lived in various portions of the United States previous to coming to Negaunee. He had resided here forty years ago when the town was in its infancy. His memory of the early days was very distinct, reaching back as it did to an earlier period than most of the present day residents are familiar with. He worked about the mines for many years, but had suffered very poor health for the past four or five years, being an invalid for the most of that time. It became evident over a week ago that his death was near at hand and all his children were present at the end. A wife, three sons and three daughters survive him. Michael resides in Negaunee, James in Houghton and Patrick Dowd, a step-son, lives here. The daughters are Mrs. T. P. Reilly, Chicago; Mrs. John Block, Marquette; and Mrs. Peter Trotter, Belvedere, Ill. The funeral will be held tomorrow morning from St. Paul's church.

STRONG BILL TONIGHT.

"The Second Mrs. Tanqueray" Will Be Given an Adequate Presentation.

Rose Coghlan, supported by a company of unusual merit, will be at the opera house this evening in "The Second Mrs. Tanqueray," which promises to be one of the most artistically produced plays that has been seen here this season. Every famous actress of the civilized world has appeared, or clamored to appear, as the much discussed Paula Ray, afterwards "The Second Mrs. Tanqueray." A MAGNIFICENT COUNTRY.

Is the Region About the Dalles, in State of Oregon.

Walter McGuire recently arrived home from Oregon where he went to file on a timber and stone claim located by John Clark, formerly of Marquette, a land-looker, who has been in the west for the past few years. Mr. McGuire filed on a 100-acre claim about fifty miles from the Dalles, which is eighty-nine miles up the Columbia river from Portland. His claim carries yellow pine and fir, and it is estimated that it will cut over 3,000,000 feet. It is admirably located on a tributary river, which will permit of easy lumbering of the tract. When Mr. McGuire was west only four of some twenty-five claims in the group located by Clark had been taken, although it is likely that others have been pre-empted in the interval. The timber is located in the foothills of the mountains and is of excellent quality. Clark and McGuire had a fifty mile drive from the Dalles to the timber claims. The country is pretty well settled, the big ranches being the rule. The settlers have to date, however, been paying little attention to the timber, as they have been looking rather to agriculture and stockraising as a means of livelihood. Thus they have sought the level plains and have even kept away from the country that affords magnificent wealth. It is probable that Clark will locate other Marquette people. He has been in Oregon the past six or seven months only, having previously been in the Coeur D'Alene district in Idaho.
