COMMENCEMENT DAY PLANS UNDER WAY

ENTIRE PROGRAM WILL BE GIVEN BY MEMBERS OF THE GRADUATING CLASS.

ORATORICAL CONTEST ON

Students Are Greatly Interested in the Event to Be Held Shortly After the Easter Vacation.

Although the end of the school year is yet almost three months away, plans for the annual commencement program are already under way. It has been decided to depart from the usual custom of having some prominent man from abroad deliver the commencement address, and this year the entire program will be furnished by the pupils themselves.

The commencement exercises will be held Thursday night, June 17, and the program will consist of essays or orations by six or more members of the graduating class, while the music will be furnished by the entire high school, under the direction of Miss Norma Ross. The graduates who will take part in the commencement program will be selected by the teachers, and, with the exception of the valedictorian, the selection will not be made entirely on the basis of scholarship, but rather with the idea of choosing a fair representation of the class as a whole.

Superintendent Gehrand intends that those who appear on the commencement program shall not discuss subjects which have puzzled the greatest minds of all the ages, as is sometimes the case in graduation exercises, but that their efforts shall be largely expository, dealing with subjects of especial public interest at the present time. The speakers will not be encouraged to expound theories of their own, but rather to set forth in a lucid manner what they may have learned about the subject of their choice from their reading and research.

There are now twenty-five members in the Senior class, but it is possible that some of this number will not graduate. This class is somewhat smaller than the average for the last few years. The class day exercises will likely be held the night preceding commencement, and will be of much the same nature as in former years. On the Sunday preceding commencement, one of the ministers of the city will be asked to deliver the baccalaureate sermon to the class. The commencement exercises will be held in the opera house, and the class day exercises in the high school building.

Oratorical Contest.

The matter of paramount interest at the high school just now is the oratorical contest, which will be held sometime after the Easter vacation. This vacation will begin at noon of April 7 and continue until April 14.

This oratorical and declamatory contest is a purely local affair, as Marquette will not compete in the district or state contests this year. Cash prizes will be awarded to the winners of both the oratorical and declamatory contests, but just how large they will be is not yet known. The late Peter White left a fund for this purpose, and Superintendent Gehrand hopes to induce several individuals and business houses in the city to donate toward the prizes for the winners of the contests.

Another year it is hoped to enter the district and state contests, but this year it was impossible to hold the preliminary contest early enough in the season in order to enter the district contest to be held at Ishpeming in the near future.

There are now five entries in the local oratorical contest and thirteen in the declamatory contest. Those who have orations have them written, but no rehearsing of any consequence has been

done. Those in the declamatory contest have made their selections and, in most cases, have them partially committed. Both the contestants and the student body as a whole are taking more than ordinary interest in the coming contests and it is expected that they will be productive of much good, both to those taking part and to the student body.

NEW TELEPHONE DIRECTORY.

Cell Company Issues Book Considerably Different from One Now Used.

The March issue of the Michigan State Telephone directory is now ready for distribution, and will be distributed to the company's subscribers by carriers, beginning today. Patrons are requested not to call at the office for copies of the new directory, as they will be delivered at your home or office within a very short time.

The new directory differs from the old in several respects. The new book is of increased size, and contains the subscribers to the Munsing exchange in addition to those in the former issue. The cities and towns now included in the directory are Marquette, Negaunee, Ishpeming, Republic, Humboldt, Champion, Michigamme and Munising.

The new book is in larger type than former issues and a change has been made in the system of number calls on the party lines. Instead of the former system of Black 100, Black 100-2, Red 100, Red 100-2, letters are used, making the call much shorter and convenient, both for the subscriber and the operator. Red 100 is designated as 100-J in the new book, Red 100-2 as 100-K, Black as 100-L, and Black 100-2 as 100-W, and all other numbers likewise.

For the first time local advertising has been admitted into the telephone directory. New directories will be issued quarterly hereafter.

COMMERCIAL FISHERS OPPOSE JENSEN BILL

TO ALLOW SMALL TROUT TO BE RETAINED WOULD DEplete THE SUPPLY, IT IS MAINTAINED.

Commercial fishermen from all over Michigan, including August J. Anderson of this city, were in Lansing Wednesday in conference with State Game and Fish Warden C. S. Pierce and to attend a hearing before the fisheries committee of the house relative to legislation affecting their line of business. Thirty or more men representing the larger part of the big fishing industry of the state were present.

One of the most important matters taken up by the visiting delegation was that of the bill fathered by Representative Jensen, which provides that fishermen may keep all small trout in their possession and fixing a certain ratio of value. At the present time the law prohibits the retention of trout under one pound and a half and such action is considered a misdemeanor, punishable by heavy fines.

There are a number of the commercial fishermen who do not favor the Jensen bill and Game Warden Pierce has put his stamp of disapproval upon it. These gentlemen assert that such a law would do great injury to the fishing industry of Michigan, as the retention of small trout of any size and weight under the limit now prescribed by law would create a dearth of that species. Before they have reached the age and weight now provided for, the fish have not reached the spawning period and to allow fishermen to retain them before this point is reached would sadly deplete the supply.

This, together with other measures that will tend to be protective to the fishing industry of the state, was taken up by the commercial fishers while in Lansing.

SUNDAY SCHOOL RALLY AT M. E. CHURCH TODAY

SPECIALISTS OF STATE AND NATIONAL REPUTATION TO CONDUCT CONFERENCE THIS AFTERNOON AND EVENING.

Herbert Moninger, a Sunday school training specialist of national fame, and D. B. Allen, corresponding secretary of the Michigan State Sunday school association, will conduct a conference at the Methodist church this afternoon and evening. Mr. Moninger will speak in the evening, and it is expected that the church will be crowded to hear him. Mr. Moninger conducted a similar meeting in Escanaba Wednesday, and the Morning Press of that city had the following to say of his visit:

"One hundred and forty Escanaba people last night pledged themselves to undertake a special Bible training course at the meeting which was conducted at the First Presbyterian church by Herbert Moninger of Cincinnati, a noted Sunday school worker who is now mak-

ing a tour of the upper peninsula. A committee from each of the Protestant churches of the city will meet early in next week to arrange if possible for a union study of the course that is outlined and if that plan is not found practicable each church of the city will take up the work separately. A special instruction book for the course is provided and at the close of the year's work each student is granted a diploma. Over 140,000 people are now pursuing the course in the United States, each state having supervision over its own students and awarding diplomas but all following out the same course.

Considerable enthusiasm was aroused by Mr. Moninger who is a most convincing speaker, and Sunday school work in this city, it is believed, received a decided impetus."
