New York, Dec. 26 .- New York and its environs were practically stormbound today for the first time this winter. The railroad service was almost wholly cut off, wire communitation in every direction was crippled, metropolitan streets were blocked with snow and shipping suffered considerable damage. Nearly ten inches of snow fell in the city. More than ten thousand shovelers and six thousand trucks were called out to remove the snow from the streets. The two eighteen hour Chicago trains wer delayed more than seven hours.

At 8 o'clock this morning a small tidal wave swept over the Battery sea wall and floaded many cellars. Two yessels were driven ashore near the quarantine station on Staten island. The coastwise freight steamer Thurman, laden with coal, ran ashore off Toms river, New Jersey, and remained tonight. hard and fast aground. Her officers and crew of twenty-two men were taken off by life savers. Five deaths in the city were charged today to the severity of the storm.

### Storm Severe at Philadelphia.

Philadelphia, Dec. 26 .- A snowfall o nearly two feet, which drifted in places to ten feet or more, completely tied up for hours today all steam and trolle traffic in this vicinity. The snowfall since yesterday morning until noon to day broke all records, the weather bureau aanouncing the actual full at 22.8 inches. A high wind caused it to drift to a depth of many feet. The Pennsyr vania railroad tonight abandoned traffic temporarily between Harrisburg, Philadelphia and Washington.

Ohio River Navigation Suspended.

Louisville, Ky., Dec. 26 .- With the withdrawal of the Louisville packets on account of the heavy ice, not a steam boat is moving on the Ohio river between Pittsburg and Cairo. Ice gorges Fourteen Persons Injured in the Wreck have formed at several points.

# COSTLY GIFT FOR MRS. TAFT.

Washington. Dec. 26 .- Mrs. Taft revived as a Christmas gift from the women of the cabinet a beautiful diamond brooch.
