

Armed with baseball bats, eluba stones, etc., the foreigners paraded through the streets of Westville, waying American flags. The mine oper. ators called on the sheriff for help, he and several deputies went to Westville. As soon as the officers saw the crowd, they determined that it would be folly to attempt to do anything should there be trouble. The governor was then called upon.

## Situation Considered Grave.

There is no doubt that the situation is grave. The miners here are determined, according to one of the leaders, to pull away from the state orgunization and fight their own battle. There is some suffering among the men. It was stated this afternoon that food is lacking among some families, and that these are starving. This is denied by the officers of the miners.

The saloons in Westville, which have been closed for two years, will open tomorrow, and the sheriff fears that if the foreigners become intoxicated they will start trouble. That is one reason why the troops are being held in readiness for riot duty.

Similar Trouble in Pennsylvania.

Pittsburg, May 5 .- A mob of four undred striking miners, mostly foreigners, raided the strip of mines of the Clemms Coal company south of here. this evening and forced the miners there to stop work. They broke pumps and dismantled gas engines and threw the wreekage into the pits. Eight mines were visited by the mob. Americans are said to have led the foreigners. The union officials deprecate the action,

In this vast region there lies upon a subsoil of covaline limestone an immense accumulation of sand, alluvial deposits and decayed vegetable matter; forming a mass of sand and mud from two to ten feet or more in depth, that overspreads all but a few points of the first strata, Upon the mud rests a sheet of water, its depth varying with the conformation of the bottom which s very rough and irregular; seldom at try seasons is it greater than three feet. The whole is filled with a rank growth of coarse grass, eight or ten feet high, with a serrated edge like a saw, from which it obtains its name of "saw grass." In many portions of the Everglades the saw grass is so thick as to be impenetrable but it is intersected by mumerous and tortuous channels that form a kind of labyrinth where outlets present themselves in every direction terminating however, at long or short distances in impenetrable barriers of grass. The surface of the water is quickly affected by rain, which makes a rapid alternating rise and fall during the wet seson. The difference of level between highest and lowest stages of water is from two or three fect; the general surface of the Everglades is thus subject to great changes. Small keys are here and there met with, which are dry at seasons; there. are many such upon which the soil is very rich. It is thought that these


