The greatest concern at present is the rescue of the help- Little Doubt Remains That the less and the relief of the thousands of homeless. Stories of wild animals fleeing for safety side by side with human beings came in today, showing the desperateness of the conditions. Tales also came of mothers burned to death with babes on their breasts.

Six Towns in Ashes.

Every settler in the fire-swept district who has not been accounted for is certain to be dead, as there was no escape For a distance of fifty miles from Baudette and Rainey River west to Warroad, the woods were a solid mass of fire Sunday. Only charred remnants mark the sites of old Baudette, Spooner, Cedar Spur, Graceton, Pitt and Swift. Refugees report having seen many dead bodies in the roads.

Fallen Trees Obstruct Roads.

Rainey River, Ont., Oct. 10.-Searching parties started out this morning over the fire-swept zon., it will be days before all the dead can be reached, owing to the obstruction of the roads by fallen trees. One instance is reported of sixteen persons being saved by getting into a dry well and staying there until the fire passod. Many settlers saved themselves by wading Rapid river.





Men Entombed in Colorado Coal Mine Are Dead.

Starkville, Colo., Oct. 10.-As darkness settled tonight over the entrance to the Starkville mine, the hope that some of

the fifty or more men entombed there would be found alive grew faint. After a day of hard work, in the face of constant peril, the rescue party had penetrated nearly 12,000 feet or within 900 feet of the men imprisoned in the nearest main entrance. The workings were found badly wrecked and poisonous cases were encountered. The men were ordered out until the air improved. The state mine inspector believes that the rescuers will come upon the bodies tonight.

Valuation of Taxable Property Boosted \$545,000, the Increase All Being Levied Against the Townships, While Cities Were Put in Same as Last Year.

County Taxes About \$30,000 Higher Than Last Year, Because of Larger Appropriation to General Fund-State Taxes About \$21,000 Less Than in 1909.

At the annual meeting of the county board of supérvisors, held yesterday, valuations were equalized and taxes apportioned to each of the cities and townships in the county for the ensuing In equalizing the valuations the board showed a decided tendency to increases rather than reductions, and the taxable property of the county was fixed at \$27,373,000, an increase of \$545,000 over the past year.

The county tax budget is practically \$30,000 more than last year, the increase being due to an increase of that amount in the appropriation to the general fund. Last year and for several years previous the annual appropriation to the general fund has been \$\$0,000, which has been just about sufficient to meet the year's actual expenses. At the time the court house was built, however, the general fund was overdrawn about \$30,000 and with an annual appropriation of \$80,000 it has not been possible to make up this county officers were fixed at the same deficit. As a result, the general fund figure as last year. has become depleted about Oct. 1 of each year, and the county has been able to meet its bills only by an arrangement with the banks, whereby current bills were taken care of until taxes began coming in, about Jan. 1. By the extra appropriation of \$30,000 it is expected that the fund will at all times have enough to its credit to meet bills as they are presented.

The appropriations to the poor fund. to the county agricultural society, to the soldiers' relief fund, to the county road fund and for retiring court house bonds were the same as last year. The appropriation to the tuberculosis hospital fund amounts to about \$30 more than last year owing to the increased valuation of taxable property in the county.

State Tax Less.

The amount levied against Marquette county for state taxes is about \$21,000 less than a year ago, being \$83,175.42, as compared with \$104,294.13 in 1909. The reduction in state tax set against






