

El Paso, Tex., Wednesday, May 10.-The fire in Juarez has broken out anew at 12:15 o'clock this morning. The entire town seems to be ablaze.

El Paso, Tex., May 9 .-- What was perhaps the fiercest battle of the Mexican revolution was fought at Juarez, across the Rio Grande, today, but without result. Tonight both federals and insurrectos are resting on their arms, ready to resume the battle at daybreak.
