FAYETTE.—A friend furnishes us the following in regard to the Jackson Iron Company's furnace at Fayette:—"There are two blast furnaces, 9 feet high, 40 feet long, one of which has been in blast since July 24, and the other since Sept. 20. During the year ending Nov. 30, there was made 8,896 tons of iron, (an excess over the product of the previous year of 2,246 tons,) nearly all of which has been shipped.

The railroad about 3 1/2 miles long, is laid with T rail, weighing 28 lbs per yard, and is equipped with two locomotives, one the A. W. White, weighing eight tons, the other the J. C. Hicks, weighing 12 tons. Also 10 coal to wood, (dumping) and 3 flat cars.

Additional blowing power to be put in next spring, will enable us to increase the product 6 or 7 tons per day when both stacks are in full blast."
