MANY WILL WATCH ACTION OF SENATE

Much Satisfaction Expressed Today by Effort Being made by Congressman H. O. Young to Secure Appropriation for Government Building Here. Bill has Passed House and is now up to the Senate for Approval.

Much satisfaction is being expressed in the city today over the announcement that an appropriation of \$50,000 for the construction of a government building in Escanaba, is carried in the general omnibus bill presented to the national house of representatives on Monday.

Private advices received in the city last night from Congressman H. O. Young, to whom the credit for the Escanaba appropriation is due, were that the appropriation bill as reported to the house by the committee, had been referred to the senate for action.

The action of the upper house on the appropriation bill will be watched by the people of Escanaba, with much interest as on the action of that body now depends whether or not the dreams of many people of the city interested in the welfare of Escanaba, are to be realized by the construction of a large government building, or whether hopes have been raised in vain.

The original appropriation asked by Congressman Young for the construction of a government building in Escanaba was for \$100,000 and which amount was cut to \$50,000 by the committee when the bill was reported out.

The appropriation proposed for Escanaba will include both the cost of a site and of the building both of which details must be settled after the final action of the senate, if the appropriation is approved.

The construction of a government building in Escanaba will mean that all government offices in Escanaba, including the post office, weather observatory office, customs office, clerk of the railway mail service and United States post office inspector, would be housed in the new building and would be moved from their present quarters.

On all sides throughout the city today were heard many compliments for Congressman Young for the effort that has been made by him in securing for Escanaba an appropriation for a public building, in preference to other cities of the peninsula whose claims for recognition have been filed.

In addition to the appropriation for Escanaba Mr. Young had also asked for \$100,000 for both Ishpeming and Sault Ste. Marie but those items were not included in the bill when it was reported out by the committee.

Michigan appropriations provided for in the bill are as follows: Representative Bishop, Manistee, \$50,000; Representative Hamilton, Niles, \$40,000; Rep. W. A. Smith, Grand Rapids, secretary of treasury, authorized to dispose of present site of present postoffice and expend \$50,000 for new building; Smith asked for a \$750,000 appropriation.

Rep. S. W. Smith will receive \$25,000 appropriation for Flint. He asked for a \$100,000 appropriation for Pontiac and will receive \$15,000. Representative Townsend secured an \$80,000 appropriation for Ann Arbor, but lost out for Adrian.

Representative Load wanted \$100,000 for Adrian and will be given \$50,000. Representative Fordney put in a bid for \$25,000 for Owosso and the bill carries 20,000.

Representative Young had bills in appropriation \$100,000 for Ishpeming, and \$100,000 for Sault Ste. Marie but these items are not included in the bill.

Young's bill for \$100,000 for Escanaba was reduced to \$50,000. Representative Townsend's bill for a \$25,000 improvement to the Jackson building also failed to get into the bill. Representative Gardner secured an appropriation of \$25,000 for Coldwater building and Representative Load has in the bill an appropriation of \$50,000 for Alpena. He asked for \$100,000.

Representative McMorran, had a bill for \$200,000 for Mt. Clemens building, but it is not included in the bill. Senators Burrows has secured the passage of a bill through the senate appropriating \$10,000 for the purpose of a space of ground adjoining the Kalamazoo postoffice. This item undoubtedly will be added to the public building bill when it reaches the senate.

IMPROVEMENTS WILL BE MADE

Repairs to be Carried out at Many of the County Buildings as Result of Recommendations to Board.

Many improvements for different Delta county buildings are to be made at once as the result of recommendations made to the Delta county board of supervisors this morning by the building committee of the board and whose recommendations were accepted in full.

Following are the improvements that are to be carried out at once:

New tin roof on portion of court house to complete the tin roof now laid over a portion of that building.

New floor in boiler at court house.

Cement floor in basement room of court house 7 by 20 feet in dimensions.

Painting all woodwork on exterior of court house.

New fire proof fixtures for treasurer's vault and additional fixtures for clerk's office to cost not to exceed \$675.

Painting entire exterior of county hospital.

Repairing terraces on Sarah street side of hospital to prevent sand from spreading over sidewalk.

The members of the building committee of the board who will have charge of the improvements are Supervisors Perron, Miller and Hoyle.

A general slashing of bills presented to the county board was indulged in by the auditing committee who made their report at the forenoon session of today.

Nearly every bill presented to the board for caring for contagious diseases in the county was cut deep by the auditing committee in their report. Many bills for such services were presented and scarcely an account of that nature escaped the axe.

Other bills for different services to the county received similar treatment. The members of the board of equalization, composed of Supervisors Morrell, Devet, Call, Darling and Lattimer, began their work this morning and will probably not be ready to present a report before tomorrow.

Supervisor O. B. Fuller of Ford River township was named at the morning session of the board to represent Delta county before the state board of equalization at Lansing when that body meets in August.

In the event of Mr. Fuller being unable to go to Lansing at that time an alternate will be named by Chairman William Bonifas.

MUST ITEMIZE ALL CLAIMS

Board Adopts Resolution Affecting all Claims Against County Filed in Future.

By a resolution adopted by the Delta county board of supervisors today no bill will be allowed in the future by that body unless fully itemized and accompanied by a full statement as to the cause for the charges entered.

It will also be necessary for each claimant to certify to the legality of the claim before a regularly authorized notary public and to file the claim with the clerk of the board not later than three days before the opening of the session by the supervisors.

Many of the bills presented to the board at his session were indefinite and the members of the auditing committee encountered much difficulty in carrying out their work.

The passage of the resolution today, it is believed, will eliminate many of the objections that are made with the present rules in force.

TUBERCULOSIS WAS FATAL

Old Resident of Ford River Township Died Yesterday at Home Near Hyde.

After an illness of several months from tuberculosis Kasper Kleinbenz, one of the early settlers of Ford River township died yesterday afternoon at his home near Hyde.

The body was removed to the home of Peter Kleinbenz, a son on South Jennie street today and funeral services will be held from that place to St. Patrick's church at 9 o'clock tomorrow morning.

Mr. Kleinbenz was 64 years of age and is survived by his wife and one son.

He came to Delta county when a young man and settled near Hyde where he cleared a farm and had made his home continuously since that time.

He was well known to all residents of Ford River township and it is expected that many people from that place will come to the city tomorrow morning to attend the funeral service.

ARRESTED TWICE IN FEW HOURS

After arriving in Escanaba at 9 o'clock on Monday evening from Calumet where she had just been fined for disorderly conduct Dora Van Camp was arrested here at 12 o'clock on Monday night on the same charge and when arraigned before Judge Emil Glaser yesterday afternoon was fined \$5 and costs. Dora was accompanied in the celebration of her arrival in Escanaba by Mamie Boutelle, an inmate of a Thomas street resort, who was also arrested and who also contributed \$5 to the support of the municipal government when arraigned in court.

Belle Dunne and five inmates of a Thomas street resort charged with disorderly conduct, were arraigned before Judge O. V. Linden yesterday afternoon and each of the defendants contributed \$5.00 to the funds in the hands of the city treasurer.

HEAR OBJECTIONS TO ASSESSMENT

Council will Again Wrestle With Problem Presented in Building of Wells Avenue Sewer.

Members of the Escanaba city council will meet tonight to hear objections to eight special sewer assessments that have been levied in different parts of the city, and it is expected that objectors will be out in force as it is admitted that in at least one instance the assessment levied is exorbitant.

When objections were first heard by the council on last Friday evening property on the north side of Wells avenue from Norris street to the Lakeview cemetery appeared before the aldermen and pointed out that the entire cost of the sewer on that street had been levied against their property, owing to the fact that lots on the south side of the street faced east and west and were not included in the assessment district.

What action will be taken by the council to overcome the objection is not known but it is expected that the assessment against each individual property owner on that street will be reduced to average sewer assessment and the remainder of the cost of the improvement will be borne by the city at large.

MUST SPRINKLE THE PAVEMENT

Barber Asphalt Company says it is Duty of City to Arrange for Regular Sprinkler Service.

That the officials of the city of Escanaba, in order to prevent the asphalt pavement on Ludington street from being seriously damaged during the warm months of the year, by sharp short showers and heavy loads, must arrange for a constant sprinkling of the pavement is the advice received from the officials of the Barber Asphalt Paving company.

It is pointed out in the communication from the company that the city is expected to arrange for a regular sprinkling service as the frequent spreading of cool water over the surface at frequent intervals prevents a serious softening of the asphalt.

It is also pointed out that it is unnecessary during the summer months for horse owners to have their horses shod with shoes bearing heavy calks and that drivers and horse shoers wishing to prevent the pavement from being damaged will lend their aid in making all conditions as favorable as possible in maintaining the pavement.

GOOD BOATS GROW SCARCE

Heavy losses by gales and fires last fall have caused an alarming scarcity in steamers. This fact has just come very strongly before the officials of the Green Bay Transportation company, who have apparently secured every available source of supply in the country without being able to charter a steamer suitable to the use of the trade.

Manager Warren C. Schilling attributed the scarcity almost entirely to the recent losses on the lakes during the storms which swept with awful fury and did hundreds of thousands of dollars worth of damage. The company has since taking on the east bound traffic in conjunction with the Soo line at Gladstone, been in a position to use very conveniently one more boat, but after endeavoring to charter one for about two months the situation is much the same as ever.

A record season in the passenger and freight traffic on the Sault Ste. Marie run is expected by the company's officials this season.

Indications thus far are that the list of passengers will be a large one. Inquiries from parties in Milwaukee, LaCrosse, Oshkosh, Fond du Lac, Appleton and a large list of other cities in the state have been received regarding accommodations for the inaugural trip and for later ones.

Two steamers, the Eugene C. and the Fannie C. Hart, will be used on the Soo run, the former leaving Green Bay on Saturdays and the latter on Tuesdays. The first trip will be made by the Eugene, Capt. Charles E. Graves. The Fannie C. Hart will start her Soo excursions from Green Bay on Tuesday June 26.

ALL STORES REMAIN OPEN

Beginning with tonight and continuing until after July 4 all retail stores of Escanaba will remain open until 9 o'clock.

The agreement to remain open during the Fourth of July rush of business was reached between the store proprietors and the Retail Clerk's union and the rule will be in effect in all places of business throughout the city for the coming week.

When counsel for defense begins to plead that his client should not be punished because some other racial has gone free, he might as well admit in terms that he has a worthless case, and this is the only argument that can be urged against the infliction of prison sentences in rebuke and discrimination cases, for which the law provides such penalties. It is conceivable that Senator Elkins and his supporters, or some of them, were sincere in their belief that the abolition of the imprisonment clause would facilitate the obtaining of evidence, and thus contribute materially to the real object of the legislation—the eradication of the rebate. But the country, after three years of experience with that policy, is convinced that sincerity could be no proof of wisdom, and is much more inclined to sympathize with the view of Attorney General Moody that the only way to break up the business is to put the offenders in jail.

THE plain common sense of the situation argues powerfully for that conclusion. The men who do the things that the law forbids in the transportation business are not accidental or ignorant lawbreakers. They are deliberate and careful criminals who practice lawlessness with a lawyer at elbow. Their sole inspiration to offense is profit, and fines to be effective would have to be frequent enough and heavy enough to eliminate that consideration that leads to the infraction of the law.

The statement of the country has been rapidly educated of late, and we believe it is strong enough to back the administration and the attorney general even in the proposed campaign against the king of trusts, Standard Oil. In the campaign which Mr. Moody outlines, the government will have been enormously strengthened, both by the law enacted to correct the evil disclosed in the Humphrey decisions and even more so by the provisions

of the rate bill which is about to become law.

That the projected assault upon the Rockefeller citadel is not without public dangers must be recognized at the outset. Standard Oil has so entrenched itself in the staple industries of the nation and in the financial centers of the country, its ramifications are so numerous and its influence so vast that in a desperate mood it could undoubtedly inflict enormous damage upon the general public. The promises of a deliberately precipitated panic, with which voters were driven into the Republican ranks in '96 were mild, perhaps, compared with the widespread distress that such an organization as that described by Miss Tarbell could cause if it were driven to adopt the tactics of the blind Sampson in the temple; but the sound judgment of the people is convinced that the alternative is even more menacing. In the revelations of the past few months it has been demonstrated to the satisfaction of most of us that unless the practices that have been permitted to foster monopoly and extortion are sternly eradicated, the inevitable end will be infinitely worse than any temporary disturbance of commerce, industry and finance, however severe. If the "system" is already so strong that to attack it is to brave the menace of national disaster, it is clear that faltering and delay can only increase the difficulties of the situation. By the very nature of the powers against whose exercise the people feel compelled to protest, they must grow and expand with that exercise. To postpone action is to feed the monster to still greater proportions and potentialities, until his overthrow and restraint become an actual impossibility. If the contest must come it can never come at a time more favorable to the chances of victory for humanity.

BIG MONTH IS EXPECTED

Marine men are of the opinion this will be the busiest season in many years on the great lakes. The boats will have all the business they can handle up to the close of navigation. Ore is being rushed forward rapidly and the shipments of June are expected to reach 5,000,000 tons. This will be a new record for a month. The present record was made last July, when the fleet carried 5,234,619 tons. The big shippers believe 6,000,000 tons will be shipped in each of the next two months.

MARQUETTE IS IN LINE

Lake Superior County Falls in Line and cuts off Heads of Two High Salaried Game Wardens.

Two deputy game wardens of Marquette county drawing salaries aggregating \$1,800 a year from the county, went by the board at the session of the supervisors yesterday, says the Mining Journal. One deputy, Cass Downing of Ishpeming, was retained, and on him will devolve the duty of preventing violations of the game law throughout the county.

This action was taken following the reading of figures going to show that in comparison with other upper peninsula counties Marquette county supported an extravagant deputy game wardens' establishment. These figures were obtained by Clerk Elliott from the various other U. P. county clerks, in accordance with the instructions of Chairman Trebilcock.

The returns from the various counties were as follows:

Alger—No deputies and no compensation whatsoever for securing convictions in cases of violations of the game law.

Baraga—One deputy, drawing a salary of \$50 a month.

Delta—Three deputies at \$200 each per year.

Dickinson—No salaries. Nor will there be any while the state continues to get all of the non-resident license fees and five-sixths of the resident hunters' fees. Under such a condition it is the opinion of the county board that the state should defray all the cost of protection.

Houghton—One deputy, drawing a salary of \$75 a month and expenses.

Menominee—No deputies. State Warden Chapman recently removed an official appointed in January this year. Previous to that date there had been no deputy for about a year.

Never more than one deputy was employed, and the remuneration has been the county's share in the door license fees, which was \$39.50 last season.

Ontonagon—One deputy, \$65 a month.

Schoolcraft—One deputy, \$100 a year and \$2 a day and traveling expenses during time of active duty.

The column of deaths falls far short of exhibiting the mortality consequent upon the careless handling of explosives on the Fourth of July. A large proportion of the mortality from accidents with explosives follows lock-jaw, and that takes several days to develop.

Let the Fourth be celebrated but let it be celebrated sanely. Fireworks belong to the Fourth as surely as the turkey is identified with the secular part of the observance of Thanksgiving; but the fireworks used should be of the safe kind and they should be handled with due precaution.

There are ordinances in regulating the sale and the use of fireworks. These ordinances should be strictly enforced.

CLAIM GIRLS WERE ENTICED

Startling Evidence That White Slave Traffic Exists in Escanaba was Unearthed Yesterday.
 Startling evidence that white slave traffic exists in Escanaba on a large scale was divulged yesterday afternoon when Mrs. Ida Secor, keeper of a resort at 517 Thomas street, was arrested charged with enticing girls under the age of 18 years to a house of ill repute.
 Similar evidence against other resort keepers in Escanaba is being investigated by the officers and additional warrants may be issued.
 In the complaint on which Mrs. Secor was arrested late yesterday afternoon it is alleged that she enticed Stella Carafel, 16 years of age, to her place on Thomas street and the girl remained until freed by her father, Eugene Gerald, of Gladstone on Monday afternoon.
 After being taken before Judge O. V. Lindes yesterday afternoon and confronted by her parents and Asst. Proc. Atty. A. W. Norblad, the girl made a complete confession and signed the complaint against the resort keeper.
 A warrant was at once issued against Mrs. Secor and when arraigned in court she was represented by Atty. John Power who asked that a continuance of the case be given.
 The request was granted and the case was continued until 9 o'clock on Thursday morning. The bail for the defendant was fixed at \$500 and was immediately furnished by F. V. Gronlaw.

The complainant, who had first been arrested charged with being an inmate of a questionable resort, on complaint of her step father was returned to the county jail, where she will be held pending the hearing of the charge against Mrs. Secor.
 In a cell at the county jail adjoining that occupied by Stella Carafel, Barthelemy L'Fleur, another Gladstone girl, who it is believed is below the age of 1 year, and who it is claimed was enticed into a house of ill repute in Escanaba, is confined. While the girl remains there she is 18 years of age, a complete investigation will be made by the officers and if facts are

found to substantiate the suspicions held by the authorities another warrant will be issued. The father of the girl is employed at Northland and he has been notified and will arrive in the city late this afternoon to aid the officers in the investigation.
 Sobbing bitterly and apparently just beginning to realize the disgrace that had been brought upon them the two girls were returned to their cells at the county jail yesterday afternoon, following their appearance in court and continued to weep for two hours. Both continually protested that they were ready to tell of the story of their downfall if they should be released.
 The two girls have innocent appearing faces and as they wept copiously in the court room yesterday before the woman, whom one has claimed had caused her degradation, an intense feeling against the keeper of the resort was aroused.
 For some time it has been suspected by the authorities of Escanaba that young girls had been enticed into a life of shame by resort keepers of the city but until in the present instance, confirmation of those suspicions could not be obtained.
 If evidence can be produced to substantiate the charges in the complaint filed against the resort keeper now under arrest, the case will be pushed to the full limit, with the hope that if such practices exist here they may be stopped at once.

ITS HISTORY IS INTERESTING

"I don't know of a fraternal order in the world that has a more interesting history and origin than that of the Knights of Maccabees," said Robert J. Hauerwas who was recently a visitor here. "If we go back 2,000 years we find living along the eastern shores of the Mediterranean, in the valleys of Jordan a people most unique. Their origin was in a past already remote and their entire history is dominated by their religion. At one time a great king, an enemy of the chosen people overcame them. Some of the meanest of the nation, hoping to gain the favors of their conquerors offered to participate in the heathen rites.
 "One Mathias, refusing to be a traitor to his country, gathered about him an army and resisted the king. But his reign was short. An old man, he could not long endure the privations he had to endure. Lying upon his deathbed, he anointed his son, Judas Maccabees. His followers combined the initials of the words, 'Me Gamoca Eluim,' forming the word Me-ka-be, and Judas became Judas Maccabees."
 "The war was long and bloody and many of the faithful fell and their bones were left without a protector. And that the widows and the families who were left husbandless and fatherless should not want, it was ordered to set apart from the spoils of war some portion to be used for the support and maintenance of those who had been left without a protector.
 "The Knights of Maccabees have taken this history as a basis for their organization name. The organization has since been reorganized, of course, but on the anniversary of the day when this provision was made by the king of Israel, the 'Knights of Maccabees' were founded."

A short time ago she took up her abode in a cottage at Saint Mandé, with a male friend with whom she had formerly lived, and who, on his return from Africa recently, had sought her out

and found her. After dining with him one evening last week she went out, saying that she was going to a little party which some acquaintances were giving in Paris, and at two o'clock next morning she was noticed passing through the Saint Mandé gate on her way back to her dwelling.

The woman went along a broad and, at that hour, deserted avenue, running parallel to the fortifications, and soon afterwards a pool of blood was perceived by a lamplighter on the pavement. Following the ruddy track the man turned a corner, about fifty yards from which he found a corpse lying in a street adjoining the avenue. The body had been divested of most of its clothing, including corset and stockings, and there was a terrible gash in the neck.

The lamplighter hurried off to the police at Vincennes, who arrived promptly on the scene of the tragedy, and soon afterwards the corpse was identified by a publican, who gave the address of the friend with whom the unfortunate young woman had been living. The friend, who had retired early to rest, and was sleeping soundly when the police called at his cottage, lost no time in accompanying them to the spot, and he quickly noted that, besides the clothes which were missing, a purse containing a considerable sum and some jewelry, which the murdered woman invariably wore, had been taken.

Though the police have worked diligently on the case they are still in the dark as to the identity of the murderer or murderers. No suspicion attaches to the friend of the woman as he succeeded in satisfying the authorities as to his movements on the night of the crime. One theory is that the crime may have been due to a desire for revenge on the part of some former acquaintance of the victim. But the neighborhood in which the murder occurred is so dangerous at night that it is thought quite probable that the woman may have been killed only for the sake of what she might have about her.
