Had Been Brooding Over Loss of His breast. Leg and the Pain That Followed Many Operations

Brooding over the loss of his leg and while temporarily insane Clinton Roy Morris, son of Mr. and Mrs. John J. Morris of 500 South Sarah street shot himself at seven o'clock Saturday evening, just above the right temple, and died an hour later without regaining consciousness,

The suicide occurred in the living room of the Morris home and in the presence of the youth's mother, who knew nothing of his intent until she heard the report of the revolver and turned to see her son unconscious with the blood flowing from a wound above TWO BURIED IN ONE CASKET his temple.

Saturday's deplorable suicide was the direct result of a shooting accident of two years ago. The boy, then nineteen years of age, accidentally shot himself in the left leg. After the wound had healed he fell from a wagon and broke the limb. Complications resulted that necessitated amputation and since that time he had undergone a series of operations. No less than fifteen times he had been put under the influence of an anaesthesia.

A month ago he secured an artificial limb and the stump of his leg had been giving him great pain since that time. Saturday morning he came to Escanaba from his father's farm, which is near the Danforth settlement, in his usual spirits. In the afternoon he complained to his mother of his leg hurting him and later he grew decidedly melancholy. Statistics show that ore shipments from Escanaba during the month of April 1913 were nearly three times as great as during the corresponding month of 1912. Although the season of 1912 was a record breaking one the shipments this year began earlier and the manifest difference in the shipments is due in the main to that fact, although the indications are that the total shipmens for 1913 will exceed those of the past years.

of Young. "'I am now convinced,' he said that if the 458 votes in dispute were counted for the contestant the verdict would not be in my favor. I am convinced that those 458 electors intended to vote for William J. MacDonald, and, while under the law he is not entitled to those votes, I do not care to hold a seat that may be questioned by honorable and disinterested men. I therefore have prepared my resignation and will forward it to the secretary of state of Michigan and will file a copy

with the speaker of the house." "Representative Hinebaugh of Illinois offered the resolution, declaring that MacDonald was rightfully elected and that Young had been given the

certificate of election on a technicality. "The Democrats and Republicans ombined and ran the steam roller

COMES TO RESCUE OF

Thinks Dogfish One of Finest for Eating.

A great many Escanaba fishermen who use dogfish minows for bait during the season little realize that by some the dogush is looked upon as one of the finest fish in the world for eating and that when properly 1399-tf. | prepared are a very delectable dish. Commissioner of Fisheries George

W. Miles of Indiana, has come to the defense of what he calls "the humble doglish" in a long article, which is copied verbatim in the twentieth biennial report of the Michigan Fish Commission. The waters of the various lakes in this country abound with dogtish but they have always been scorned by the sportsmen who could see no glory in its pursuit. The Indians always ate the dogfish and made use of them almost to the exclusion of all other fish. This was probably due to the fact that it was the easiest to secure and would bite at any kind of bait, alive or dead, being naturally a very stupid fish. The fact that Indians also cooked dogs and relished them also had something to do with the natural prejudice that has arisen against the dogfish.

The dogtish has an air bladder that is divided toto cells, and is a halfdeveloped lung. At intervals it ascends to the surface of the water, gulps down a mouthful of air as a turtle does and descends again. If hindered from arising when the time comes to take in a fresh supply of air, the fish struggles violently, like a mammal about to drown; but it can expel air beneath the surface. this characteristic indicates that lungs were first developed in fishes from modifications of their air bladders. Mr. Miles states in his article that he has never seen a colored man in the south or a white man in the north who has eaten of the flesh of the dogfish that has been properly dressed and cooked, and admitted the flavor of it to be as fine as that of a bass or a pickerel, which later it must resemble. If the dogfish were as popular as

some of the other varieties which are sought, the lakes and streams in this vicinity could be planted with them and in a few years would be well stocked. The dogfish propagate very rapidly and are very hardy. Many people who have tasted dogfish have condemned it because of the fact that it had a "mossy" taste. This unnatural flavor is due to the fact that pared. To properly prepare a dog-Hirn's Bakery and Charlotte St., fish for the table, it should first be skinned, the skin being very tough is to skin from the tail toward the head. The head and tail should be removed and the ribs separated from the backbone, both being cut out. The flesh is solid and firm and is of a reddish color. It should be coated with flour or cornmeal and cooked in hot grease much the same as doughnuts are, and nearly as brown.







FLINT'S LETTER

For the first ten days this month exports of copper have exceeded thirty million pounds. There is no indication at present of any concerted action to curtail the production so that it is very difficult to understand how anyone can take anything but a favorable view of the future of the copper industry.

A dispatch from Ely, Nev. says that Giroux is shipping one thousand tons of ore to the smelter each day and that if the Nevada consolidated could give them more than one unit they could increase their shipments materially. The copper stock market has been so dull lately that the majority of traders have switched over ot the Tonapohs, which have been quite active for the jast month.
