"The House Speaker"

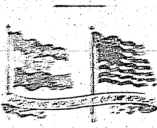
The House Speaker, Charles G. Dyer, has announced that he will not be a candidate for re-election next year. He has been in the office since 1919 and has served four years of his term.

His successor, James H. Doolittle, of Michigan, was elected on Monday, January 14, 1924. Doolittle is a member of the Republican party and has served in the House since 1911.

The Speaker's office is located in the Rayburn building on the north side of the Capitol. He is assisted by a Clerk of the House, a Chief Clerk, and a Secretary.

The Speaker presides over the House and has the right to adjourn it, subject to the concurrence of a majority of the members present. He also has the right to suspend the rules of the House and to order the yeas and nays taken on any question.
