Blumrosen Bros. Opening.
 Blumrosen Bros. commenced removing their stock of goods from their old stand in the Williams block, into their fine new store on Ashmun street, this week. In addition, load after load of new goods has been received from the depot, until the interior of the mammoth store at present resembles a huge warehouse, packed to the ceiling with boxes of every description and size. Order is being brought out of chaos rapidly, however, and if it is possible the handsome new store will be thrown open to the public with the advent of prosperity, March 4.

The building is located opposite the city hall, on Ashmun street, and is in the heart of the business section of the Soo. It consists of one story only, but that story is a 'whale' as the building has a frontage on Ashmun street of 60 feet, the largest of any in the city, and is 100 feet in depth. It cost, with the ground \$10,000. The interior has a ceiling of 10 feet in the clear. There are three front entrances to the store, and four display windows of ample proportions. The store in its entirety is a highly creditable accession to the business portion of the city. The interior arrangements are handsome and convenient. The south side of the room will be devoted to dry goods, ladies' furnishings, and the thousand-and-one nic-nacs dear to the feminine heart. The central portion will be the boot and shoe department, and a complete line of those goods will be carried. The clothing department will occupy the north side. Extending across the rear of the room is a gallery 24x60 feet, upon which will be displayed a fine line of carpets, the finest obtainable. Access to this department is gained by a broad stairway at the center. When it is remembered that this gallery alone in dimensions equal to a good-sized store, it can be readily seen that there is sufficient space in which to display a large line of goods to the best possible advantage. Underneath the gallery will be the cloak department. The fixtures, with the exception of some of the showcases, are all new, and in every way of a quality in keeping with the splendid store. It will be lighted by electricity.

Blumrosen Bros. located in the Soo in 1895, embracing in business in Pease & Lipsett block. The firm is composed of B. and M. Blumrosen, and has been engaged in the dry goods business at Manistique for years, as well as at Ashland. The latter branch, which B. Blumrosen managed, was discontinued when the firm opened here. B. Blumrosen being in charge of it. At the end of the first year's business here the firm was unable to make satisfactory arrangements for a renewal of its lease, and was compelled to move into other quarters, which were secured in the Williams' block. The room was small, and entirely inadequate for the business, but no better could be found. Then it was that Blumrosen Bros., having abundant faith in the future of the Soo, decided that they would build them such a home as they needed. With characteristic enterprise and hardy arrangements to that end were quickly made and consummated. The result is now before the people, as well as Blumrosen Bros., may feel pardonable pride.

Both of the Messrs. Blumrosen will be at the store here. While the Manistique branch will still be run, the active management has been placed in other hands.—Soo News.

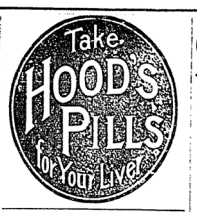
The store of Schuman & Horwitz in the Northby block, Hancock, was closed yesterday and a sign on the door stated that it was for the purpose of taking inventory. On February 18 the firm filed a chattel mortgage on the stock and fixtures of \$4,045 Abraham Mendleson, of Hillman, Mich., and the mortgage made preferred creditors of half a dozen others, the majority of whose surnames is Schuman. Several Chicago firms, creditors of Schuman & Horwitz, but not protected by this mortgage, have retained Messrs. Gray Loomy to look after their interests and the mortgage in question will undoubtedly be attacked on the ground that it was given to defraud certain creditors.

Schuman & Horwitz opened up in the Northby block only a few months ago in the merchant tailoring and ready-made clothing business. A short time after they advertised their stock of ready-made clothing at a sacrifice, as they were going out of that branch of the business. They sub-rented the store they occupied from Jacob Gardner, who is the lessee from the owner, Northby—Calmnet News.
