THE BUFFALO MAY YET BE SAVED.

The American Buffalo, now on the verge of extinction, has a champion in C. J. Jones, better known as "Buffalo Jones," who is proprietor of the largest and finest buffalo farm in the United States.

Mr. Jones established his farm in order to prove by practical demonstration that the buffalo could be propagated and that under proper conditions would thrive and increase. Speaking in this connection in a recent interview, Mr. Jones said:

"Little from purely sentimental considerations, there is every practical reason why a determined effort should be made to save the bison, especially when such a hope is so entirely feasible and can be readily accomplished. The few productive possibilities of a few bearing animals must be considered, and that soon. We Americans are a wasteful people. Nations have endeavored to grow up lazily with everything they could get their hands on, and we have got into the habit of throwing away that which we shall surely need in a few years from now. crossed with domestic cattle. The robe of the buffalo is valuable as a garment because it makes a seamless coat, while the skin of the seal must be pieced interminably.

No doubt it took several ages to bring up this wonderful animal and to fit him for existence in his peculiar home. "The buffalo, despite his power and great size, is extremely nervous and like plenty of room and immunity from molestation at the hands of his human beings. Uncle Sam has millions of unoccupied land admirably adapted to the purpose, and I am certain that a fair sized section were devoted to buffalo raising under the systematic care of trained experts the result would be more than conspicuous, viz., the ox."

We began with only three calves and a small herd consisting of seven cows and four bulls.
