FOOTBALL GAMES ARE ON

The Sport Is the Main Subject of Conversation Among College Students.

MICHIGAN WILL HAVE A GOOD TEAM

President Adams, of the University of Wisconsin, is an alumnus of the university at Michigan. The football clubs are meeting at the University of Wisconsin.

Football practice which is being carried on daily with all the men who are desirous of winning a place on the Michigan eleven is receiving a great deal of attention from the student body. Large numbers of men and women go to the athletic field each afternoon to cheer the players. Two teams are made up from the candidates for the varsity eleven and these are sent against each other. One team is composed of the very best men, and for convenience is known as the varsity; the other team comprises the next best lot of players and is called the reserve team or scrubs. Of course the varsity wins in all these contests, but they have to work to do it and it is just these efforts that give them the strength and experience with which to contend with the teams from the other universities.

Large Contributions. Nearly \$2,000 has been voluntarily contributed by the people of Ann Arbor, the university professors and the students. The subscriptions are in amounts from ten to one hundred dollars, the latter amount being given by each of five different families.

President Adams, of the University of Wisconsin, who has resigned, is an alumnus of the U. M. He was graduated from the University of Michigan as a bachelor of arts in 1865 and the following year took his master's degree. Since then he has taught at the University of Wisconsin, Chicago and Harvard have conferred upon him the degree of doctor of laws. He was made instructor of history at Michigan the year following his graduation as a master of arts and continued as an instructor in the same subject until 1885, when he was made assistant professor. In 1887 he was given the chair of history in the institution, and filled it until 1888, when he resigned to accept the presidency of Cornell university. He served but a short time there when he was called to Madison, Wis.

Woman Rejoins a Suit to Recover the Site of New Buffalo, a Berrien County Village.

Mrs. Bronson, of Packard Station, 13 miles south of St. Joseph, has filed claim on all the land now covered by the village of New Buffalo. Mrs. Bronson claims her father, Adam Smith, was the first white man who settled in Niles. The house was built on old Indian reserve in 1837. In 1850 Smith bought a considerable tract including 140 acres, which now is the site of New Buffalo. Smith purchased the land in wildland times and received a land patent from the government.

He died very suddenly and his affairs were taken in charge by the executor of his estate. Since then no records of the transfer of land from Smith to his heirs have been made. The claim is that the statute limitations does not run against county tenants; that the heirs of Adam Smith are sole owners of land and that their rights have not been jeopardized by any transfers of real estate made since Smith's death.

The annual meeting of the State Federation of Women's Clubs will be held in this city October 29, 30 and 31. A many of the members of the federation will be from the various colleges and many of the college girls belong to the different clubs. This is the first time since the federation was organized that so many delegates from outside of the city are expected.

Debatable Schedule. The schedule for the intercollegiate debates has been arranged. Three big debates will be held. The first will be with the representatives of Northwestern university, the second in Chicago with the winner of the debate between the University of Chicago and Michigan. The third debate will be in Philadelphia with students selected from the University of Pennsylvania.

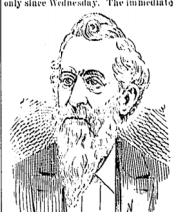

'MORMON LEADER DEAD.

President Lorenzo Snow Passed Away Suddenly at Salt Lake City, Utah.

Salt Lake City, Oct. 11.—Lorenzo Snow, 81st president of the Church of Jesus Christ of Latter Day Saints, died unexpectedly at his private residence, the historic Beehive house, at 2:35 o'clock Thursday afternoon, after an illness that has been serious only since Wednesday. The immediate cause of death was apoplexy.



Lorenzo Snow was born in Vermont in 1812. He was a member of the church since 1833. He served as president of the church from 1870 to 1898. He was a prominent leader and a man of great influence in the church.

Such, in brief is the history of this association, and it stands for the promotion of beauty, and cleanly living in all parts of our land. It is ready to aid in the promotion of good roads to see that the streets are kept neat and attractive. To make reasonable, but exact rules for good sidewalks, planting of trees, forestry laws to make rules for the preservation of natural beauty and historic landmarks. It will work to have no pollution on streets and to aid in bringing to the attention of tourists, the beauty of our rivers, brooks and springs. It will try to create interest in favor of public recreation grounds in improving and beautifying cemeteries, making them places of such beauty that one instinctively feels entering the grounds; that those resting there have a beautiful place to wait in until the late afternoon.

It is interested in traveling libraries and art galleries and to bring into the humblest home the joy of blooming flowers.

How can we say all this is brought about? We answer, by the formation of an Improvement Association in every city, town and village in America. To get people interested enough to form one we must talk about it to our friends, distribute copies of "The Work of Your Improvement." This will tell what is being done in other places. Some one, feeling very much interested could invite the people of her neighborhood to get together and evening to talk it over. Invite the editor of her paper. If there is a family in the neighborhood, particularly untidy, invite her and all members of the family, parents, and treat them to tea, you yourself. You may find that they will take a heartier interest, and do more work than many whom you would naturally expect to help you.

It is very important to win people's interest without their cooperation. The premises will be a continual eye sore, after the improvement begins to be noticeable and their children may destroy your shrubs and plants. They more than make up to us as the bottom of every all cutting of shade trees, and pulling up of flowers. If she cannot get the parents to come, get the children by one, give them flower seed, show them how to care for them. You will win them in time.

The needs of communities differ so greatly, that each association must decide for itself, that which the town most lacks, to make it beautiful and healthful.

New Associations would do well to concentrate, the little they will be able to do at first. Pat in order the most offensive and unsightly places first, and whatever you do, do it so thoroughly that it is noticeable and keep it so. Do it carefully, be careful about making enemies. Let the village officials know and feel, that you mean to work in harmony with them.

CHEAP STATUETTES.

HOW THEY ARE MADE, HARDENED, FINISHED AND COLORED.

Italians From Tuscany Excel the World in Their Production—The Demand For These Facts That Castor Oil For the Schools.

While it is not difficult to secure good American workmen for carrying out schemes of interior decoration, it is impossible yet to get native workmen capable of modeling statuettes and busts such as are sold on the street corners and in many of the art shops. All the best work is done in factories that produce these are Italians, chiefly from Tuscany. This is especially true of those who follow the trade in their many and France. The Tuscans appear to have a natural ability for that sort of work that has given them the monopoly of it.

The great majority of these busts and statuettes are copied directly from the originals, however they happen to be made and then the molds are made from that copy and sent to all parts of the world, the artist being sent to the place where they are to be sold. In the larger shops in New York city, however, a certain amount of original work is done in order to keep pace with the popular demand for representations of the hero of the hour. A great many of our most distinguished poets, authors and statesmen whose busts are exposed for sale on the street corners never see the light of day.

Some merchants model the bust after a photograph and occasionally has produced such good work that it is almost indistinguishable from the original. The sculptor's name should remain unknown.

The chief purchasers of these casts from the larger waters are the great schools all over the country. They demand, of course, not only classical subjects and copies of ancient bas-reliefs and architectural details, but also busts of famous men and women from every period of the world's history. Such a wide range of subjects is covered by this demand that seven and eight thousand titles are included in some of the catalogs issued. The factories where these figures are turned out exhibit in their showrooms an assortment and confusion of line, size and nature being withering to look at.

The process of casting these statuettes is a comparatively simple one when the mold is once completed. The material used, plaster of paris, is chosen of a very excellent quality to produce in this country. The figures are carefully removed, and then the cast is placed in an oven heated at about 120 degrees. After it has been baked for a certain length of time it is plunged into a solution of stearic acid and kept there until thoroughly set. Then, when it has dried, the yellow color is gained by applying to the surface a solution of lacquer, turpentine and coloring matter. This color will not wash off, and, of course, any stucco can be produced at will.

"The demand for made statuettes in the art schools is growing less every year," said one of the largest makers of these casts, "it is because people are reading more and more that artists must draw from the human figure itself if they wish to understand the human form. We get more orders now for draped figures in the art schools and for busts in the high schools. We very recently had orders from one of the celebrated American writers who had been made in Italy from photographs sent over from this country, and many mistakes occurred in matters of detail, the use of the coats and collars. We are trying to see how now a more modern and characteristic way and occasionally have been furnished with photographs by their families."

The statuettes which are carried about the streets wrapped in harmonious yellow tissue paper or are displayed on the sidewalks or on the steps of unoccupied houses are made by quite a different set of manufacturers. The larger dealers do not sell to these street peddlars at all. The peddlars have their own little warehouses, which furnish them with their stock at a much lower rate than the regular dealers charge. No originals are made in these shabby and most of the models are copied by taking them from a cast bought from some other firm. This stucco end both is left out of the process and consequently the color of these cheap workies wastes off.

The peddlars of these statuettes stand in about the same relation to sculptors and sculpture that the band organ plays to music musicians. They are, in fact, fairly accurately the popular taste, and according to their testimony, it is the Tuscan figures that is the long run sell the best of all these stock. From time to time there is a market for the best of some particular man, and these figures are always temporary. Brought figures are always in demand and copies of the various models of Venus which the public are familiar with. Of Cupids and of boys' heads, winged Victories and buds of Wagner come into the popular favor. But the Tuscan figures have a steady sale that insures their presence in the stock of nearly every street peddler in New York City.

An abstract of bids No. 12 and 13, bids 3, in District No. 4, add, was presented and the same referred to the City Attorney to investigate regarding the title to the property, and if the Attorney held the property to be all right that the Mayor and the auditor should purchase said property and to make deed of same and forward it to Mrs. Dan, Ragle Lake, Wis., for signature, which was carried by unanimous vote.

Moved, supported and carried that the clerk be authorized to draw an order for \$50.00 for Chas. Bunko and charge the same to his account.

A petition of two taxpayers and real estate holders, petitioning the tapping the tile at the corner of Walnut and Lake streets was read. Moved, supported and carried that the Mayor be granted them, provided that the tapping does not interfere with the water discharge of said work.

Bills for the unpaid fund to the street commissioner amounting to \$475.20 and in the highway fund to the amount of \$238.12, were audited and on motion of Ald. Benson and supported by Ald. Schneider were allowed by unanimous vote.

Smallpox bills were audited and on motion of Ald. McNeil and supported by Ald. Wickwire were allowed and referred to the board of supervisors.

The street commissioner's monthly report was read and on motion accepted and placed on file.

A petition that was laid on the table until this meeting in reference to have a well drilled or near the school east of Hoffman Add. was taken into consideration.

Moved by Ald. Schneider and supported by Ald. McNeil that the petition be granted them and a well drilled on Hoffman Add. which was carried by unanimous vote.

The council on motion adjourned.
