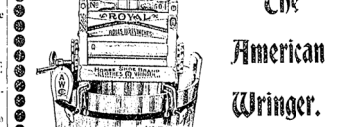

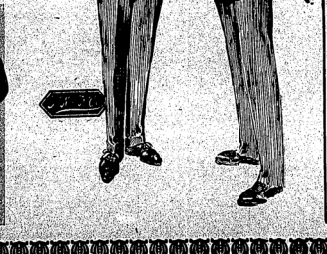

IRRIGATION BILL

MEASURE TAKEN UP IN THE HOUSE UNDER A SPECIAL RULE.

MUCH OPPOSITION DEVELOPS

Eastern Members Argue That It Will Benefit Certain States at the Expense of Others and Should Be Defered—London Dock Charges Bill Under Discussion in the Senate for a Time.

Washington, June 13.—When the house met Mr. Ray (N. Y.), chairman of the Irrigation committee, introduced the unanimous consent that Monday, after the consideration of bills under suspension of the rules, and Thursday he will report on the bill to amend the reclamation act. There was no objection and the order was made.

Mr. Daboll, from the committee on rules, then presented a special order for the consideration of the senate reclamation bill, one day for general debate and one day for amendment under the five-minute rule.

Pending the adoption of the rule Saturday was substituted for Friday for the consideration of private pension bills and the order setting aside Sunday, June 25, for general debate on the life and character of the late Representative Clarence M. Dixon of New York, was modified so as to extend to the end of that day in order to permit eloquence upon the late Representative Otis of New York.

Mr. Robinson (Ala.) opposed the adoption of the rule for the consideration of the reclamation bill. He declared that it would be beneficial to the arid land but would be detrimental to all others. He criticized severely the action of the Democratic congress and the committee in the resolution favoring the irrigation bill.

Mr. Underwood (Ala.) favored the adoption of the rule. He argued that the arid land states were to be benefited by its irrigation.

The resolution then was adopted without division. The house resumed itself into committee of the whole (Mr. Murray Minn.) in the morning and entered upon the consideration of the irrigation bill. It was arranged that Mr. Mendenhall (Wyo.) should read the time for the measure, and Mr. Ray (N. Y.) explain it.

Mr. Mendenhall admitted an extended argument in favor of the bill. The amount of land which is irrigated is estimated, he said, between 35,000,000 and 75,000,000 acres. He said that in his opinion the reasons why the states could not undertake the work. The wisdom of the national aid in the reclamation of the arid lands of the West, he declared, had been demonstrated to both political parties in national conventions assembled.

Mr. Ray (N. Y.) opened in opposition to the bill. He declared that the irrigation of the arid lands was not a national undertaking, but a local one, and should be left to the states. He said that the bill proposed to take the proceeds of the sale to develop one section of the country.

NOW BEING TABULATED.

Taylor, a clerk in that department who was employed on May 1st, 1910. The resolution was referred to the committee on civil service.

CAUSING SERIOUS DELAYS.

Wreck of the International Railroad at Sault Ste. Marie, Mich. June 9.—The wrecking of the International railroad bridge at Sault Ste. Marie, Mich., has caused serious delays in the movement of goods across the river. The damage to the bridge is estimated at \$200,000.
