DIED AT DETROIT

Mrs. Florence Friedman Passed Away Last Sunday Evening at Hospital

LEAVES INFANT DAUGHTER

Highly Regarded Here, Where She Spent Practically Her Whole Lifetime

Mrs. Florence Blumrosen Friedman of Detroit, died at Grace hospital in that city last Sunday night at midnight, after a very short illness with blood poisoning. The news of her death came a pall of gloom over this community for she was well known and highly respected by practically every resident of the city.

The deceased was the eldest daughter of Ex-Mayor and Mrs. Blumrosen, and was born in this city nineteen years ago. She spent practically her whole lifetime here, save the past three or four years, when her parents moved to Detroit.

About a year ago she became the wife of Mr. William Friedman, of Detroit, a member of the firm of Friedman & Smilansky, attorneys. Three weeks prior to her death she gave birth to a daughter. Her condition was so favorable that her father left Detroit for Traverse City, the Soo and Manistique. When he reached Manistique Friday evening he received a message informing him that her condition was serious. He left for Detroit the following morning and her death occurred Sunday night as stated above. The funeral services were held from her late home, 151 Garfield Ave., Detroit, Wednesday afternoon at 3 o'clock and the remains were placed to rest at Beth Olam cemetery of that city.

Messrs. and Mesdames L. Resenthal and Sam Winkelman of this city, attended the obsequies. The deceased was highly regarded by all knowing her, and her death coming at a time when least expected and when life, to her, was taking on its brightest hues, is sincerely regretted. The bereaved husband, daughter, parents and immediate relatives have the sincere sympathy of all in their bereavement.

MRS. ORR DEAD

Her Demise Occurred this Morning at Four O'clock at Home of Son

WAS 87 YEARS OF AGE

Had Been a Resident of this City for the Past Seventeen Years. Was Highly Respected.

Mrs. Robert Orr died at the home of her son, Walter L. Orr, at four o'clock this morning. The deceased would have reached her eighty-seventh milestone next Monday night. She lived and her death may be attributed to old age. During the past two weeks she had been confined to her room, and her death was not unexpected.

The deceased was born in the state of New York and resided there until about twenty years ago, when she and her husband moved to Manistique to spend their declining years with their seven sons who had preceded them to Manistique. She became the wife of Robert Orr about seventy years ago, the latter dying ten years ago.

Mrs. Orr, or "Grandma Orr," as all called her, was universally respected by all knowing her. She was a lady of deep religious convictions, was an ideal mother, friend and neighbor. She was a life long member of the Methodist denomination.

Seven sons survive her, all of which are residents of this city. They are: George H.; Aaron, Albert, Ernestus, Burton, Walter and Fred.

LOSS FROM FOREST FIRES

Chicago Lumbering Co. Suffers Heavy Loss This Week in Vicinity of Scott's Camp.

Fire has been prevailing in the vicinity of Scott's camp during the past week and the loss occasioned is heavy. The Chicago Lumbering Co. is a heavy loser. A tract of territory five miles wide has been swept over and included in the loss is 1,000 cords of bark. Mr. Chas. R. Orr took all of the available men in the city up the line Tuesday morning to fight the fire.

Schoolcraft county has sustained its heaviest loss from forest fires in July, during the present period of drought.

HIVE TO BE INSTITUTED

L. O. T. M. Hive Will be Instituted Here Next Week.

A Hive of the Lady Macabees of the World will be installed by Mrs. Corn Sunday of Buchanan, district deputy commander for the upper peninsula, at the K. of P. hall, Thursday, July 14. The charter list will then be completed. The Hive is an auxiliary of the Macabees of the World, organized here last fall.

The Lady Macabees of the World was instituted some seventeen years ago, now has over 145,000 members, has fully four and half million dollars in its treasury and is doing business in fifty four states and provinces. It is the first organization controlled exclusively by women at rates under sanction of the fraternal congress. The first Hive was instituted in the upper peninsula some eighteen months ago and the district now numbers over three hundred members.

The Tents and Hives of the peninsula are now planning for a big rally at Marquette July 29th, at which time the largest portion of both organizations will attend. It is expected that several supreme officers will be in attendance at the rally. The reunion, without doubt, will greatly stimulate both branches of the organization.

YOUNG HERE

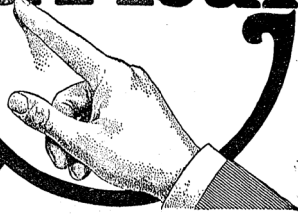

The local politicians are busy conducting a quiet campaign for their respective favorites and some lively arguments are heard. Among the names mentioned for the office of governor none is more prominent than that of Chase S. Osborn. The latter has a host of admirers here and among the warmest is Mayor Wm. D. Glanville.

Mr. Freeman, who was a guest of Justice Fuller at his Sorrento cottage, "Main Stay" wore with the jurist when he died.

For many years the chief justice had spent his summers at Sorrento, a summer colony located on French Man's Bay, five miles from Bar Harbor.

To Chief Justice Fuller fell the honor to third rank for length of service as presiding justice in the highest tribunal of the American government. For twenty two years he was chief justice of the supreme court of the United States, but Chief Justice Marshall presided over the court for thirty four years and Chief Justice Taney for twenty-eight years. With the future rest the deterioration of his rank among the chief justices of history for ability and accomplishments.

Before Grover Cleveland sent his name to the senate on April 30, 1888, he was practically unknown except to members of the legal profession. In Maine, where he was born on February 11, 1833, he had been known as a well behaved, rather scholarly lad. He had gone to Bowdoin college and, incidentally, there won most of the prizes for election. He had gone down to Harvard law school for one year.

Finally he blossomed forth as a full fledged lawyer and politician of a high minded sort of his native city of Augusta. He became an associate editor on a Democratic paper called The Age and about the same time was elected president of the city council and then city solicitor. Soon thereafter he left Maine for the greater opportunities of life in Chicago.

From 1856 to 1888 he lived in Chicago, but attracted little attention outside his immediate circle of friends and associates at the bar until he

took under the defense of Eliza Cheney on a charge of heresy. His knowledge of ecclesiastical history and procedure established those who conducted the case and his argument of the cause of the bishop before the supreme court of Illinois is referred to still as a forensic effort seldom, if ever, surpassed in that court.

The Maine boy who had "gone west" accomplished much, notwithstanding his quiet life. He had laid the foundation for a deep understanding of the commercial law of the country and along this line he had performed services for clients that was estimated to have netted him an annual income of \$80,000. These accomplishments led the Republican senators from Illinois to urge upon the Democratic President the appointment of Mr. Fuller as the successor of Chief Justice Waite.

CHIEF JUSTICE FULLER DIES

Dean of Supreme Court Bench Dies Suddenly at His Home.

Chief Justice Melville W. Fuller of the United States supreme court died of heart failure at his summer home in Sorrento, Bar Harbor, Me., at 6 o'clock Monday morning. Mr. Fuller was in his seventy-eighth year.

The death of the chief justice was entirely unexpected, as he had been in apparently good health lately, and there had been no peremptory symptoms of any kind of trouble. Sunday he attended church as usual and when he retired at night he was at all appearances in his customary health.

Death came about six o'clock in the morning. His daughter, Mrs. Nathaniel Francis, and Rev. James

William Philbeck's horse ran away on the evening of July 4. The continuous noise of the firecrackers frightened the horse, no one was hurt.

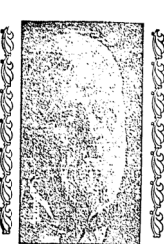
"It's too bad," one of the strangers said, "that we haven't another man here. I'd like to get up a little game of draw poker."
