THE BARN A MODEL ONE.

That Farming Pays is Demonstrated on the Farm in Question.

Through the courtesy of Mr. Geo. Nicholson Jr., the editor, his family and guests, were given the pleasure of an extended automobile trip Wednesday, in his new Packard car. Recently, the farm at Marblehead and its appointments were inspected. The most modern barn in the county is located on the farm, and it is safe to say that few barns, even in states where agriculture is made a specialty, are more substantially built and more convenient. The nucleus for a very large orchard is one of the features of the farm, and the area of stone will be materially increased. The farm comprises about 1000 acres of which nearly 160 acres are cleared and under cultivation. The soil is a clay loam and the luxuriance of the growing vegetation proves its fertility. An experiment is being made in the propagation of alfalfa and the results are very satisfactory. One crop has been harvested this season, and a substantial second crop will, from all indications, be garnered later.

ROOSEVELT MAY MAKE A FIGHT

Convention Has Final Selection of Chairman.

EASTERN PRESS AROUSED

Orthodox Republican Papers Depreciate Action of 'Old Guard' in Turning Down Former President and Look for Further Friction in Party as the Result—Column Uses Word 'Progressive' in Statement Issued.

Washington, Aug. 18.—Official Washington is very much upset over the action of the "old guard" in New York in rejecting the nomination of Theodore Roosevelt to temporary chairman of the Republican state convention. The fear is expressed here that it will force a political declaration from Mr. Roosevelt and the leaders in Washington are apprehensive that before many months have passed it may result in a split between the president and the former president. The belief is quite generally entertained in Washington that Mr. Roosevelt is in sympathy with the progressive cause throughout the country. The progressive cause has his support in New York. It is significant that in his statement given out after the meeting of the Republican state committee he employed the word "progressive" for the first time since his return to the United States.

Whether he wishes it or not, Mr. Roosevelt is bound to remain in active part in politics in the near future. The "old guard" in his own state has given him the defile and he has accepted the challenge. The chances are that he will be present as delegate in the Republican convention to be held in Saratoga in September. There may be lively developments before the convention is held. The "old guard" has the right to propose the name of a temporary chairman in the convention, but the nomination is subject to confirmation by the convention itself. Vice President Sherman will go to Saratoga with the nomination, but it remains to be seen whether he will be made the choice of the Republicans of the state as represented in the convention.

The Eastern press is very much wrought up over Roosevelt incident in New York. Some of the New York papers, notably the Sun and the World, are very much excited over it. The Tribune, orthodox Republican, deprecates the choice of the old guard. The Tribune believes it might help a fight to the finish and, at the finish, it looks for the elimination of the old guard.

USES WORD "PROGRESSIVE"

Roosevelt Issues Statement Concerning Turn Down by Committee.

New York, Aug. 18.—Colonel Roosevelt issued the following statement regarding his rejection as temporary chairman of the coming Republican state convention by the Republican state committee: "To the various persons who asked me whether I would accept the position of temporary chairman of the state convention I said that I would do so only if they were sure, after knowing my attitude, that they desired me, because my speech would be of such a character that it might help in the convention nominated the right kind of a man, on a clear cut progressive platform; but that I would not accept the nomination if the right kind of a man were nominated nor the right kind of a platform adopted."

TO ALLOT BERTHOLD LANDS

Part of Reservation Will Be Opened Next Year.

Ryder, N. D., Aug. 18.—Work of allotting to the Indians their share of the lands on the Fort Berthold reservation in accordance with the treaty by which a large part of the reservation is to be opened for settlement, will be started this week. Major Hoffman is in charge.

After the allotments are made the work of appraising will be done.

Death of President Mont.

London, Aug. 18.—President Pedro Mont of Chile is dead in Bremen. President Mont arrived at Bremen on the steamship Kaiser Wilhelm der Grosse and died at twelve hours later. Death was due to a recurrence of heart failure following the recent attack of angina pectoris from which he suffered.

BRYAN CANDIDATES LOSE IN NEBRASKA

Shallenberger and Metcalfe Appear to Be Beaten.

Omaha, Aug. 18.—Standpatism thoroughly defeated insurgency in the Republican primaries. Burkett, standpat, for United States senator, defeating Wheeler, insurgent, by a three to one vote. Hayward, secretary Republican national committee, defeated Troy, insurgent, for the congressional nomination in the first in a walk-away.

Norris, leader of the insurgents in the house, had no opposition for re-nomination in the 6th district.

Aldrich, for Republican nomination for governor, is probably nominated over Chadwick in state county option, while Cady represented the whisky interest. Sufficient returns have not been received to indicate the outcome of the legislators, but indications are that county option is defeated in both parties.

In the Democratic primaries Hitchcock defeated Metcalfe for United States senator by a three to one vote, over carrying Metcalfe's home city of Lincoln, where the Bryan influence carried. Shallenberger, present governor, is probably defeated by Dahlman in Democratic nomination for governor.

Shallenberger agreed to sign a county option bill if one was passed by the legislature, making the promise in order to secure the Bryan vote. From indications Dahlman is nominated, carrying Omaha by 5,000 and carrying Lincoln itself, where Shallenberger's influence is strongest.

FOG CAUSE OF ACCIDENTS

Score of Persons Injured in Series of Wrecks at Chicago.

Chicago, Aug. 18.—A dense fog overhanging Chicago was responsible for the injury of at least twenty persons, some severely, in traffic wrecks. Not less than twelve accidents are reported, the most severe of which came being fatal for many persons.

A westbound Chicago-Calamet suburban car, crowded with passengers, ran into an open switch which opened at forty miles an hour. The car was wrecked and piled in a ditch.

All the passengers were slightly injured and three young women were taken to the hospital.

SIXTH PANEL TAMPERED WITH

Further Revelations in Lee O'Neil Browne Case.

Chicago, Aug. 18.—When the sixth panel of a venire called in the case of Lee O'Neil Browne reported a count nearly all of them as was the case with the fifth panel, recalled that they had been "approached" with reference to their possible services as jurors. Judge Kersten called counsel for Brown into his chambers for consultation.

When Judge Kersten asked those veniremen who had been spoken to about the case to come forward the request was not clearly understood and only five men responded. His next request was more successful.

Forty of the panel of sixty-three arose. J. Tutener, a member of the panel, said that his wife had been asked if he belonged to any reform or secret societies. Walter Eklund's father had been asked similarly by two investigators. The stories told in each of all of those who came forward were of the same tenor, but as they made the admissions they were dismissed from the venire.

BLANK BALLOTS TO BE MADE.

All Parties Not Filing Petitions.

Attorney General Kahn, in an opinion handed down says, that under the present primary election law every political party in every congressional, senatorial and representative district, must nominate candidates under the primary system of political parties in counties. Where one political party has adopted the system all must use that method of nominating their county tickets. The boards of election commissioners, it is held, must furnish ballots for the primary election as prescribed by law, even though no candidates have filed petitions outlining them to place on the ballot and must prepare the ballots for voters to vote for candidates for other offices in case petitions are filed for part of offices for which nominating lists to be made. It is held that there are not sufficient number of enrolled voters in the district or county to allow a candidate to secure the necessary number of names to entitle him to have his name printed on the ballot, the board must provide blank ballots for use on primary day.

AUTO FRIGHTENS HORSE.

Andrew McKerrow Thrown Out of Buggy and Sustains Fractured Bones.

Mr. Andrew McKerrow of Germfask was thrown out of a buggy, east of the city Tuesday afternoon, when a passing automobile frightened the horse, and sustained the fracture of his left arm and hand. The auto was driven by a party hailing from Imlham, who is camping at White Lake. The horse was owned by W. W. Watson of Fayette, and the owner was driving. Mr. Watson was not severely injured. Mr. McKerrow was brought to this city by Julius Larson, the meat dealer, who happened along shortly after the accident, where his fracture was reduced.

BIG ENROLLMENT IN U. P.

Kelleyites Disconcerted on Account of the Big Vote Obtained by the Opposition.

Consternation has been cast into the camp of the Kelleyites at Lansing by the fact that in the Republican enrollment in the upper peninsula 158,185 a total vote of all parties for governor in the previous election was 61,283, and the three candidates for governor in 1908 received a total of 10,010. This shows that an enormous number enrolled on enrollment day last spring. These figures augur well for the success of Chase S. Osborn. It is concluded that he will receive at least seventy-five per cent of the total vote cast above the straits, and if he does, his nomination by a big plurality will be the result.
