

2 teas. salt	1 1/2 cup. grated cheese
1 1/2 cup. toasted almonds	1 cup crushed potato chips
2 tbl. lemon juice	

**WHEN SERVING HOT:** Mix all, except cheese and chips. Pile lightly in buttered dish. Sprinkle top with cheese and chips. Bake at 450 degrees for 15 to 15 minutes. Serve on lettuce leaf.

**WHEN SERVING COLD:** Mix all together lightly, except cheese and chips, saving for topping. Serve on a lettuce leaf. Serves 6 or 8.

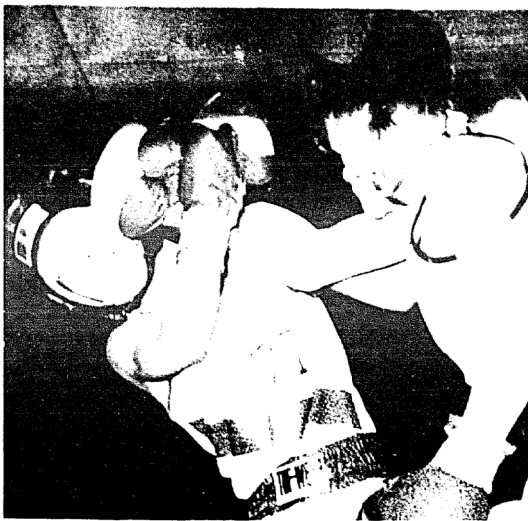

## The saloon debate rages on

On March 11 we ran a photo of what we thought was the saloon of the old St. James Hotel. At least that's what was written on the photo. This was challenged by Bill Vassau, who said it was his mom's place, across the street from the St. James on First Street, and known as Vassau's.

Last week we ran Bill's story and expressed the fond hope that he wouldn't get into trouble with the McNamara clan (although I think Bill could hold his own against great odds); he was able to identify the patrons at the bar and his manner was very convincing and forceful. I figured Bill should recognize the place he grew up in, but also thought Francie Mack had a point because he spent many of his childhood years in the St. James, and even sometimes frequented the saloon to say hi to the bartender. He also can be very convincing.

So what I did was "cop out" and throw the confusion to the readers, hoping that somehow fate would intervene, the real story would come out, and your faithful correspondent would be off the hook.

Things started to look up when a couple days ago we had a call from Eldon Norton, who said he had a photo of Vassau's, and it wasn't the same place at all. Now we're going to get the matter cleared up once and for all, right? Read on.

The bartender in this photo, by the way, was identified as Lucius Mercer and the area to the right of the bar which leads to the back of the building was identified as the part that led to the living quarters. We thought we owed it to Bill Vassau to show him this shot and get his clearance; I mean, we're either right or wrong, and Bill should know. But Bill stuck to his guns and said no way was this Vassau's saloon; he'd know it anywhere. But he recognized this week's picture as Matt Schneider's saloon, which occupied half the building now known as "The Saloon" and which later became the

Red Owl grocery. And the bartender was Rock Charter. (And we're getting in deeper.)

Now I was getting curious and curiouser and decided to try some more. I may have previously mentioned that George Mero, at the time these photos were taken, was the chore boy at the St. James, and his testimony in this highly important matter could be valuable and maybe even settle it once and for all. George very kindly agreed to an interview, even knowing that he could be in grave jeopardy by giving evidence that may be in variance with that already clouding the picture.

Now we get to the fun part. According to George...and he should know because he worked there...day's photo is the St. James Hotel saloon (where have I heard that name before?) and the bartender is none other than Dennis Collins. (I now remembers George worked there and made the handsome sum of one dollar per week, and board, for doing the chores and getting up at four in the morning to start the fires. Now think hard, George. I said; could it possibly be Vassau's, and if not could it possibly be Matt Schneider's? (At this point Mrs.

Mero very kindly asked me to sit down and have some pancakes but since I was expecting a call I had to politely decline. But George was certain: this week's photo is the St. James saloon, and the one of March 11 was Vassau's.

And Francie, you're going to have to dig up some supporting witnesses or maybe have a heart to heart talk with a couple of guys who can be very convincing. If I don't hear from you I plan on letting the matter rest. Unless you team up with Eldon Norton, that is, and we start up all over again.

Our photo of March 18 was of an ice-making project that took place back in the Twenties on the paper mill flume. A loyal reader has since

brought in the following clipping from a paper dated Feb. 19, 1924:

"Manistique-No matter how hot the summer, Manistique people will not lack for ice during 1924, is the assurance of John Girvin of the Coffey Fishing Co., who has a crew of men harvesting ice on the flume, storing up a supply for city householders and business places. Mr. Girvin's concern is the only one in the city storing ice for sale. It expects to have some 10,000 cakes available for patrons."

## New book tells story of St. Martin Island

"Island Story" is a short history of a speck of land 10 miles south of the Garden Peninsula which is much more than a re-creation of the hardships of frontier life in the 1800's.

The book, recently published by the Mid Peninsula Library Cooperative, chronicles the history of St. Martin Island.

Jean Nicolet, the French explorer, probably was the first European to land on its shores, in 1634. Father Marquette and Joliet stopped by in 1673 and it is believed Marquette gave the island its name. Fur trading, commercial fishing and logging all made up its economy.

A bit of mystery comes with the finding of a skeleton of an Indian with a spearpoint imbedded in the chest bone. The furor that marked the rule of "King Strand" on Beaver Island reached St. Martin, and there was the "Jaffa Crusade" to the holy land which left its mark on these people thousands of miles from Jerusalem.

Margaret Coppess, author of the book, has delved deeply into the backgrounds of many families, some of whom are still existing, for intimate details of the life and times of the Islanders—their joys and sorrows, how they contended with the changing seasons, how they worked and how they played.

grew up around the fishing trade on the island—great catches necessitating barrels for shipment to the major markets.

Population on the island was never large. Twenty-four men went off to fight in the Civil War, a number far out of proportion to the number of residents. Still, education of the children was not over-looked. Several teachers were brought from the mainland to conduct schools. One was an Englishman, Joseph Sever, who had trouble with his. When asked by a student how to spell salsa, he accommodated them, unaware of any plotting, by replying, "Salo-n-hess, hay, I, two hoos and a how." Ministers and priests visited the island to care for the religious needs of the settlers. Trading was done at the store at Sac Bay, on the Garden Peninsula, in good weather, and trips were frequently made by boat to Chicago for fishing gear.

Logging of the island's hardwoods came with the startup of the iron smelting furnace at Fayette in 1866. A chapter of the book is devoted to the islands neighboring St. Martin, the Summer Isles, Poverty Island, Gull Islands (where, it was observed, white gulls lived on one island, and gray gulls on the other) and Big Summer Island, off which LaSalle's "Giffin" is believed to have sunk in 1679.

Another chapter tells of the boundary dispute which went on for years between Michigan and Wisconsin, and in which St. Martin had a role in the final solution which was given by the U.S. Supreme Court.

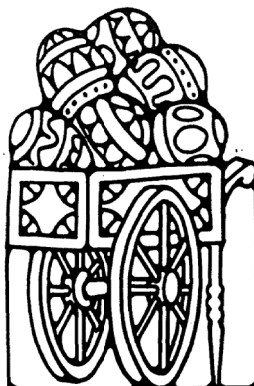

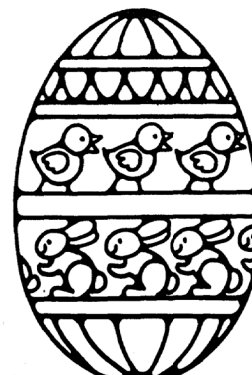

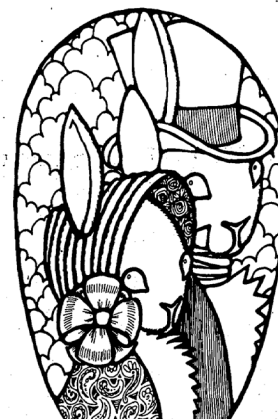

# Prune your trees now

DNR REPORT by Carol Schmidt Newberry DNR Office

As spring is rapidly approaching, now is the time to start pruning shade, fruit, and ornamental broadleaf trees. The type of tree, the intensity of cultivation, and the objective in view determine the amount, kind, and time of pruning.

When is the best time to prune? There is an old saying that the best time to prune is anytime the saw is sharp! While it may be true that pruning can be safely pruned anytime of the year, early spring pruning is the best time for preparing for, ornamental and shade broadleaf trees.

There are three basic things to look for while pruning. First, remove all dead, dying and diseased branches. Second, branches that interfere or rub against each other should be removed. Finally, those branches that are too low or with weak V-shaped crotches should also be removed.

When pruning, it is important to have sharp tools. A good clean cut results faster and is less unsightly. Also, all cuts should be made close to the main branch or trunk. Short branch stubs callous over slowly and are an encouragement to insects and disease.

There are three basic things to look for while pruning. First, remove all dead, dying and diseased branches. Second, branches that interfere or rub against each other should be removed. Finally, those branches that are too low or with weak V-shaped crotches should also be removed.
