

### Bodies Of Lloyd Edwards, Millard Hutchinson, War Victims, To Be Returned

Next-Of-Kin Here Notified That Remains Will Arrive Within Month

Bodies of two young Manistiquie soldiers, both 19, who died in the same battle area in Italy are being returned to Manistiquie from the front. They were killed on the 10th day of this week. They were the bodies of Pvt. Lloyd Edwards, son of Mr. and Mrs. Ernest Edwards, and Pvt. Millard Hutchinson, son of Mrs. Minnie Hutchinson, both of this city.

Pvt. Edwards was reported seriously wounded in action on June 1, 1918, and died the next day. Pvt. Hutchinson was killed in action on June 2. Both had participated in the fighting in Italy, including the bloody action at the Anzio beachhead and the march on Rome.

Survivors of Pvt. Edwards besides his parents are four brothers, Kenneth, Vernon, Millard and Willard, and one sister, Mrs. Jackson. Pvt. Hutchinson is survived by his mother, four brothers, Ralph, Clarence, Alfred and Dewey, and two sisters, Mrs. Leona Aldrich and Mrs. W. Miller.

The bodies of both Pts. Edwards and Hutchinson have been returned in a temporary military casket in Italy. When they will arrive here is not known but the Chicago distribution center of the American Graves Registration Division has announced that they will be returned from overseas "within the next month."

Military honors will be given them at funeral services which will be attended by next-of-kin. Both bodies will be accompanied by a uniformed army escort, and the Schoolcraft county permanent burial committee organized several months ago with the beginning of the program to return the dead, will conduct the military rites.

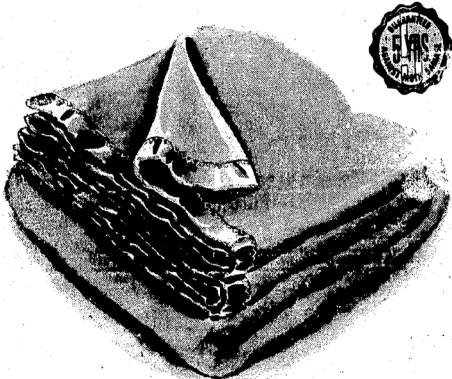

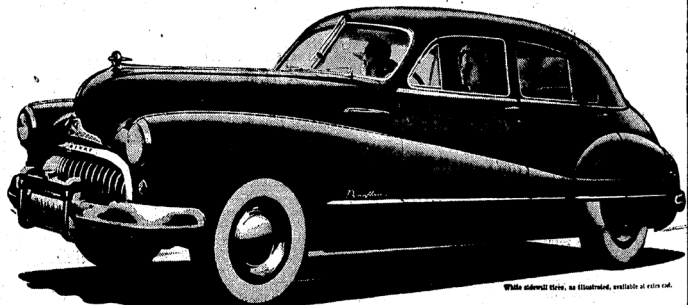

## SAFETY IS POLICE THEME FOR JULY

State Police Commander Here Issues Warning To Local Motorists

"Speed kills, take it easy!" This is the traffic safety theme to be stressed during the month of July by police agencies of Michigan, according to Sergeant Kenneth White, commanding officer of the Manistique post of the Michigan state police. The campaign is part of a year-round traffic education program sponsored by the National Safety Council under the title of "Operation Safety."

"Modern, smooth running cars give a sensation of safety when running at high speeds," Sergeant White said. "No car, however, is safer than its driver, and the records show that speed is factor in accidents more often than any other violation. Speed is likewise a contributing cause in two out of every five traffic deaths."

Contrary to general belief, Michigan does have a speed law that applies to the open highway, Sergeant White pointed out. "Unless a zone is posted with signs, the law does not designate any specific speed limit outside of business and residential districts," the officer said. "But it does provide that driving too fast for conditions is a violation. By conditions is meant such considerations as the weather, volume and rate of flow of traffic, condition of highway and whether it is day or night."

Under certain circumstances, you can speed at five to 10 miles an hour as well as at 10 or 60. And when you're going 60 and hit a solid obstruction it is just like driving off a 10-story building. Although the accident record is not increasing proportionately with the increase in traffic, nevertheless it is at a new peak and growing. Sgt. White stated. Last year 1,444 persons were killed and 29,629 injured in 137,610 traffic accidents in Michigan.

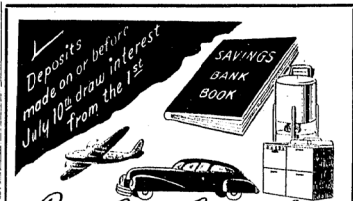
"Vacation is an attitude of mind," the Michigan department of health indicated this week when it issued "Ten ways to get the most out of your vacation."

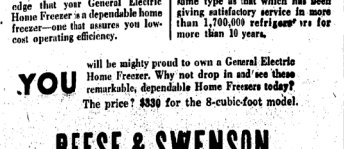

### GRASS HELPS IN EROSION CONTROL

One of the greatest uses for grass is in erosion control. It holds, extends soil conservation at Michigan State college, points out that when land is abandoned, it naturally covers it with a protective grass covering.

Grass, including legumes, is an effective tool for reducing wind and water erosion. (Grass such as ryegrass and sweet clover may be used as a cover crop on eroded fields. They will aid in reducing erosion, may be plowed under as a green manure crop, or possibly as seed sowing pasture.)

Fort Miami Played Part In Discovery Of The Mississippi

(Editor's Note: This is one in a series on historical spots and monuments in Michigan based on information in the Michigan Historical Collections at the University of Michigan.)

A tiny fort erected at the mouth of the St. Joseph River in 1679 played a key part in the discovery of the mouth of the Mississippi River.

Destroyed long ago, the stockade was constructed overlooking Lake Michigan on a bluff that now adjoins the business center of the city of St. Joseph.

Called Fort Miami, it was the first fort built in the lower peninsula. It formed the main base in Michigan for La Salle's explorations which led to the discovery of the mouth of the Mississippi.

the University of Michigan. Never one to waste time, La Salle cut the bastion from the wilderness while awaiting a rendezvous with other members of his party before making his first attempt to get to the Illinois River...

Tried Again Unsuccessful in his first try, the husky, intrepid explorer returned to Fort Miami, and then left for Fort Pontchartrain, Kingston, Ont., to arrange for more supplies. He and several others trudged the 1,000 miles through the snow and slush of early spring in 65 days.

In Nov. 4, 1682, La Salle returned to his Fort "Miami" headquarters which he soon left on a trip to the Illinois River. Two months later he was back, but left in March to visit friends at another Indian village, the mouth of the Mississippi.

After another Indian visit, he left the fort for Montreal by way of Mackinac. Back at Fort Miami

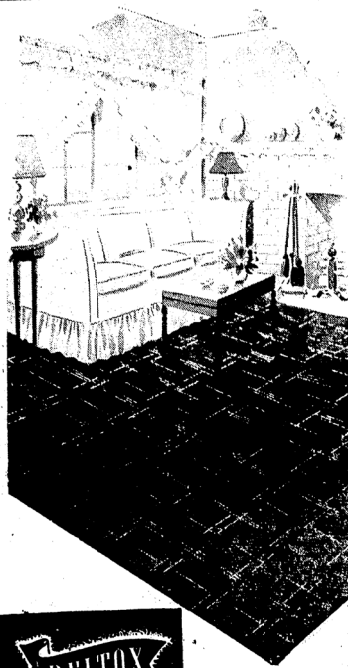

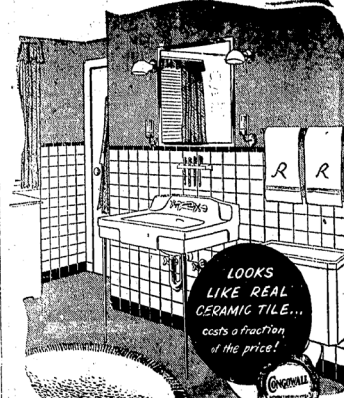

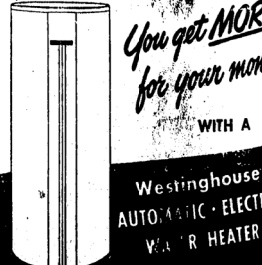
