SKILLED LABOR SHORTAGE

The department of labor warns of a possible shortage in skilled workers. This is due to the fact that in a depression when labor is abundant, occupations cease to train new workers to supply needs. As a result, the number of workers in each business picks up in often tops its previous speed and more labor of the skilled type is in demand.

This report should be encouraging to those on relief jobs who are seeking better employment, and to those who are not satisfied with present jobs. If these workers would get in touch with employment agencies they may receive aid in following employment trends and in finding where training can be had to qualify them for skilled jobs.

THE BEACON OF LIBERTY

That we cannot let the Supreme Court of these United States become the tool of any one man is best expressed in two paragraphs taken from the book, "The Constitution of the United States," by James M. Beck. The Supreme Court of the United States compels the living generation, too often swept by selfish interests and frenzied passions, to respect the immutable principles of liberty and justice. The court is thus the trustee for the unborn, for it protects their heritage from spoliation in the mad excess of party strife in living generations. Thus the court must often affront the pride of power of temporary majorities. And Mr. Beck continues along these lines, which were written in the year 1924, by saying, "The American republic has attempted for over one hundred and thirty years and on a scale unprecedentedly bold to solve the great problem of government by the people. It has been a period of fierce controversy and bitter party strife. Like the ocean, the political life of the American republic is at times placid, with hardly a ripple upon its surface, and then the furious storms of discontent lash the waters into violent and angry seas. But always the supreme court stands as a great lighthouse, and even when the waves beat upon it with terrific violence (as in the Civil War, when it was shaken to its very foundation), yet after they have spent their fury, the great lamp of the Constitution—as that of another Pharo—illuminates the troubled surface of the waters with the benignant rays of those immutable principles of liberty and justice, which alone can make a nation free as well as strong."

This has been the history of our Supreme Court. Its power is now being threatened in Washington. We cannot fail in our duty to see that it shall always remain to be the lighthouse that sends forth the benignant rays of liberty. And we can best accomplish this duty by writing or wiring our congressmen today, to exert all possible influence against the president's proposed Federal Judiciary Reform bill.

ECONOMIC HIGHLIGHTS

Happenings That Affect the Dinner Table, Dividend Checks and Tax Bills of Every Individual. National and International Problems Inseparable from Local Welfare.

Recently the business indicators have shown the effects of two adverse influences—strikes and floods. Both caused sharp reductions in consumer purchasing power, and both were felt throughout the entire industrial structure.

Most serious strikes involved Pacific Coast maritime workers, and automobile workers. These strikes have been at least temporarily settled. West coast shipping, tied up practically 100 percent for more than 90 days, is resuming normal proportions. General Motors plants are again operating. But the labor outlook is still mixed.

It is regarded as inevitable that more strikes will be called this spring and fall. Objectives of two of these strikes will be the coal and steel industries, which employ about 900,000 men. At the present time, the soft coal mines are operating under a labor agreement effected between the operators and the United Mine Workers. This agreement expires on the last day of March, and it is likely the union cast that at that time the union will make demands the operators will refuse to meet, and a strike will follow. So far as steel is concerned, it has been the avowed intention of John L. Lewis to force the closed shop on the industry, and it is said that he has his plans all ready for what may prove to be the greatest strike in recent history.

As the U. S. News recently pointed out, "Modern industry is now so integrated and inter-related that the troubles of any one part soon reflect themselves throughout the whole. Strike effects take on national importance." In other words, when a strike hits a big industry, such as automobiles, its dampening effects on trade are felt immediately throughout many other big industries—steel, rubber, oil, textiles, transport. Car dealers run out of stock, and must discharge salesmen. In a thousand communities purchasing power declines, is felt by grocers, drug stores, movie theatres, every commercial activity. Cumulative losses run up into the billions. These widespread influences of a general strike are regarded by some labor leaders as an asset—they feel that public opinion, impressed by the bankruptcy on normal prosperity, will throw its weight to their side to bring a settlement with employers. Yet the automobile strike settlement gave labor a great deal less than they asked for, as regarded by A. F. of L. President Green as a setback for the workmen.

The influences of a natural disaster, such as the Ohio river floods, are of course similar. Factories and stores close, people must leave their homes. Their purchasing power is almost entirely stopped. First and most drastic effects, as a result, are felt by the retail industries. During and following the recent floods, the large mail-order houses reported serious drops in orders. However, retail trade for the country as a whole is managing to stay ahead of the levels of 1936. And it is of course certain that there will be a stimulus to construction in the affected areas after the waters recede.

Consequence of these adverse industrial factors is a recession in the standard business indexes lately. Yet the general tide of industry is still upward. The government adjustment is made for catastrophes and seasonal influences. Items of interest follow:

Railroads: Carloadings are running consistently ahead of the comparable period last year. Outlook for business is good. Worst problem faced by the industry is legislative—it fears that laws, which will materially increase the cost of operation without providing means for increasing income, to compensate, may be passed by Congress.

Electric Utilities: Also face a grave legislative problem, are in the air as to what Federal power policy will be in the future. Power consumption has been very high, is now declining somewhat, but is expected to be in the future. Summer electric consumption, particularly in the domestic field, is naturally less than in the winter.

Steel: Iron and Steel Institute says the industry's 1937 construction and equipment budget will be 45 percent above of 1936, totaling about \$290,000,000.

Cost of living: In holistic variations were not extraordinary. Important advances nor recessions in sight. Commodity prices are likewise reasonably stable, with drops in a few lines. Some experts look for sharp jumps in grain futures, due to a relatively small world crop.

Profits: January dividend declarations were not extraordinary. A number of industries paid less than in the same period last year. Advances were registered in such industries as packing, food, utilities, department stores, steel.
