

(Continued from first page) tax supported units once ugain were able to make reductions in their levies, which should prove a welcome surprise to taxpayors.

This marks the sixth consec tive year since property valua-tions were set by the state tax commission in 1949 that the levy has been reduced. The peak rate in that year was 52.36 mills Members of the Board of Education cut by two mills the levy for retirement of Lakeview School and Memorial Gymnasium bonds, while the city lovy declined by a portion of a mill.

Total valuations on which taxes are due is \$20,211,675, which is an increase of \$1,133,610 over a year ugo, when the amo ns \$19,078,065. This gain in valuation will amount in a boost of revenue of approximately \$48,000 for the three units, city, school and county, which share in the tox returns.


