A NEW CONTROVERSY FOR THE PHONE INDUSTRY

An acrimonious fight is building up between the phone industry nationally, of which the Ontonagon County Telephone Company is a part, and the Federal Communications Commission over a new trend in the policies of the regulatory agency. Make no mistake about it—your home telephone bill is at the center of the controversy.

If the phone industry is right, the FCC is launched on a course which may eventually cause domestic telephone charges to increase as much as 75% per month. This, of course, is the industry's opinion. They are entitled to have it and to express it, even if the FCC disagrees.

The complicated issues has to do with whether other non-regulated companies should be allowed to construct competing inter-city trunk lines or to install competing terminal equipment in factories and offices.

The FCC sees nothing wrong with allowing a competitor to string a line from Detroit to St. Louis or wherever (duplicating a costly telephone company provided line already there) and to offer a separate service to customers (who obviously are going to be big businesses).

Also, the FCC sees nothing wrong with permitting competitive companies to install terminal equipment, again for big businesses—such as the company switchboard and everything in the office or factory wired to it.

Richard E. Wiley, FCC chairman, refers to these privileges—now being granted by his agency—as a "return to market-place principles" and argues that the competition will be good for the telephone business.

Of course, the matter isn't quite that simple and the phone industry replies—with vehemence—that the FCC is permitting competitors to "skim off the cream" and is thereby wrecking the single integrated system which has worked so well for this country.

The phone industry argues it is required by the 1934 Communications Act to work for universal service in this country, which means a phone in every house. Competing companies now setting up parallel services for large corporations are not burdened with unprofitable country and village customers.

Further, they argue, pricing of telephone services has all along favored the householder. Charges for big businesses and long distance tolls actually subsidize the cost of providing universal home service. They say if this form of subsidization is taken away, home telephone bills will have to go up 75%.

The telephone companies are asking only one thing at this time—that there be open public debate before Congress on these issues. They say the FCC is making policy by its rulings and this is wrong. The policy-making function, they say, belongs to Congress and has been usurped by the FCC.

There is a vehicle for the debate—bills that have been introduced in the House and Senate to amend the 1934 Act. The telephone companies hope this legislation will not be allowed to vegetate and the bills will be given full congressional hearings.

An important question of public policy is involved here and it affects almost every family in the land. Let the hearings take place. This newspaper supports the telecommunications industry contention that the whole telephone question needs a good public airing and that the proper place for this is before Congress.

Readers are urged to write their Congressman and ask support for the Consumer Communications Reform Act of 1976. Such letters will assure congressional debate of this issue that could hit every residential telephone customer right in the pocketbook.



BURGESS LISTS QUALIFICATIONS FOR SHERIFF'S CANDIDACY

William E. Burgess is a Democrat candidate for the office of Ontonagon County Sheriff. As a continuous resident for the past twenty-two years, Bill served eight of those years as an Ontonagon Village Police Officer and seven years as Court Officer of the 98th District Court. With his experience in working with the public he is aware of the problems and conditions of the County.

Bill believes the Sheriff's main job to be administrative. He is well qualified in this area. He has been employed by Hoerner Waldorf Corporation for nineteen years and has been an officer in the United Paperworker International Union Local 354 for fifteen years. The last five years he has been serving as President of Local 354. He is also a trustee of the Gogebic-Ontonagon Labor Council.

For thirteen years Bill has been director of the Ontonagon County Ambulance in the North end. He also serves as second vice-president for the Board of Directors of the Upper Peninsula Area-wide Comprehensive Health Planning Association and also as president of Zone 1. This organization coordinates the health services in the Upper Peninsula. (Just recently the name has been changed to the Upper Peninsula Health Systems Agency, by new Federal law.)

Bill is a veteran of the Korean conflict, having served in Japan and Korea. He is Post Chaplain of the Lake of the Clouds Post 5600. He has also held some 15th District offices. He has been active in many other organizations and civic affairs including the Gogebic-Ontonagon Law Enforcement Association.

Bill attended college at Bryant Business College in Providence, Rhode Island and Wayne University, Detroit. He is presently enrolled with Northern Michigan University in the in-service training course for Police Officers.

If elected, Bill plans to make several changes in the operation of the Sheriff's Department, such as returning necessary equipment to the County and setting up a rehabilitation program for inmates. He intends to take advantage of state and federal grants which are available for this purpose. He also sees a need for continuous education for the whole department to keep his officers informed of up-to-date procedures.

Further, Bill intends to be responsive to the suggestions of the public and to create a climate in which the Sheriff, his Deputies, and the public can all work together for the Common

good. Bill pledges to work hard to maintain the peace in the spirit of honesty and fair treatment for everyone.

16 LOCAL YOUTHS PARTICIPATE IN OTTAWA YCC PROGRAM

High school students from Ironwood, Bessemer, Ramsay, and Wakefield began an eight week work-education program on June 28 on the Bessemer Ranger District of the Ottawa National Forest according to District Ranger Charles Bartlett.

The students report to the Ranger Station each morning, Monday through Friday, and work under the direct supervision of two group leaders, both graduates from the University of Southern Illinois. Group leaders work under the supervision of Forest Service personnel.

One of this summer's projects just completed was at the Black River Harbor Recreation Area. YCC'ers did some landscaping around the main entrance sign, trail maintenance work on the Rainbow Falls east trail, and painted bases of barbecue grills. Other projects on their schedule this summer will include more work at the Harbor Area, sign erection and landscaping, trail construction, tent pad construction, plantation release, land corner search and monumenting, wildlife opening maintenance and gathering soil research data.

Also planned as a learning experience are tours of the plywood plant in Bessemer, the Sylvania Visitor Information Center and Toumey Nursery in Watersmeet, Nagel's Sawmill in Land O' Lakes, and the Michigan Department of Natural Resources in Wakefield. YCC'ers will also take part in an Environmental Awareness Workshop.

The Youth Conservation Corps program involves 30 hours of work and 10 hours of education each week. The students are paid for their work, learn about natural resources management and ecology, and accomplish a good deal of work on the District.

According to Dave Tucci of the Bessemer Ranger District, "We really appreciate the fine work these students accomplish for us each summer - they enjoy their experience and leave with a better knowledge of what the Forest Service is, and does, as well as a greater respect for the natural resources of this area and how man's activities affect them."

Area Seniors will be particularly interested in the Annual Senior Citizen's Picnic to be held at the Adventure Mountain Sports Facility in Greenland on July 25. There will be a program, dancing and refreshments throughout the day and all Seniors county-wide are invited.

NEW PUBLIC ACCESS & BOAT RAMP AT SILVER CITY READY FOR USE

The residents of Carp Lake Township and the surrounding area now have for their use a new Public Access and Boat Ramp. It is located on the Big Iron River just below the bridge near the intersection of M-64 and M-107.

This facility was constructed by the Department of Natural Resources, Waterways Division with an appropriation of \$19,000. The District I construction crew located in Baraga did the work on this fine, and much needed boat landing. Actual construction should be completed this week with the installation of a 30' skid pier. The ramp is 24' wide and can easily accommodate boats over 20' long. The ramp is made of pre-fabricated concrete. Parking room is available for 20 cars and boat trailers as well as 10 cars only. Toilet facilities are also available.

The whole area is very well designed and landscaped. This is a very welcome addition and will definitely be enjoyed by many boating and fishing enthusiasts. We thank the DNR Waterways Division for their efforts.

SHERIFF'S ATTORNEY RESPONDS TO PROSECUTOR'S LETTER TO GOVERNOR

The following copy of a letter sent to Governor Milliken was received in our offices on July 8, 1976, from Jeryl A. Manchester, the attorney representing Sheriff Donald Powelson in the recently completed investigation by the State Attorney's offices.

Dear Governor Milliken:

As your office is no doubt aware, I am both the attorney for and a friend of Donald R. Powelson, Sheriff of Ontonagon County. As such, I have been involved in the investigation of the Ontonagon County Sheriff's Department conducted by the Attorney General's Office at the request of Mr. James Jenkins, the Ontonagon County Prosecutor.

After hearing its text broadcast on a local radio program, I requested and received from the Ontonagon County Prosecutor a copy of his June 28, 1976 letter to your office. In that letter the Prosecutor blames a "lack of leadership in the Sheriff's Department" for, among other things, the incidence of offenses for "resisting arrest, obstructing police officers, or disorderly persons," occurring in Ontonagon County.

In reviewing that letter, I feel compelled to advise you that it is written by an incumbent Prosecutor who this year for the first time faces a very serious challenge in the August primary for his party's nomination to the office of Prosecutor for Ontonagon County. Had the letter been sent only to your office and to the persons directly involved, his plea for action on your part would have had the color of legitimacy. However, when the Ontonagon County Board of Commissioners is the only involved party to whom a copy of the letter is sent, and copies are mailed to seven representatives of the media, the letter is clearly revealed as an attempt by the Prosecutor to capitalize upon the decision to be made by your office to further his own political aspirations.

Because I feel strongly that the letter should be called what it is, I have sent copies of my letter to those persons receiving a copy of his June 28, 1976 letter. Thank you.

THE PRIVATE LINE

Effective July 1, 1976, the last of the 3400 customers of the Ontonagon County Telephone Company were officially cut over to one-party service. With the conversion of the last exchange (Ontonagon) the project started several years ago was finished. All customers of the company, no matter where they live, now have private line telephone service. During the past several years, hundreds of miles of buried cable has been added to existing cable and extended to the far corners of the company's service area in order to bring the latest in telephone improvements to everyone. Gone forever are the frustrations and aggravations of multi-party lines that have plagued our customers and the company itself. This latest expansion included bringing telephone service to everyone in our service area who requested it.

White Pine and the Silver City area were the first areas cut-over to private lines. The following year, Rockland, Mass, Ewen and Bruce Crossing were completed. Ontonagon was the final exchange and completed that phase of the company's plans.

The telephone company has placed the order for equipment necessary to offer touch-tone, touchcall, push-button, etc. service and is planning to have it available at least by September of this year. To eliminate delays, it would be appreciated if everyone desiring touchcall would contact the business office.

The latest REA loan making these improvements possible amounted to \$1,400,000.00. Most of these funds have been spent to bring these improvements to our customers.

There was a considerable amount of trouble connected with the one-party conversion in Ontonagon. For any and all inconveniences caused our customers, we are sincerely sorry. The adding of new facilities to work with existing facilities in certain areas of the Ontonagon exchange created special problems. We appreciate the patience of most of our customers.

It seems particularly fitting that during the centennial year of the telephone, one of the oldest telephone companies in the country is continuing to bring the best telephone service possible to its customers at reasonable rates.

VOLUNTEER CAMPGROUND HOSTS FOR OTTAWA

The Volunteer Campground Host Program is something new to the Forest Service, according to Bob Burton, Recreation Officer of the Ottawa National Forest. The hosts pay no campground fees and provide a valuable public service while camping in a National Forest campground for a minimum of two weeks. One couple described their experience as campground hosts as, "The best vacation we've had in years!"

The use of volunteer hosts is one way of providing improved campground services on a personal, continuous basis. The hosts principle duties include greeting new campers, helping with registration and parking, if necessary, explaining regulations, providing general information, and taking care of minor repairs and maintenance. In return, the hosts are allowed to camp free and may come and go as they wish. They should be able to spend two weeks "on the job" and have comfortable camping equipment.

The program has been very successful on several National Forests. In the state of Washington, where the program was initiated, they are called "Good Sammers." The Forest Service discovered that where a campground host was stationed, vandalism became almost non-existent, campground rowdiness vanished, and general maintenance, litter pick-up, and other caretaker duties were accomplished. The very presence of the hosts seemed to discourage those bent on vandalism or mischief.

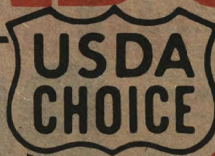

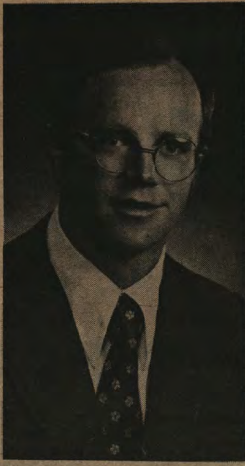

GARDENERS, BEWARE! BUGS ARE ON THE MOVE.

From now until the first frost, home vegetable gardens are likely to be invaded by a number of serious insect pests. According to Don Cress, Extension entomologist at Michigan State University, you should be on the lookout in July for aphids, corn borers, cabbage worms, slugs and flea beetles.

Aphids - Aphids are small, soft-bodied insects that feed on plant juices sucked from leaves and stems. They usually feed from the undersides of leaves. Unless you check plants closely, you may not realize you have them until their population is huge.

Because aphids at this time of year are all born female, populations can build up to unbelievably high numbers very rapidly. It takes only one aphid to start a colony that can do a lot of damage in a short period of time, Cress says.

Aphids commonly feed on cabbage, cucumbers, corn, beans, tomatoes and peppers, and most garden crops are susceptible to at least one species of aphid.

Feeding by large numbers of aphids can reduce plant vigor and decrease yields, Cress says. Many aphids also transmit viruses that cause plant diseases. These may further reduce yield or even kill the plant.

Inspect plants closely and often, paying particular attention to the undersides of the leaves, Cress advises. If aphids are present, control with malathion or diazinon applied to the undersides of the leaves. As with all insecticides follow label directions for amounts, frequency of use, plants and pests the material may be used on, and the length of time that must elapse between last spray and harvest.

Corn Borers - The larva of the European corn borer is a small, light brown caterpillar. It bores into an ear of corn through the side of the ear or from the stalk end and feeds on the young, sweet kernels. The same worm enters peppers around the edge of the cap that fastens the pepper to the plant.

Controls are used to keep the worm out of the edible part of the plant, Cress says. Once it is inside, it is too late.

For both corn and peppers, the recommended chemical control is a combination of Sevin and diazinon sprayed on the undersides of the leaves as well as on the ears and fruits.

Cabbage Worms - At this time of year, little green caterpillars on cabbage, cauliflower, broccoli and other cole crops are probably the larvae of the imported cabbage worm butterfly, Cress says. The velvety green worms chew large holes in the leaves of these crops and can destroy whole fields in a short time.

In mid-August, the imported cabbage worm will be joined by the cabbage looper, a light green worm with a white stripe down each side. It gets its name from its looping, inchworm motion across a leaf.

Controls for cabbage worms include Sevin, diazinon, malathion or Bacillus thuringiensis, a bacterial disease of caterpillars that is sold under the tradé names Biotrol, Dipel and Thuricide. It is toxic only to the worms -- it will not harm other insects or humans.

Slugs - Slugs are not insects. If you've never seen one, imagine a snail without a shell.

Slugs will feed on almost any garden crop, says Cress. They feed at night and spend the daylight hours hiding in dark, cool, damp places.

Removing mulch and eliminating other hiding places is usually recommended to get rid of slugs. Another way is to place old boards around the garden site as slug traps. The slugs will crawl beneath them to hide. Then all you have to do is tip the boards over and let the sun kill the pests.


A saucer of stale beer set in the garden at night will also eliminate some slugs, Cress notes. Drawn by the smell of sugar or yeast, the slugs crawl in and drown.

There are no chemical sprays labeled for use against slugs, he points out. Cultural controls -- removing mulch, watering less often to keep the soil surface drier, etc. -- are your best bet.

Flea Beetles - Flea beetles are tiny, usually black insects about one-eighth inch long. They are very active and jump from one leaf to another to feed. They eat small holes in plant foliage, giving the leaves the appearance of having been shot with a shotgun.

Control flea beetles with malathion or diazinon as soon as you see the damage, Cress says. Always read and follow label directions when applying any chemical to your garden, he urges.

KICK OFF MEETING HELD FOR OTTAWA FOREST PLANNING EFFORT

At a meeting last week held at the Holiday Inn in Hurlley, Wisconsin officials of the Ottawa National Forest "kicked" off the Forest planning effort, according to M. K. Lauritsen, Supervisor of the Ottawa National Forest. Rangers, Staff Officers, and staff specialists in water, wildlife, and soils met to discuss information and timetables needed to complete a Forest Plan by June, 1977.

The land systems approach will be used and will serve to "divide" the Forest into natural planning units. For example, the Ottawa National Forest is located within the Laurentian Shield physiographic province. This is a region of similar bedrock structure and climate. Within the Forest, other smaller divisions that meet planning needs will be made. Within these units, planning will identify needs and deficiencies by resource. After available information on all of the various resources in each unit has been considered, the best mix of uses will be determined.

Much of the information to be included in the Forest Plan for the Ottawa National Forest is already available. The plan will pull this information together.

During the planning process, the comments and opinions and facts available from the public will be requested, and the plan will be prepared based upon this public participation. The public will have an opportunity to review the draft plan prior to approval.

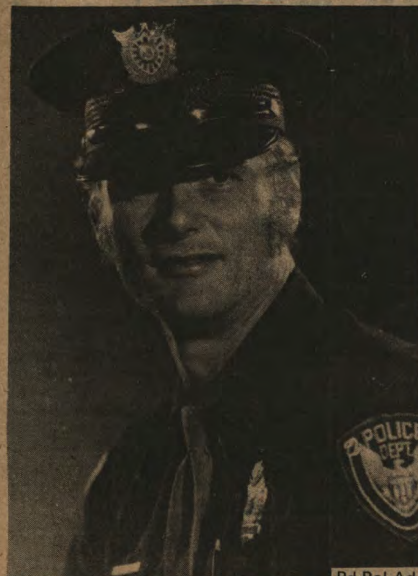

Pet care topics

Fleas and ticks spoil fun for sporting dogs

Successful control of fleas and ticks on a dog requires control of the pests in the dog's environment. But when the dog's environment is the whole outdoors, flea and tick control becomes an especially thorny problem.

Active outdoor pets like hunting dogs spend a lot of time in heavy underbrush, high grass, and other favorite haunts of fleas and ticks, often returning heavily infested with the parasites.

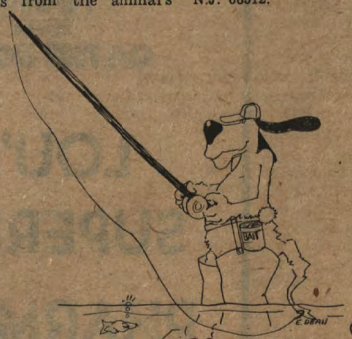
When this happens, the first step in flea control is the use of a flea and tick shampoo such as Lambert Kay's Zenox, which not only kills fleas and ticks but removes organic debris from the animal's

STATE THREATENS TO SUE IF A-DUMP IS LOCATED WITHOUT ENVIRONMENTAL IMPACT STATEMENT BEFOREHAND

The State of Michigan will file suit if the federal government tries to locate a dump for nuclear wastes near Alpena in lower Michigan without first preparing an environmental impact statement.

Frank Kelley, State Attorney General, who once served as Alpena city attorney, said on Monday he has given formal notice to the U.S. Energy Research and Development Administration (ERDA) of his intent to file such a suit if an environmental impact statement is not prepared.

The 1969 National Environmental Policy Act prohibits the Energy Administration from proceeding with such a significant federal action without advance preparation of "a detailed statement of environmental consequences," said Kelley.

In a letter to ERDA administrator Robert Seamans, Kelley said he would go to court, if necessary, to "restrain the creation of an A-dump in Michigan if ERDA attempts to proceed without an adequate advance study of potential environmental consequences."

Kelley said that he hoped, however, that ERDA would fully comply with federal law without the necessity of legal action.

Kelley said the previous "bad experience" came in 1974 when the U.S. Forest Service ignored a request for an environmental impact statement before attempting to spray the toxic herbicide "agent orange" near Bond Falls Basin. Kelley got a federal court injunction which is still in effect against the aerial spray.
