Justice Court is Reduced By Circuit Judge

The personal injury case, Oliver Allard versus James DeGrande, had been set for trial Monday afternoon, but was postponed to Tuesday morning when Judge R. C. Finckhann reduced the justice court verdict of \$100 to \$50 and no costs in favor of the plaintiff.

The suit was the result of a quarrel which arose after DeGrande had sold an automobile truck to Allard, on credit and had threatened to take the truck if Allard failed to make proper payments. The argument developed into a fight during which it is alleged, DeGrande hit Allard's finger.

The case is an appeal from justice court. When the case was tried by Judge R. C. Finckhann on Sept. 15, 1918, Allard was awarded a judgment of \$100, which was reduced by circuit court Friday to \$50.

Attorney H. J. Reardon was counsel for the plaintiff and Attorney T. J. Riley for the defendant.

A judgment of no case for action was rendered by Judge Finckhann in the case of Theophile Duford versus Leo Zawain. Attorney H. J. Reardon represented the plaintiff and Attorney T. E. Strom the defendant.

Two divorce decrees were granted in the cases of Seymour Sutton and Charles versus Charles.

McDonough's case is an isolated one and there is no fear of an epidemic, city officials said last night.

The parents have been in the habit of leaving home early in the morning and returning late at night, paying no attention to the condition of the little ones. If conditions are as described to the police, drastic action will be taken, according to City Carney announced.
